## NARRATIVE SUMMARY

1. Headquarters Battalion continued to have elements positioned throughout the 3d Marine Division Area of Operations during this period. Location of major elements are as follows:

2. Unit Activities/Events

a. Continued improvement was made in the established street system in the Headquarters Battalion Area.

b. A total of ten (10) vehicular accidents were investigated by the Military Police during this reporting period. Ten accidents occurred in the Phu Bai area, resulting in one (1) Marine fatality and seven (7) minor injuries. Total property damage caused by vehicular accidents in the Phu Bai area is estimated at \$2,963.00. The consolidated monthly total for property damage is \$2,963.00.

c. The city of Hue was inspected for Black-market activities on several occasions during December. There were no changes in Black-market volume and prices have remained stable.

d. Planning was commenced for the displacement of the Division Command group to the Forward Command Post at Dong Ha. Completion of the move is expected by 10 January, 1968.

e. Various items of communications equipment were moved to Dong Ha during December in order to support the planned move of the Command group.

f. The Division Communications Center was relocated to a bunker next to the Command Post bunker at Phu Bai. This has the effect of providing the Commander with a more secure communications capability.

g. Both the new Officers Club and the new SNCO Club opened during the month.

h. A new SNCO mess was opened during the month. The new mess is larger and better equipped to provide a full range of food service to the large number of SNCO's in the Battalion.

e. New Techniques Employed. Nonef. Command Relations. Satisfactoryg. Equipment. Distribution of the 2nd Increment of M-16A1 rifles is still in effect at this time.h. Logistics. The high deadline rate of motor vehicles continued to be the most significant logistics problem. The M422A1 vehicle in particular has proven to be extremely difficult to keep in operating condition. The unavailability of required repair parts is the primary cause of the deadline situation.i. Civic Action. On 23 December 1967, a Christmas party was held for the children of Chiet Bi Ha hamlet, just adjacent to "B" Sector of the Perimeter. Approximately 300 toys were distributed and refreshments were served. A small MedCap was held and 33 civilians were treated.j. Administration. A study was conducted as to the feasibility of relieving Sub Unit #5 of the responsibility of base functions at Khe Sanh and thus bring the unit to zero strength. Through liaison

with the G-1, 26th Marines and this Headquarters, recommendations were submitted to Commanding General, III Marine Amphibious Force. III Marine Amphibious Force concurring in the recommendation will provide 4 officers and 24 enlisted men as a regimental headquarters with augmentation of 1 officer and 8 enlisted from this headquarters. It is anticipated that Sub Unit #5 will be reduced to zero strength about 10 January 1968. Those personnel in excess of the augmentation requirement will be reassigned within Headquarters Battalion.

k. Personnel. 23 officers and 220 enlisted were rotated to CONUS during this period. 38 officers and 265 enlisted were joined in the Battalion during the period.
