

(2) Roman Catholic coverage for this battalion is provided by Chaplain Ray Roy, 3rd Battalion, 1st Marines and Chaplain James Jenner, Regimental Chaplain, 1st Marines. During the month we had 4 Sunday Masses with a total attendance of 162. Also, 2 weekday Masses were celebrated with a total attendance of 59.

(3) Protestant services conducted within the battalion for the month were 6 with a total attendance of 235. The Chaplain of this battalion is also responsible for Protestant coverage of 1st Marine Regiment "CP" and 3rd Battalion, 1st Marines.

SECTION III

INTELLIGENCE

1. Enemy Situation

a. General

The enemy continues the heavy employment of mines/booby-traps and light to moderate sniping at patrols and friendly installations. A decrease in enemy initiated incidents has been noted throughout the TAOR.

b. Enemy Units which Operate Near Our TAOR.

(1) Q-15 Company (Dien Ban). This unit is reported to be located at BT 0060. This unit is armed with 1-81mm mortar, 1-60mm mortar, 1-57RR and 3 MG.

(2) 402nd Sapper Bn (MF). This unit is reported operating in the vicinity of AT 8064 and AT 8066. Strength and weapons are unknown.

c. Enemy Initiated Incidents during the Period in the TAOR

(1) 031520H. Foxtrot 2 patrol at BT 035599 while sweeping the area of a suspected VC position received 75 to 100 rounds of small arms and automatic weapons fire from an estimated 3 to 5 VC at BT 035599. An 81mm mortar mission was called and the position assaulted. The area was swept with negative results.

(2) 031740H. Echo 3 patrol while sweeping the area at BT 028621 received 40 to 50 rounds of automatic weapons fire. Fire was returned with small arms and an 81mm mortar mission was fired with good effect on the target. The enemy broke contact. The area was not searched due to unfavorable terrain.

(3) 050645H. Golf A1 patrol at BT 000638 received heavy automatic weapons fire and carbine fire from AT 996635. Fire was returned with organic weapons and an 81mm mortar mission. The area was swept with negative results.

(4) 061210H. Echo Company patrol at AT 997550 spotted a VC running across a foot bridge constructed from an old railroad bridge. Small arms fire was received from AT 998546 acting as a cover for a VC withdrawal. Fire was returned with small arms, M-79, MG and artillery fire. A search of the area produced 5 VC KIA (Conf), 4 VC WIA (Conf), 3 rifles, 3 packs and several grenades.

- (5) 081300H. Hotel platoon at BT 025594 received 30 to 40 rounds of small arms fire from BT 034592 and BT 034593. An 81mm mortar mission was called with good effect on the target area. A search of the area was made with negative results.
- (6) 131845H. Hotel 2 at BT 012568 received 20 rounds of automatic weapons fire from BT 014559. Fire was returned with small arms and an 81mm mortar mission on the enemy positions. The enemy broke contact and the area was searched with negative results.
- (7) 141015H. Foxtrot Company at BT 028615 received 30 to 40 rounds of small arms fire from an unknown number of VC at BT 026613 and BT 027614. Fire was returned with small arms and an artillery mission. The area was swept with negative results.
- (8) 151215H. Hotel platoon at BT 017588 received 50 to 75 rounds of automatic weapons fire from BT 015585. Fire was returned with small arms, M-79, M-60 and 60mm mortars. 2 VC were seen to be hit and fall. The area was not swept.
- (9) Foxtrot 1 platoon at BT 007613 received 50 rounds of small arms fire from BT 008611. The patrol returned fire with small arms and the enemy broke contact. The area was swept resulting in 1 VCS taken to Dien Ban District Headquarters.
- (10) 210040H. 2/1 CP perimeter reported approximately 4 figures moving towards the communication wire barrier from BT 013633 and BT 014630. At the same time the perimeter received approximately 10 rounds of small arms fire. The figures were taken under fire by small arms and M-79. 1 VC was seen to be hit. The area was not swept due to darkness.
- (11) 231030H. Foxtrot 3 patrol sweeping at BT 031600 received 25 to 35 rounds of small arms fire. Fire was returned with all platoon weapons. The area was searched with PF's assisting and 1 VCS was apprehended. The VCS was turned over to the Village Chief.

e. Significant Trends during the Period.

- (1) Enemy movement throughout the TAOR has decreased this reporting period. Reason: the Marines have stepped up their activities, the area has been heavily flooded, and the rice planting season is now in existence.
- (2) Enemy units (2-5 men) have continued the limited hit and run tactics. A decrease in all enemy initiated actions has been noted throughout the TAOR.

f. Enemy Situation at the end of the Period. The tactics employed by the enemy have remained basically the same, with the exception of a few isolated incidents.

2. Terrain. There has been a significant change due to the Monsoon Season. Large areas are inaccessible to troops and vehicles.

Section IV

Operations and Training

1. Mission. Occupy and defend assigned TAOR conducting unilateral and/or coordinated operations designed to further the social revolution and expand the area of influence of the governmental agencies of the RVN; be prepared to assume the responsibility for another battalion's sector within the 1st Marines TAOR and to deploy anywhere in RVN by the most expeditious means, within the specified time from the first warning order.

2. Control. Control of the Battalion was exercised throughout the period from the command post and/or light command group in the field. Wire and radio communications continue to be used equally to exercise control of subordinate units.

3. Close Combat

a. Patrols:

(1) Search and Destroy: 47 company, 37 platoon, and 97 squad search and destroy patrols.

(2) Security: 34 platoon and 4 squad security patrols.

(3) Reconnaissance: 11 platoon and 2 squad reconnaissance patrols.

b. Ambushes: 13 platoon and 110 squad ambushes.

c. Listening-Post/Outposts: A total of 141 LP's/CP's.

d. Security Post: 30 company (-), 9 platoon, and 44 squad security posts.

4. Special Operations.

a. Combined Operations:

(1) Co F provided a blocking force for the 51st ARVN on 12 November 1966 in the vicinity of TAN HANH (AT 996655).

(2) Co E (Rein) provided a blocking force for the 51st ARVN Regiment (Rein) five company search and destroy operation in the vicinity of BICH NAM/HA DONG (AT 9963, AT 9964, BT 0064 and BT 0065) from 19 November - 21 November 1966.

b. Psychological Warfare Operations

(1) Significant Activities

(a) On 7 and 8 November a C-47 aircraft was employed to broadcast loudspeaker messages on the CHIEU HOI theme from BT 0560 to BT 0070 over Route #1; on 14 November helicopter broadcasts were employed over GS BT 0362 in conjunction with a two company search and destroy operation.

(b) On 21 and 22 November a KIT CARSON made loudspeaker broadcasts from a motor vehicle in the THANH QUIT market center (BT 041622) and from a portable loudspeaker at night near the battalion perimeter. Themes employed were "Life as a VC", "CHIEU HOI" program, and "Life as a CHIEU HOI". Audio equipment for these broadcasts were provided by a team from the U.S. Army 244th Psychological Warfare Operations Company.

(2) Material Distributed

(a) During November 7000 leaflets were distributed by helicopter drop in the general vicinity of GS's BT 0362, 0462, 0261, 0361, 0260 and 0360. Themes of the leaflets included "Weapons and Mine Information Rewards", "Don't run from Marines" and "Allied Power".

(b) Daily distribution of sanitation leaflets and "Free the South" newspapers were continued from MedCap locations at the Battalion CP, BT 042579, and BT 043620.

(3) Feedback. Hostile fire toward loudspeaker positions when the KIT CARSON was utilized was less than usual. Local villagers in the THANH QUIT market center (BT 041622) received the broadcasts with noted interest. Their enthusiasm to receive a copy of the "Free the South" newspapers was also noteworthy.

5. Nuclear, Biological, Chemical and other Types of Warfare

a. During the reporting period neither NBC Warfare nor equipment peculiar to it were employed.

b. No NBC Warfare training was conducted.

c. All items of NBC equipment authorized by T/E are on hand and operational.

6. Problem Areas. No significant problem areas were encountered.

7. Sequential Listings of All Contact, General Description of Scheme of Maneuver and Results Attained:

(1) 1 November - Near the conclusion of County Fair 1-24 at 0655H a 30 year old male walked into the cordoned area (BT 020586) apparently unaware of USMC presence. He was challenged, then shot and killed by Co H when he attempted to flee. Co H patrol discovered body of young male inside cordon area near BT 025585 at 0730H. Condition of corpse indicated death occurred by fragmentation wounds 2 days previously. County Fair 1-24 terminated at 0800H and participating units returned to respective CP locations.

(2) 2 November - Co F placed on BALD EAGLE alert at 1200H. At 1340H Co E patrol member detonated a mine (wired M-26 grenade) at BT 015619 and died before med-evac chopper arrived. This same patrol continued to BT 017619 where they received 5 to 6 rounds of small arms fire from BT 015626 at 1525H. Fire was returned with 15 rounds of small arms and 81mm mortars. Sweep of area yielded 40 rounds of 7.62mm ammunition. Co F patrol at 1300H (BT 003617) apprehended a VN male whose ID card caused suspicion. VCS was interrogated at CP and held. At 1530H a M-35 truck belonging to 1/11 was struck by small arms fire resulting in a broken windshield and 2 flat tires near BT 051599. Fire was returned with 100 rounds of small arms. Echo ambush moving into position at 1910H near BT 017620 received 20 rounds of automatic small arms fire from BT 017616 resulting in one WIA. Returned fire with 20 rounds small arms, 17 rounds M-79, and 2 rounds 81mm mortars. Med-evac completed without further incident. Platoon relocated ambush position.

(3) 3 November - At 0820H, Co E squad patrol near BT 053598 pursued and apprehended 1 VCS female who ran from patrol; and accomplice VCS female was found hiding in a house. Neither had ID cards. Women were interrogated at 2/1 CP and forwarded to DIEN BAN District Headquarters. Co H observation post at BT 047554 received 2 rounds of small arms fire from BT 043552 at 1050H. Ten 60mm mortar rounds were fired on enemy positions. Enemy fire stopped; area not searched due to river barrier. At 1100H Co H patrol near BT 030570

apprehended a 17 year old male with GUY CHAM papers including identification photograph. Returned to Co A for further identification and verification of GUY CHAM status. Co A platoon patrol at BT 039601 received small arms fire from estimated 2 VC near BT 037604 at 0915H. VC vanished before fire could be returned. No supporting arms were fired because of proximity to village. At 1215H the patrol received 3-4 rounds small arms fire at BT 034602 resulting in one WIA. Estimated 3 VC fired on patrol from BT 034603; 100 rounds small arms fire, and 6 M-79 rounds returned. After med-evac, area was swept with negative results. Co H discovered roadblock constructed of a card board box, bamboc and barbwire on Hwy # 14 at BT 023573 at 1300H. Obstruction was not bodily trapped and was removed from road and destroyed. At 1520H Co F platoon patrol at BT 035599 received 75-100 rounds of small arms fire and automatic weapon fire from an estimated 3-5 VC near BT 033799 resulting in one WIA. 81mm mortar mission fired, area assaulted and searched with negative results. WIA was med-evaced by helicopter, which was observed receiving 2 rounds of small arms fire. At 1626H Co H observation post reported seeing a VC flag, people moving, and reflections from metallic objects visible near BT 043552. Artillery mission was fired and area searched by AO. Second artillery mission was fired, AO searched area. No trace of troops or flag pole visible. Area not searched by ground troops due to river barrier, (6 prob VC KIA). At 1740H, Co E patrol received 40-60 rounds of small arms including automatic weapons fire from BT 028621 while at BT 024622. Small arms fire returned and 81mm mortar mission called. Area not swept due to unfavorable terrain.

(4) 4 November - Co G patrol observed passing helicopter receive several rounds small arms fire from BT 995625 at 0820H. 81mm mortar mission was called on suspected VC position. Patrol searched area with negative results. As Co F patrol at 1205H began search of houses (vic BT 034606), a VC ran from patrol. Patrol fired on individual who was seen to fall. Search for body had negative results. Same patrol later at 1230H observed 2 VCs hiding in cemetery watching patrol; 2-3 more VCS with weapons were observed moving near BT 032624. VC in cemetery fired several rounds small arms at patrol, and received artillery and small arms fire in return. Enemy broke contact and patrol continued on its mission. 2 VCS KIA (prob). At 1425H Co H observed one VCS at BT 025581 and received 8 rounds small arms fire. 81mm mortar fired one WP round which landed in patrol area resulting in 4 US WIA. Patrol continued mission after LVT evacuation of 4 (minor) WIA. At 1430H, Co E patrol at BT 017618 received 15 rounds of small arms fire from BT 014516. 4 rounds 60mm mortars, 20 rounds 81mm mortars, 5 rounds M-79, and small arms were returned. Area was searched with negative results.

(5) 5 November - At 0530H Co C ambushed VC 998637 received 10-20 rounds small arms fire from AT 994632. Fire returned with 7 M-79 rounds and 81mm mortars. Sweep area with negative results. Relocated position and continued mission. Later at 0645H, same ambush near BT 000638 received heavy automatic weapons fire from vicinity AT 996635; fire was returned and area searched with negative results. Foxtrot patrol at 0600H near BT 015617 received 40 rounds of small arms automatic weapons fire from BT 017614. Returned 3 105mm rocket rounds, 15 M-79 rounds, 150 rounds small arms. Area swept with negative results. Co H platoon-size patrol at 1100H received heavy automatic weapon small arms fire from BT 023587 while at BT 027583. Observed one VC with linked ammo across chest running in tree line. Patrol returned small arms, 12 M-79 rounds and artillery fire; maneuvered under fire to BT 005590. VC broke contact and fled. Patrol pursued but unable to reestablish contact. At 1130H Co F patrol captured a VCS attempting to destroy a map inside a hut at BT 031514. VCS was taken to S-2 upon completion of mission. About 1225H Co H patrol near BT 023587 received 3 rounds of small arms fire from BT 017585. Fire was returned with small arms, 60mm mortars, 10 HE and 15 WP artillery rounds, which set fire to VC position; VC broke contact. Area and burning rubble of house searched. One VC KIA (prob). At 1345H, same patrol near BT 017587 received sporadic harrasing small arms fire from BT 016587. Fire returned with small arms and 4 M-79 rounds. On sweep the patrol discovered woman and child with fragmentation wounds. Wounded were taken aboard LVT and taken to DIEN BAN Headquarters.

(6) 6 November - Co G at AT 981564 observed 2 boats crossing river about 0830H near AT 979559 with unknown number of VC. Fired M-79 grenades and boats appeared to be hit; they disappeared on south bank of river. Co G discovered another boat hidden under water in vicinity at AT 982559. Boat was destroyed. At 1210H, Co E observed approximately 10 VC running across bridge at AT 998546 and began receiving small arms fire covering VC withdrawal. VC taken under fire with small arms. An artillery and NGF mission was fired on target with excellent coverage. Subsequent search confirmed 5 VC KIA, 4 VC WIA, 3 rifles, 3 packs and documents. Papers on 1 of the dead VC identified him as a guerrilla chief. Eight boats were discovered hidden underwater at AT 997550 by Co E at 1400H and were destroyed. At 1556H, a Co E member was wounded (minor) by sniper fire received from across the river near BT 003553. During the day, Co C apprehended 50 civilian women and children, and Co E apprehended 30 women and children in the operating area.

(7) 7 November - At 0820H, Co E Marine detonated a mine of undetermined origin at AT 994585 resulting in one KIA and one WIA. Casualties med-evaced to C-Med. Co E at 1400H, in the vicinity of AT 997597 observed 1 VC and fired. VC was hit as evidenced by blood

trails; 1 Marine WIA occurred in fire fight. At 1400H, near AT 996604, Co E received one sniper round resulting in 1 WIA (leg wound). Fire returned by small arms. As med-evac was being conducted for above WIA at 1445H intense small arms fire was received. During ensuing fire fight, HUE-1 made firing run. There were 3 VC KIA and 1 WIA. Air strikes were conducted by 4 flights of fixed wing and 1 flight of HUE-1 gunships. An additional WIA was injured from fall while escorting casualty to med-evac aircraft. Three casualties taken to C-Med. Large secondary explosion noted in target area of air strikes. Search results inconclusive due to approaching darkness and poor mission. At 1710H, a vehicle leaving the Bn perimeter received 5-10 rounds of small arms fire from vicinity of BT 012633; trash dump sentry was also fired upon. Small arms fire returned and VC fire ceased. Darkness prevented conclusive sweep. At 1920H, Co E outpost at BT 043620 reported a C-47 aircraft making psychological warfare broadcasts was fired upon by approximately 20 rounds small arms fire from unknown number of VC suspected to be located in GS 0462. Aircraft continued mission over Route #1 in a NW direction. At 1930H, Bn perimeter received small arms fire in northern sector from unknown number of VC near BT 012633. Fire returned with 50 rounds small arms, 13 rounds 81mm mortar, and 1 - 106RR round which was observed to hit directly on location of VC muzzle flash. VC broke contact. Area to be searched at first light. 1 VC KIA (probable).

(8) 8 November - At 0930H, Co E observed an armed VC walking down trail at AT 994546; VC was shot (KIA) and left on trail. When five more VC arrived, one was shot (KIA) and the remainder (4) captured; 1 US carbine M-1 was captured. A Co H patrol member was wounded by a sniper at 1030H at BT 040593. Fire was returned on suspected VC position at BT 040596. On sweep of area, 3 auto batteries, one distributor, 1 voltage regulator, 1-8" loudspeaker, 1 signal bell, and 1 drum was discovered hidden in a hut. Batteries were destroyed; other items were returned to Bn S-2. At 1300H, Co H patrol received 30-40 rounds small arms fire from BT 034592, BT 043593, and BT 034597. Fire was returned with small arms and 81mm mortars; area was searched with negative results. Co E platoon patrol at 1430H observed 2 VC with weapons walking down trail at AT 998600. VC were taken under fire and one was wounded; the other escaped with both weapons. VC WIA carried orders directing him to organize a meeting of all VC in the area. VC died of wounds at 2130H. Co H patrol at 1515H observed 3 male VN's dressed in dark clothing moving south near BT 015565. Artillery fired on area with good target coverage. Sweep conducted with negative results.

(9) 9 November - At 0950H, Co E at AT 996605 observed 2 VC with weapons near AT 999606. Platoon fired on VC, wounding one. Second VC appeared to drag the wounded man away. Patrol pursued and searched

with negative results. Co H platoon patrol on a AmTrac near BT 023573 detonated a mine at 1200H resulting in 3 WIA NE. Detonation created a 6' x 10' x 5' crater and extensively damaged the vehicle track. Co E returning from blocking position in support of Operation SHASTA discovered a M-16 mine near the bridgehead at AT 997607 about 1230H. Mine was disarmed and returned to CP for intelligence value and subsequent destruction. Co E near AT 997612 at 1515H received 2 rapidly fired sniper rounds resulting in 1 WIA. Fire not returned due to lack of knowledge of the VC position and the proximity of friendly troops. WIA continued with company and was med-evaced from Bn CP at 1745H. A 1st Marines Communication vehicle 3/4 ton truck near BT 044617 received one round M-79 grenade. Fired from an unknown position at 1420H resulting in 4 WIA's. Vehicle returned to BT 043620 where med-evac was conducted by Co E squad outpost at THANH QUIT Bridge. Regimental Headquarters notified of names of casualties and repairs required to the vehicle.

(10) 10 November - At 0700H, Co H platoon patrol member detonated a trip wired M-26 grenade at BT 015560 resulting in three WIA's who were med-evaced. Patrol continued its mission. At 1840H, Co H observation post at BT 045585 observed 4 VC at BT 037561 upon illumination of area by flare ship. Artillery fired on target area with good coverage, not to be swept because of river barrier.

(11) 11 November - During the heli-lift of Co E at 0750H, from BT 015627, 75-100 rounds of small arms fire were received while airborne. CH-46A crew chief and one Co E member were wounded. Helo returned to LZ to discharge the casualties. ONTOS fired into the suspected VC position, and area was searched with negative results. At 0950H, Co E at BT 002542 apprehended a male VCS sitting in a house with several children. Interrogation revealed confirmation of VC KIA and WIA of 6 November. Co G engineers discovered and disarmed two M-16 mines and one trip wired CHICOM grenade at BT 013568 about 1000H. Co H patrol killed one VC about 1015H near AT 997561 who ran when challenged. Body bore no identification. No weapons were located in the area. Foxtrot platoon patrol at 1045H discovered an M-79 grenade and trip wired CHICOM grenade at BT 014617. Grenades were disarmed and returned to Bn CP. At 1045H, Co H platoon patrol observed 4 VC running from patrol at AT 990554. VC were taken under fire resulting in one VC WIA (prob). Search results inconclusive. At 1135H, Co E member was wounded by a possible stray round near BT 002546. Co H platoon patrol at 1130H discovered two mines, one of which contained a 40 lb shape charge. Each mine was covered with a five gallon bucket and loose dirt. Mines were blown in place. At 1230H, Co G engineers discovered a 60mm mortar round planted as a mine at the bridgehead near BT 012568. Mine was disarmed and returned to a safe area for destruction. ONTOS supporting Co G

near AT 996552. At 1250H, observed VC small arms fire coming from hut at AT 994542. VC taken under fire by 16 rounds of 106 RR destroying 3 huts. One round created a secondary explosion raising a 75 foot high smoke column. Co G engineers discovered a 60mm mortar round and a M-79 round at BT 012568, both were planted as mines. The mines were destroyed in place. At 1400H, Co H patrol killed a VC who ran from patrol when challenged. No weapon or ID card was found. A booby trapped helmet tied to a stick was destroyed. Co H patrol at 1430H discovered a bundle of 150 bamboo punji stakes at BT 015590. Stakes were destroyed. At 1620H, resupply helo's arriving at LZ near BT 003543 received intense small arms fire from BT 012548 and BT 020550. Helo's aborted mission. Aircraft strikes by two UH-1E gunships and two F-8's were run on VC position. Area not swept due to distance involved. At 1930H, Co H observation post at BT 046560 observed signal lights and heard movement at BT 039552. Artillery mission fired on area with good target coverage. Area not swept due to river barrier.

(12) 12 November - At 1115H, Co E platoon patrol vicinity BT 018549 observed 1 VC sitting beside trail. The VC ran from the patrol when challenged. Patrol shot and killed one VC, captured 1 CHICOM automatic rifle with 4 magazines, and 1 grenade. LVTE-1 line charge detonated several secondary explosions; 3 at BT 015569, 2 at BT 021573 and 6 at BT 026576. At BT 026576, a crater 20 feet long, 12 feet wide, and 8 feet deep resulted from 2 secondary explosions. It was estimated to be two 100 lb charges. At 1600H, Co E platoon patrol vicinity AT 999544 observed one armed VC walking down a trail. Patrol shot and killed the VC and captured 1 U.S. Thompson sub-machinegun with 4 magazines.

(13) 13 November - No significant contacts.

(14) 14 November - At 0730H, Co F at BT 033620 killed 2 VC, wounded 1 VC (confirmed), 5 VC KIA (prob) and captured one M-2 carbine, one M-26, one CHICOM grenade, assorted booby trap parts, medical supplies and apprehended 10 VCS. At 0800H, Co F at 034617 apprehended 2 VCS and turned over to IPT. At 1030H, Co F at BT 030616 captured 1 VC corpsman with large bag of medical supplies, narcotics, and one .50 caliber cartridge with a wooden projectile. At 1015H, Co F at BT 028615 received 30-40 rounds small arms fire from BT 026613 and BT 027614. Co F returned fire with small arms fire and called artillery mission. Area searched with negative results.

(15) 15 November - At 0101H, while firing 81mm mortar H&I's, one round landed in Bn CP at BT 015627, resulting in 3 USMC WIA's minor. At 0830H a squad from Co H at BT 040577 observed one VC running at BT 032589. An 81mm mortar mission was called with excellent coverage.

Search of area revealed a blood trail. At 0845H 3rd Platoon of Co H at BT 045562 observed five VC, one wearing a brown helmet and carrying a rifle at BT 039555. The five VC were taken under fire with small arms fire and artillery mission called. One VC was observed to be hit. Area was not searched due to river barrier. At 0930H a platoon from Co G in blocking position at AT 998597 received heavy automatic carbine fire from 4 VC vicinity AT 996603. Platoon returned fire with M-79 and small arms fire and one VC was observed to be hit. A sweep of the area revealed a trail and pool of blood. At 1215H a platoon from Co H at BT 017588 received 50-75 rounds of automatic fire from vicinity at BT 015585, resulting in 2 USMC KIA's and 1 USMC WIA. Platoon returned fire with small arms and M-79, and M-60 and 60mm mortars. During search of area an individual's right forearm was discovered. At 1430H a platoon from Co F at BT 036601 heading west took 2 VC under fire resulting in one VC KIA and 1 VC WIA (prob). One M-1 carbine with bayonet, a M-26 grenade, and a wallet containing map and papers were captured. At 1500H a platoon from Co H at BT 017588 received heavy small arms fire from BT 015585. The platoon assaulted the position with support of Amtracs. The platoon observed 12-15 VC crossing a foot bridge at BT 014587. Engineers destroyed the foot bridge. Small arms fire was received from BT 012588. The platoon returned fire with organic weapons and called artillery mission. The platoon observed 12 VC hit, resulting in 8 VC KIA (prob) and 4 VC WIA (prob). During search, platoon apprehended 4 VCS females with children. At 1530H a platoon from Co F searching area vicinity BT 036601 apprehended 4 VCS males who acted suspicious and were uncooperative. At 1730H a 4x4 1/2 ton vehicle from 3rd Engineers proceeding north received heavy small arms fire from BT 030632 resulting in 1 USMC KIA. 2/1 convoy with ONTOS arriving on scene returned fire with 106 RR and small arms fire. At 1840H convoy returning north with Co G received heavy small arms fire from BT 030632. Convoy returned fire with small arms fire and 106 RR fire. VC broke contact.

(16) 16 November - No significant contacts.

(17) 17 November - At 0930H a combat patrol from Co F at BT 007615 received 10 rounds small arms fire from BT 004615 and BT 009613. Patrol returned fire with organic weapons. Area not swept due to water barrier. At 1130H a platoon combat patrol from Co F at BT 007613 received 50 rounds small arms fire from BT 008611 from approximately 3 VC resulting in one USMC WIA. Patrol returned 300 rounds small arms, 1000 rounds M-60, 26 rounds of 81mm mortars HE and WP rounds. White phosphorous particles caused one USMC WIA (minor). Patrol swept area and apprehended one VCS, age 20, with no identification. At 1645H a platoon combat patrol from Co G at BT 042642 apprehended one VCS, age 18, with no identification.

(18) 18 November - At 1030H a platoon patrol from Co F at AT 999614 apprehended 2 female VCS in a house, ages between 25-30, neither had an ID card.

(19) 19 November - At 0715H a platoon ambush from Co F at AT 999617 tripped an ambush on 1 VC carrying an M-1 at AT 999617, VC observed being hit. Search of area revealed heavy blood trail which was followed for 300 meters. A Sun helmet cigarette lighter, and a whistle with chain was found. At 2210H a patrol member from Co E at BT 003633 stepped on a steel punji stake. 1 USMC WIA med-evaced.

(20) 20 November - At 0605H a Co F squad ambush at BT 033624 fired upon one VC, resulting in one VCC WIA, who was med-evaced. At 1415H, a Co F platoon conducting a combat patrol at BT 040602 discovered a mined punji trap. During probe of pit, the mine detonated causing 3 USMC KIA's and 8 USMC WIA's of which 3 WIA's were not evacuated. The Battalion perimeter near Delta sector observed 4 VC near the defensive wire and took them under fire about 2300H, and received approximately 10 rounds of small arms fire. One VC was seen to fall. Day light search of the area revealed the concertina wire had been cut at two locations.

(21) 21 November - No significant contacts.

(22) 22 November - No significant contacts.

(23) 23 November - At 1030H, Co F platoon patrol near BT 030600, apprehended 1 VCS female following a brief fire fight. 1 VCS female released to custody of village chief near BT 028611 by PF's operating with the platoon.

(24) 24 November - Co F squad tripped ambush on 6-10 VC, simultaneously firing on a boat moving down the SONG THANH QUIT at 2130H near BT 056626. Boat was sunk, discovered 3 coolie hats and drag marks indicating 2 VC KIA (probable).

(25) 25 November - Co F platoon patrol received 1 round of sniper fire from BT 047646 at 1215H, resulting in one U.S WIA. Artillery fired across the river on VC position and during med-evac for WIA, UH1-E gunship made repeated passes with MG and cannon into the area. Area not searched because of river barrier. At 1250H, Co F platoon security for med-evac at BT 050634 fired upon 1 VC running from VC position. VC was WIA and apprehended, interrogated and med-evaced. At 2130H, Co H. squad ambush fired on 4 VC near BT 001644 observing 2 VC to be hit and fall, drag marks was found on search of the area, indicated 2 VC KIA (probable)

(26) 26 November - No significant contacts.

(27) 27 November - Co H squad at AT 985662 about 1940H tripped an ambush on 3 VC moving across flooded paddy area in a Sampans. Two VC observed to be hit by small arms fire; and boat was sunk. Search not conducted due to high water.

(28) 28 November - No significant contacts.

(29) 29 November - No significant contacts.

(30) 30 November - Co F squad ambush near BT 014620 at 0655H challenged 1 female and 2 male Vietnamese who ran and were fired upon by the squad. One female VCS - WIA was apprehended and returned to CP for interrogation and evacuation. Co G squad patrol at 1500H near AT 980677 accosted a VN male without an ID card who attempted to run from patrol. Man was apprehended as a VCS and returned for interrogation.

8. Training. The major training emphasis continues to be on-the-job training. Thirty-three replacements fired the M-14 rifle on the 900" range for proper battle zero. All newly-joined personnel attended the Battalion troop indoctrination program. The battalion continues to utilize fully the school quotas received from 1st Marine Division and III MAF Schools. During the period 21 to 30 November, 56 marines attended the 2½ day landmine warfare classes at the 3rd Engineer Battalion. Local classes on the proper "Use and completion of prisoner tags" was conducted by Interrogation Team personnel to all company commanders, platoon leaders, platoon sergeants and squad leaders.

9. PF/RF Liaison and Training.

a. One squad of Co H provided training assistance and guidance for the 2 PF Platoons located in the vicinity of BT 048560. Integration of the squad into the PF Company has consistently improved relations between the two. Progress continues to be good in the training status of the PF's in weapons fundamentals, and elementary infantry tactics. The leadership ability of the PF Commander continues to improve through the Marine influence and example. Due to the change of areas of responsibility with the 1st Marine Regiment, this CAC unit has been dropped from the rolls of this command. 1st Battalion 1st Marines assumed control of this squad on 22 November 1966.

b. One squad from Co E continues to be billeted with the RF Company Headquarters at BT 042620. The mission of the squad is to provide liaison with this unit and coincidentally to provide training assistance. Steady progress in this regard continues.

SECTION V

LOGISTICS

1. Supply. During the reporting period, difficulty was again encountered in the procurement of certain items. The status of individual equipment remains critical. Items of particular concern are Helmet, Soldiers Steel, W/Release Strap, Pocket Ammunition U/W M-14 Rifle, and Grenade Carrier, Cloth Cotton Duck. Stocks of Jungle Utilities and Boots have become exhausted. Limited numbers of extra-small and large sizes are on hand, but medium sizes are critical with none on hand. Documents have been submitted, but to date, no issues have occurred. Direct liaison is being effected with the Supply Officer of the First Marines and Fleet Stock Account Office at FLSG-A to solve these problems.

2. Maintenance. 189 Tactical Equipment Repair Orders were submitted to FLSG-A during the month and 65 were completed. The following is a breakdown by section of the work orders submitted and completed:

3. Food Services. Food Service personnel and facilities encountered no difficulties during the reporting period. The Battalion is currently receiving two "A" ration meals and one "B" ration meal daily. Fresh salad and fruit are available daily.

4. Cantonment and Camp Facilities. The request for 35 tropical huts has been cancelled. The 1st Platoon, Company A, 1st Engineer Battalion is leaving with no replacement expected. To date, three burnable type huts have been constructed. During the reporting period, adequate quantities of plastic siding were received to waterproof all structures presently within the Battalion Command Post.

5. Transportation and Roads. Roads between Da Nang and the entrance to the Battalion Command Post access road have remained in satisfactory condition. However, periods of heavy rain do cause flooding in certain areas. The access road from the Battalion Command Post to Highway 1 has remained in a trafficable condition. 7th Engineer Battalion again attempted to improve this road, but was stopped due to heavy rains and inadequate amounts of proper fill.

6. Fiscal. During the month of November, the Battalion obligated \$60,159.44 for stock fund account items.

7. Water. No problems were encountered during the reporting period. The water point remains within the Battalion Command Post. With the advent of cooler weather, efforts to obtain a shower unit for the water point were to no avail. However, a substitute apparatus was built which at least serves to take the chill off the water.

8. Motor Transport. Preventative maintenance is being performed on a continuing basis. Presently, 5 Truck, Platform, $\frac{1}{2}$ T 4x4, M-274's and 3 Truck, $\frac{1}{2}$ T 4x4, M-422A1's are deadlined for 3rd echelon repairs at FLSG-4. During the reporting period 3 Truck, Platform, $\frac{1}{2}$ T 4x4, M-274A1's were received as 3 were "X" Coded. Presently there is a quantity of 2 Truck, Utility, $\frac{1}{2}$ T 4x4, M-422A1's on order.

9. Embarkation. The Battalion embarkation posture remains satisfactory, with the exception that there presently exists a critical shortage of mount-out boxes. These boxes have been on order for more than sixty days. No embarkation or debarkation occurred during the period.

10. Hospitalization and Evacuation. The majority of the Battalion casualties were evacuated directly by helicopter from the site of injury to "C" Company, 3rd Medical Battalion. The non-battle casualties were, for the most part, referred to the Battalion Aid Station for treatment and disposition. Those requiring hospitalization were sent either to "C" Company, 3rd Medical Battalion or the U.S. Naval Support Activity, Hospital, Da Nang.

SECTION VI
COMMUNICATIONS

1. GENERAL

a. Since its recent arrival in the Danang TAOR, the Division CEO has been inspecting communication sections within the 1st Marine Division...

b. The Battalion received an inspection during November 1966 with primary interest on local communication problems and equipment shortages.

c. After the inspection a conference was held at the Division CP to enumerate the division-wide problems. As discussed, the major problems are: distribution of messages; allocation of frequencies and replacement of parts for the new FM family of radio equipment.

2. RADIO. The KY-8 secure voice system has been used on the Regimental Tactical Net on a 24 hour basis during November. The circuit has proven reliable and very useful. There was some difficulty experienced in the shorting out of the X-mode cable. It is felt that the twisting motion in removing the cable caused this difficulty.

3. WIRE. Wire communication functioned normally during the month of November. A hot locker was built around the battalion switchboard to insure more reliable service during the monsoon season.

4. MESSAGE CENTER. The message center chief has conducted off-line crypto instruction with the members of the crypto board. Two drill off-line crypto messages have been received from regiment and answered by courier.

5. SUPPLY AND MAINTENANCE SUPPORT. Due to the reception of 45 miles of WD-ITT field wire this month the shortage of this item was alleviated.

Section VII

FIRE SUPPORT COORDINATION CENTER

1. During the month of November, the First Battalion, Eleventh Marines, who is in direct support of the First Marine Regiment, fired in support of the Second Battalion, First Marines. Lima Battery, Fourth Battalion, Twelfth Marines, was on occasion employed in a general support reinforcing role.

2. Fire support for the Second Battalion, First Marines was coordinated by the Battalion Fire Support Coordination Center. During this past month, coordination of fire support was required for small unit activities, combined operations, and battalion(-) search and destroy operations within the TAOR of the Second Battalion, First Marines.

Section VIII

AIR SUPPORT

1. During November 36 medical evacuation missions were flown in support of 2/1. Of these there were 15 emergency, 5 priority and 16 routine.
2. Eleven fixed wing aircraft were used in conjunction with helo assault missions. There were 3 OE, 4 A4, 2 F4, and 2 F8 aircraft.
3. Helicopters were utilized for 17 missions broken down as follows: 7 resupply, 1 convoy escort, 4 assault troop lift, 3 Psy War and 2 for spot/observe mission.
4. There continues to be a shortage of O-1 aircraft for useful and potentially highly productive missions.
5. Emergency med-evacs have become increasingly sluggish. Examples: 251210H request sent, 251300H request completed, mission number 11 E; 201400H : sent, 201500H complete mission 11 K; 192335H sent, 200050H complete mission 11 N; 111757H sent, 111945H complete mission 12 K; 071444H sent, 071533H complete mission 7 I; and 021850H sent, 021931H complete mission 7 P. This represents only emergency missions where time space factors are believed to be excessive. It is considered that weather was not a contributing factor.
6. As should be expected, adverse weather has caused abortion or cancellations in the number of missions requested by this command. During the monsoon season, weather will continue to inhibit air operations throughout the Battalion TAOR.

SECTION X

CIVIL AFFAIRS ACTIVITIES

1. Significant Activities. During the month of November, 3,342 Vietnamese Civilians were administered medical aid at the Battalion's four daily MedCAP stations. The total treated was appreciably less than the 5,223 treated during the month of October. The decrease in treatments was a result of a combination of factors. Numerous days of inclement weather forced the closing of two locations intermittently as well as caused the people to remain at home on other days. The MedCAPS at Cam Lau Bao and Dong Cau Phi were closed on 18 November, when Company "H" was moved because of the realignment in the Battalion's TAOR. MedCAP activities were hindered throughout the month because of the lack of supplies.

As part of the Battalion's Indoctrination Program for Marines arriving from COMUS, a program was initiated during November to explain to each replacement what he can do in the field of Civil affairs.

2. Material Distributed. Through the MedCAP program, over 1,000 bars of soap and 3,000 vitamin pills were distributed to Vietnamese Civilians.

3. Special Civil Affairs Projects. Due to several traffic accidents in recent weeks as a result of speeding vehicles, forty-eight speed limit signs are being painted for posting along route 1. It is hoped that the signs, printed in both English and Vietnamese, will aid in the prevention of traffic accidents. A combined Marine and ARVN road patrol was also established to check on speeding marine and GVN vehicles.

As soon as medical supplies become available, a MedCAP program will be started in four new locations within the Battalion's TAOR. As a result of the shift in the TAOR, Companies "G" and "H" are located in areas where no MedCAP program was previously established.
