

NARRATIVE SUMMARY (S)

1. Throughout the reporting period subordinate units of this command were assigned missions as follows:

Company A, Direct Support of 1st Marines.

Company B, Direct Support of 5th Marines.

Company C, Direct Support of 7th Marines. (U)

2. 1-31 July 1967. The Civic Action Program for the month of July included the treating of 581 people in Yen Bac and Cam Hoa Hamlets (AT985708 and AT975703). An outdoor movie theater was built for Yen Bac and 350 people from that hamlet viewed Psyops films during the reporting period. The hamlet water pump was repaired several times, and Yen Bac was given 200 gallons of gas to run the pump. Also 300 pounds of rice were given to Yen Bac Hamlet to help hold them over till the September harvest. A chicken farm is being set up, and plans are under way to build a new water pump, hold an Elder's Festival and distribute winter clothing at Yen Bac Hamlet. (U)

1-31 July 1967. The Battalion continued its mission of supporting the Southern Sector Rear Area Defense by running both day and night patrols and Operations in the assigned SOR. The additional commitment of providing a rifle squad to patrol the Western flank of the Southern Sector was also accomplished. (U)

1-31 July 1967. The Ontos mounted 106mm RR standdown was still in effect during the month of July. A total of 15 Ontos have had .50 caliber machine guns mounted (two per vehicle), and these have proven to be effective. (S)

1-31 July 1967. During the month of July the Battalion fired a total of 3 106mm rounds, 2,425 rounds .50 caliber, 2,490 .30 caliber rounds. The Battalion Ontos traveled a total of 3,182 miles. (U)

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS (U)

- 7 July Ontos A-34 of Company A struck a land mine estimated 30 pounds TNT at coordinates BT117628, resulting in 3 USMC WIA Non-medevac. Right suspension system was destroyed and the Ontos was evacuated two weeks later. All 3 WIA's returned to duty after first aid.
- 8 July Two Ontos from 3rd Platoon, Company B, with a reinforced platoon from Company K, 5th Marines, left at 0600H as a reaction force to assist platoon under attack at coordinates BT219358. Vehicles fired 400 rounds .30 caliber at fleeing VC in treeline. Area was swept by Company K; Results, Unknown.
- 12 July 3rd Platoon, Company C, with light section from 2nd Platoon, Company C, began Direct Support of 3rd Battalion, 7th Marines, on Operation GEM. At 1700H Ontos C-34 at coordinates AT862563 spotted two VC running into a house.. Fired 25 rounds of .50 caliber machine gun which were on target. Area not searched due to water barrier. Results: 2 VC KIA Probable.
- 14 July At 1130H Ontos C-34 in support of Operation GEM at coordinates AT863566 picked up 15 male and 2 female refugees-Ages 10-50; two(2) turned over to 3/7. Results: 2 VC Suspect.
- 15 July Operation GEM secured.
- 16 July **Two Ontos from 1st Platoon, Company B on a search and destroy mission with 2nd Platoon, Company L, 5th Marines, were engaged in a two sided ambush by an unknown number of VC firing automatic weapons at coordinates BT112468. Ontos expended 300 rounds .30 caliber and, on order from infantry Platoon Commander, fired two round HEPT 106mm, and one round 106mm FLECHETTE. Firing ceased. Area was searched with unknown results.**
- 17 July At 1400H 3rd Battalion, 7th Marines at Hill 10(coordinates AT923693) spotted VC Battalion at coordinates AT900710. The 3rd Platoon, Company C moved 4 Ontos to Hill 10. No contact was made.
- 19 July At 2310H Ontos C-35 located at coordinates AT923693 spotted 10 VC at coordinates AT932712 and fired 23 rounds.

The following morning a patrol from 3rd Battalion, 7th Marines found several blood trails and drag marks. Results: 3 VC KIA Probable.

- 21 July At 0800H, Lieutenant Colonel P. D. REISSNER, JR. assumed command of the Battalion, relieving Major P. S. GALLIGAN who became Executive Officer.
- 25 July Ontos A-12, 1st Platoon, Company A, at coordinates BT055675, passed over an enemy box type land mine, pressure detonated with 25 pounds TNT, which detonated after the vehicle passed over it. Results: Minor damage to the vehicle and 2 USMC WIA Non-medevacs. Both WIA's returned to duty after receiving first aid.
- 29 July Ontos C-12 medevaced 3 USMC WIA's from 1st Battalion, 7th Marines, from coordinates AT948583 to BAS Hill 55 (Coordinates AT968622).
- 29 July Ontos A-13, 1st Platoon, Company A, while located at coordinates BT069677 received 300 rounds automatic weapons fire from 15 VC at coordinates BT069678. A-13 returned 200 rounds .30 caliber. Search of area was made, and blood trails were found. Results: 2 VC KIA Probable.

1. Throughout the reporting period, subordinate units of this command were assigned missions as follows:

1st PLT, DS 3rd Bn First Marines

2nd PLT, DS 2nd Bn First Marines

3rd PLT, DS 1st Bn First Marines

2. 1-31 July 1967. The Ontos were in DS of the 1st Marine Regiment. Company A continued to provide Ontos for escort missions, mechanized patrols, and defensive positions.

3. 1-31 July 1967. The Ontos fired (0) 106mm rounds, (0) .50 cal. rounds, and (200) .30 cal. rounds. The Ontos traveled 674 miles in 661 hours of operation.

PART III

SEQUENTIAL LISTINGS OF SIGNIFICANT EVENTS

- 7 July THIRD PLATOON: A-34 hit enemy land mine at 117628 resulting in 3 USMC WIA NON MEDEVAC. The Ontos and all gear were salvaged. Mine was a pressure detonated with 30 pounds of explosives. (See Ref (A)).
- 25 July FIRST PLATOON: A-12 hit enemy land mine at 055675 resulting in 2 USMC WIA NON MEDEVAC. The Ontos was slightly damage and all the gear was salvaged. Mine was a pressure detonated box type of approximately 25 pounds of explosives which detonated after the Ontos had passed over it. (See Ref (B)).
- 29 July FIRST PLATOON: A-13, while at 069677, received 300 rounds automatic weapons fire from 15 VC in village at 069678. A-13 expended (200) .30 cal. rounds resulting in 2 VC KIA Probable. Search was made of the area and blood trails were found. (See Ref (C)).

During the month of July the Ontos was still restricted from firing the 106's. The .50 Cal. machine guns proved effective as they resulted in five (5) VC KIA (Probable).

The Ontos of Company C fired 60 rounds of .50 Cal. linked and 300 rounds of .30 Cal. and traveled 1770 miles in support of infantry units.

- 7 July 1967 At 0600H Two Light Sections from 1st Plt. Company C with eight (8) Amtracs and eight (8) Tanks went on sweep with Construc B, in vicinity of AT960530.
- 7 July 1967 At 0930H Two Light Sections from 1st Plt. Company C moved to C 1/7 blocking positions at AT945535, arrived in blocking positions at 0945H.
- 8 July 1967 Light Section from 1st Plt. Company C on patrol with Construc C at 1130H in vicinity of AT950535 with Negative Results.
- 9 July 1967 At 1130H Light Section departed C 1/7 Combat Base for blocking position in vicinity of AT945535. Discovered dud 81mm mortar round in road at AT934523. Round was blown in place. Negative Results.
- 9 July 1967 At 1700H Two Light Sections from 1st Plt. Company C returned to Hill 55.
- 10 July 1967 Negative.
- 11 July 1967 C-11 and C-12 on patrol with two squads from Construc Charlie in vicinity of AT928502. Negative Results.
- 11 July 1967 C-15 at Construc Alpha AT941579 received fifty (50) rounds small arms fire from the vicinity of AT941581. Returned fire with 30 rounds .30 Cal. Negative Results.
- 12 July 1967 3rd Plt. Company C, with Light Section from 2nd Plt. Company C in support of 3/7 on "Operation GEM".
- 12 July 1967 At 1330H C-34 AT861566 in support of Operation "GEM" received ten (10) rounds small arms fire from AT863562. Returned fire with fifty (50) rounds .30 Cal. and fifty (50) rounds .50 Cal. Linked at sniper running into house. Negative Results.
- 12 July 1967 At 1700H C-34 at AT862563 spotted two VC and fired 25 rounds of .50 Cal. Linked rounds which were on target. Two (2) VC KIA (Probable).

13 July 1967 At 1330H Light Section from 1st Plt. Company C on patrol in vicinity of AT920540 with squad from Construe B. Negative Results.

13 July 1967 3rd Plt. (Rein), Company C in support of Operation "GEM". Negative Results.

14 July 1967 At 1130H C-34 in support of Operation "GEM" picked up 15 males and 2 females, refugees - ages 10-50 years old. Two (2) were turned over as VCS, results Two (2) VCS.

15 July 1967 3rd Plt. (Rein), Company C secured from Operation "GEM".

16 July 1967 2nd Plt. Company C moved a Light Section from Hill 55 to Construe Charlie CP.

16 July 1967 Light Section from 2nd Plt. Company C AT955522 received approximately 40 rounds to 50 rounds small arms fire from AT956522. Returned fire with 500 rds. of .30 Cal. Negative Results.

17 July 1967 At 1400H 1 VC Battalion spotted at AT900710. 3rd Plt. Company C moved 4 eagles to Hill 10 at AT923693.

17 July 1967 3rd Plt. Company C moved to Hill 10 at AT923693 to reinforce K 3/7, that spotted 1 VC Bn. at AT900710.

18 July 1967 3rd Plt. Company C returned to Hill 37 at 1000H. Negative results.

18 July 1967 At 0900H 2nd Plt. Company C moved two vehicles from Construe C CP. One went to Alpha CAP and one to Hill 55.

19 July 1967 At 0930H Heavy Section from 3rd Plt. escorted armor convoy to Hill 48 at AT862581.

19 July 1967 At 2310H C-35 at AT928707 spotted 10 VC at AT932712. Fired 23 rounds .30 Cal. Negative Results.

20 July 1967 Results of C-35's firing on 19 July 1967 was changed to 3 probable VC KIA after area was searched by 3/7.

21 - 23 July 1967 Negative.

No significant mechanical failures were encountered and the Ontos proved to be completely reliable.

15. Recommendations. That the Ontos be employed with the maneuver element in the future.
