NARRATIVE SUMMARY

1. Company B was assigned in direct support of 5th Marines and Company C in direct support of 7th Marines during the entire reporting period. Company A (-) was attached to 1st Marines throughout the reporting period.
2. 1-30 Nov 1967. The Civic Action Program for the month of November included the MedCap treatment of 316 people from Yen Bac and Cam Hoa (2) Hamlets. One truck load of dunnage lumber and 15 bags of cement were delivered to each of the hamlets for use in the construction of public wells and other building projects. Four movies were shown in Cam Hoa (2), attended by 150 people.
3. 1-30 Nov 1967. The Battalion continued its mission of supporting the Southern Sector Rear Area Defense by running both day and night patrols in the assigned SOR. In addition, an augmentation squad was furnished for the bridge security forces on a regularly scheduled basis. OP Tiger was maintained as an integral part of local cantonment security.
4. 1-30 Nov 1967. The operational firing standdown on the Ontos-mounted 106mm Recoilless Rifle remained in effect for all units OPCON to 1st MarDiv. ACo (-) (OPCON 3rd MarDiv) fired upon request in support of 1st Marines. All other 106mm firing was conducted as live firing exercises for the purpose of maintaining gunnery skills and safety procedures.
5. 1-30 Nov 1967. The Battalion continued to provide Ontos for escort missions, mechanized patrols and defensive positions.
6. 1-30 Nov 1967. The Battalion fired a total of 20 rounds 106mm in combat and 134 rounds for training, 192 rounds of Cal.50 spotter-tracer, and 2905 rounds Cal.30. During the month the Ontos of 1st ATBn traveled 2700 miles.

- 1 November Company A. Received five rounds sniper fire at YD287534 and spotted 1 VC moving with rifle. A-11 and A-25 expended total of two 106mm rounds. Negative results.
- 5 November Company A. Received six rounds sniper fire at YD285528. Returned four 106mm rounds. Search conducted with negative results.
- 8 November Company C. Received one unknown caliber rocket inside wire and five outside wire at AT863574. C-33 returned 30 rounds caliber.30. Negative results.
- 8 November Company C. Third platoon CP received unknown quantity of mortar fire in conjunction with heavy small arms fire from vicinity AT918578. C-35 returned 200 rounds caliber.30. Results unknown.
- 9 November Company B. B-24 detonated 40 Lb. mine while on road sweep escort at AT909507. Three road wheels and track destroyed, Hull split. Two USMC WIA (NE).
- 11 November Company A. First platoon commander detonated delay-fuzed device 15 feet to his rear. No casualties.
- 16 November Company B. B-11 and B-12 fired on by three automatic weapons from AT990630. Returned fire with caliber.30. No search conducted.
- 21 November Company B. B-12 received approximately 100 rounds automatic weapons fire from vicinity AT988638. Returned fire with caliber.30. No search conducted.
- 24 November Company A. A-11 and A-13 received 15 rounds automatic weapons fire at YD277521. Expended total of ten 106mm rounds. Search conducted with negative results.
- 26 November Company A. A-13 detonated 50-60 Lb. Box mine at YD293523. Tracks and road wheels destroyed, hull bent, engine compartment floor split. 2 USMC WIA (NE).
- 26 November Company A. A-11 received five rounds sniper fire from vicinity YD284514. Expended one 106mm round and 50 rounds caliber.30.

NARRATIVE SUMMARY

1. Throughout the reporting period, subordinate units of this command were assigned missions as follows:

Company A, 1st Antitank Battalion attached to 1st Marines

1st Platoon, GS 1st Battalion, 1st Marines - 2nd Battalion, 4th Marines

2nd Platoon, GS 2nd Battalion, 1st Marines

2. 1 - 30 November 1967. The Ontos were attached to the 1st Marines. Company A (-) continued to provide Ontos for, mechanized patrols, sweeping forces and maintaining defensive positions within the 1st Marines' tactical area of responsibility. Company A (-) participated in no major operations during this period.

3. 1 - 30 November 1967. The Ontos fired (66) 106MM rounds, (38) .50 Cal. spotter rounds, (50) .30 cal. rounds. The Ontos traveled (482 ) miles with (294) hours of engine operation.

- 1 Nov FIRST PLATOON: At coordinates 288533, 4 VC with weapons were spotted moving into a treeline. A-11 expended (3) 106MM R.R. rounds with negative results. Unable to search area.
- 1 Nov FIRST PLATOON: At coordinates 287534, received 5 sniper rounds and spotted 1 VC moving with rifle. A-11 expended (1) 106MM R.R. round A-25 expended (1) 106MM R.R. round. Negative results. (See ref (A))
- 5 Nov FIRST PLATOON: At coordinates 285528 Company A units received 6 sniper rounds. Units returned (4) 106MM R.R. rounds. Search conducted with negative results. (See ref (B))
- 11 Nov FIRST PLATOON: At coordinates 295532, 1st Platoon Commander tripped booby trap device with delayed fuse. Device exploded 15 feet behind the Marine. Negative casualties. (See ref (C))
- 24 Nov FIRST PLATOON: At coordinates 277521 units received 15 rounds automatic weapons fire. A-11 expended (5) 106MM R.R. rounds, A-13 expended (5) 106MM R.R. rounds. Area searched with negative results. (See ref (D))

26 Nov FIRST PLATOON: At coordinates 293523, A-13 struck mine, estimated between 50 to 60 pounds (Box type). Tracks and road wheels destroyed. Hull bent and engine compartment floor split. 2 USMC WIA.

A-11 received 5 rounds sniper rounds from coordinates 284514. A-11 returned (1) 106MM H.R. round, (50) .30 Cal. machine gun rounds and (10) 5.56MM rifle rounds. With negative results. (See ref (E))

Narrative Summary

1. The Ontos of Company "C" continued in direct support of the 7th Marine Regiment. The Ontos traveled 1,208 miles in support of infantry units while conducting mechanized patrols, road escorts and establishing perimeter defenses.

- a. 1st Platoon (-) in DS of 1stBn 7th Marines
- b. 2nd Platoon (-) in DS of 1stBn 7th Marines (1 - 13 November 1967).  
2nd Platoon (-) in DS of 3rdBn 7th Marines (14 - 30 November 1967).
