

PART II  
NARRATIVE SUMMARY

During August the major effort of the First Field Artillery Group continued to be long range fires into the A SHAU Valley, general support for the 3d Marine Division with priority to deep reconnaissance activities and close defence/counter mortar/counter battery fires in defense of the fire support base. During this month the First Field Artillery Group occupied two separate locations. The command group, consisting of the operations platoon and the communications platoon were located within the Cumberland area, and the administrative and supply sections remained in the Phu-Bai TAOR.

Operation Cumberland First Field Artillery Group employing light, medium and heavy artillery supports elements of the 3d Marine Division from the established fire support base at grid YD 620095, from which heavy artillery (175mm Gun) can attack targets in the A SHAU Valley, and light/medium artillery (105mm/155mm) can provide supporting fires for ground operations.

At 310800H July 1967 a platoon of 155mm Guns was Chopped OPCON to the First Field Artillery Group. This platoon arrived at the Cumberland fire support base at 021345H August 1967. On 032300H the platoon was Chopped OPCON to the 4th Battalion 12th Marines but remained in the Cumberland area until 5 August 1967. The platoon was assigned the mission of long range fires in support of the fire support base and its adjacent areas.

At 010915H August 1967, Battery "A", 2nd Battalion 94th FA(USA)(175mm Gun) fired the first round of 175mm Gun ammunition into the A SHAU Valley from the Cumberland fire support base located at grid YD 620095.

Battery "A", 2nd Battalion, 94th FA. (USA) remained in support of "Operation Cumberland" until 090700H August 1967 when they displaced from the fire support base and proceeded to Phu-Bai for transportation to another operating area.

Battery "A", 2nd Battalion 94th FA (USA) at 101000H August 1967 was Chopped OFCON from the First Field Artillery Group to the 2nd Battalion 94th FA.

At 020900H August 1967, Battery "B", 6th Battalion, 27th FA (USA) (4-175mm Guns) arrived at the fire support base and occupied grid YD61850919. Immediately after occupation of position, Battery "B" commenced firing long range fires into the A SHAJ Valley.

a. Organization

b. Operations. The First Field Artillery Group during the month of August continued to participate in operation Cumberland. This operation commenced prior to the reporting period and continued throughout the month of August.

The Commanding Officer First Field Artillery Group is designated as the area commander of Cumberland area of operations.

The mission of the fire support base at Cumberland is to place long range fires into the A SHAU Valley utilizing heavy artillery weapons (175mm Guns), provide deep supporting fires for long range reconnaissance patrols for units of the 3d Marine Division. The light/medium artillery weapons (105mm/155mm) are to provide supporting fires for ground operations and defense of the fire support base.

The First Field Artillery Group fired a total of 3,856, 175mm rounds into the A SHAU Valley during the month of August 1967.

#### 4. Enemy, Weather, Terrain

There was little intelligence matter received other than periodic intelligence summaries and target listings within the A SHAU Valley.

On 3 August a counter-mortar plan was put into effect which was to support the fire support base at grid YD 602095. This plan was updated and published on 12 August 1967 to include those weapons located at Battery "G", 3d Battalion, 12th Marines position grid YD 7161C7. This fire support base is also mutually supporting Battery "G", 3d Battalion, 12th Marines position with on-call counter-mortar fires.

The weather was generally good with only a few days of precipitation towards the later portion of the month. Weather did not effect any movement or commitments at this base. During several short periods 175mm gunfire into the A SHAU Valley (Zone 3) was delayed due to heavy rain. The heavy rain caused premature bursts with Fz Q.

#### 5. Training.

Due to personnel shortages and operational commitments, training, other than on-the-job training was negligible during the period.

In order to ease the work load created by shortage of personnel within certain occupational specialities, security personnel were given the opportunity to cross-train into critical occupational fields with the battery.

#### 6. Civic Action. There was no significant civic action.

#### 7. Logistics

Normal logistics support continued for the First Field Artillery Group located at Phu-Bai and also at the Fire Support Base grid YD 620.

During August a Logistical Support Area was established at the fire support base.

The LSA performed the logistical support duties for the Cumberland area. All items were procured by the LSA except class II spare parts and organizational equipment.

Headquarters Battery normally dispatched one M-35 and one M-38 daily to the fire support base. The vehicles were used mostly for rotation of personnel, personal effects, ice, beverages and certain supply items.

On 21 August while proceeding to the fire support base a conveyance containing the headquarters battery vehicle was attacked and during the battle an M-35 (6x6) was burned and destroyed by an RPG rocket. The burned chassis was later returned to the fire support base and then returned to Phu-Bai for desposition.

- 211045H: One M-35 (6x6) was burned and destroyed while enroute to the fire support base within a Fourth Marines convoy, resulting with four marines from 1stFAG WIA.
- 220545H: Fire support base was under attack by enemy mortars. The mortars were spotted on hill grid YD627083 and taken under fire by 60mm and 81mm mortar sections of A and B Companies of the 1st Battalion, 4th Marines which are security for the fire support base. The attack ended at 220605. There was extensive damage to engineer equipment within the area, which included, TD-15's, trucks, trailers, sawmill, and portable electric saws.
- 220620H: Battery "B", 6th Battalion, 27th FA(USA) reported 3 WIA non-medevac in battery position.
- 220830H: Patrol from "A" Company, 1st Bn, 4th Marines returned from vicinity of VC/NVA mortar site, indicated there was blood and drag marks in area.
- 282030H: Conducted counter-mortar drill, results satisfactory.
- 312400H: Journal Closed.
