NARRATIVE SUMMARY

1. During the period covered by this Chronology, Headquarters and Service Battalion (-), Reinforced, 1st Force Service Regiment/Force Logistic Command, Fleet Marine Force, Pacific provided command, administration, communication, and transportation support for the Force Logistic Command/1st Force Service Regiment and other supporting services to Marine Division/Wing elements of the Third Marine Amphibious Force deployed in the I Corps Area, Republic of Vietnam as depicted in the mission, which included graves registration, fumigation, bath and laundry, air delivery, materials handling, mess, utilities and construction and other logistical services as required in executing additional tasks, to include personnel/services, operational supervision and logistical support for two (2) Combined Action Platoons; personnel and supporting services for the operation of the Third Marine Amphibious Force Transient Facility; operational supervision and personnel for internal and perimeter security defense of Force Logistic Command units located at Camp Books, Red Beach Complex, Banang.

## PART III

e. On 20 May 1967, the Commanding General, Force Logistic Command presented an award of the Purple Heart Medal to Corporal Paul J. DAVIS 2197392/3051 USMC for wounds received in combat action while in support of the Forces of the Republic of Vietnam in their struggle with the insurgent communist (Viet Cong) forces on 18 May 1967.

## 2. Administration

a. Normal Command Administration at Battalion level. Companies are not self-sufficient administratively.

b. Savings Bond participation within the Battalion increased to 96.9% during May 1967.

## 3. Intelligence

a. Pacification of this Sub Sector continues. Vietnamese officials as well as the people within the villages and hamlets pass information on Viet Cong movement, however, almost all the information is received after the event. It is difficult for the Vietnamese to pass the information within the time frame required for friendly forces to react to the situation. During this reporting period there was one report received that proved to have some substance to its credibility. This report was received by CAC-E-2 on 9 May 1967 and passed to higher and adjacent units. The report contained information that a Viet Cong platoon from north of KIM LIEN had a mission to attack the hamlet chief and popular forces in KIM LIEN by 150100H. This attack did in fact take place on 10 May 1967.

b. Many reports of impending attacks have been received and in almost all cases a reaction to the information has been planned and executed. On the basis of the number of reports received, it is difficult to determine which of these will result in an actual attack.

## 5. Special Operations

a. Combined Action Platoons Echo-2 and 3 conducted a total of 117 patrols during May 1967. There was not any contact made during this period.

b. On 14 and 15 May 1967 the Air Delivery platoon dropped 21 A-22 containers of ammunition, water, C-rations and MO-gas to the 3rd Battalion, 9th Marines.

c. On 18 May 1967 a joint operation by the Security Platoon, CAC, and G 2/7 swept GODAU island resulting in the pick up of two detainees.

8. Logistics

a. Logistic Support Unit 2/9 was hosted during the period 8-28 May 1967

b. B Company, 7th Motor Transport Battalion was hosted during the period 20-31 May 1967.

#### 9. Community Relations

a. On 2 May the HOA KHANH market place was completed and dedicated. This market provides stalls for 100 farmers to display and sell their produce.

b. On 7 May the TRUNG PHUOC Primary School was completed and dedicated. This school provides classroom space for 180 students.

c. At Da PHUOC, 13 houses started on 8 May were completed before the end of the month. This is a continuing project which, upon completion, will consist of 40 houses.

d. On 15 May at PHUOC NGHIA, a hat factory was started which is scheduled for dedication on 4 June 1967. This factory will provide an area to work in for about 25 hat workers. The hats are to be sold as souvenirs.

e. On 28 May at HOA HIEP and on 31 May at HOA KHANH, meetings were held with the village leaders and elders. Those meetings were considered successful in that many subjects were broached and discussed. It was the feeling of those attending the meetings that everyday the Vietnamese are understanding and appreciating more the efforts of the Marines located in this area.

f. On 30 May 1967 movies were shown in the hamlet of NAM O. It is estimated that over 400 local citizens attended. The cartoons drew very favorable response by the children. The adult movie depicted a soap opera type story of one Viet Cong brother pitted against a pro-government type brother. The response of the people was outstanding in that they cheered the efforts of the pro-government brother and seemed pleased that the Viet Cong was finally won over.

g. Lieutenant Colonel CORSON, the Combined Action Program Coordinator from III MAF, selected CAC, Echo-2 as the location in which to film a narrative film for a CBS television team depicting the CAC program in the Republic of Vietnam.

h. The MEDCAP program conducted at the CAP compounds and during friendship patrols treated 2,020 persons for minor sicknesses and injuries.

#### 10. Communications

a. Normal

b. Message Center on 1 May became a tributary of the DCS System, terminating its circuits with III MAF Headquarters.

c. While operating at reduced strength during the first 25 days of May, 16,330 messages were handled in contrast to 16,450 for the entire month of April.

d. Radio Platoon installed and is now operating a 24-hour covered radio circuit between the Force Logistic Command Operation Center and Force Logistic Support Group Alpha, using the RT 524, KY-6/B and RC-292.

#### 11. Redesignations

a. No redesignations were made.

#### 12. Miscellaneous Services

a. The MARS Station processed 121 messages and completed 941 phone patches. A significant event was the record long distance call placed on 25 May 1967 to Irvine, Yorkshire, Scotland, with clear reception.

b. The Laundry processed 51,870 pounds of clothing.

c. The Transient Center billeted 24,224 personnel during the month. A total of 53,986 meals were served during this period.

d. Support Company assumed technical operation and control of all Marine Graves Registration Units in I Corps.

e. The Graves Registration Section processed a total of 706 remains during the month of May 1967.

The adult movie depicted a soap opera type story of one VC brother pitted against a pro government type brother, the response of the people was outstanding in that they cheered the efforts of the pro government brother and seemed pleased that the VC was finally won over.

d. Lt. Colonel CORSON, the Combined Action Program Coordinator from III MAF selected CAP Echo-2 as the location in which to film a narrative for a CBS television team depicting the CAC Program in the Republic of Vietnam.

e. The MEDCAP program conducted at the CAP compound and during the friendship patrols treated 2,020 persons for minor sickness and injuries.

f. Vietnamese and English classes are being conducted on a regularly scheduled basis.

g. The construction of DA PHUOC Refugee Camp was initiated in April 1967. This was not reported in the April Command Chronology. The camp will consist of 40 duplex homes of brick construction. Future occupants of each home are providing the labor. CAP Echo-3 is providing direct liaison under the supervision of Headquarters and Service Company for procurement of material through the civil affairs program. The Vietnamese under the control of Father SACH appear to be well organized. Estimated time of completion is June 30, 1967.

## PART II

NARRATIVE SUMMARY

1. During the period covered by this report, Communication Company continued to provide support to the Red Beach Complex and other units of FLC not at Red Beach.

Radio Platoon installed and is now operating a 24 Hour covered radio circuit between the FLC Logistic Operations Center and FLSG-A using the RT 524, KY-6/B and RC-292 equipment. In addition, radio equipment (MRC-83)

and operators were provided to 30th NCR on a test basis for a shot to Saigon in order to determine exact equipment needed to establish a reliable radio link from Danang to Saigon. Also, communication support was provided for CG, FMFPac, Lt Gen V. H. KRULAK on his visit to Red Beach during the month.

The Maintenance section repaired over 150 items of equipment for the Company and received additional technical help when three technicians reported aboard, two of which were SNCO's. One man, Corporal SPRALDING returned from Lenkurt C-26 Modem School, Clark AFB, Philippines.

Wire Platoon cleared over 100 trouble reports, in addition to relocating 18 instruments plus performing 300 test in the Frame Room. Also the new annex to FLC Headquarters was wired for phone service.

Message Center on 1 May became a tributary of the DCS system, terminating its circuits with III MAF Headquarters. While operating at severely reduced strength during the first 25 days of May, 16,330 messages were handled in contrast to 16, 450 for the entire month of April.

1. Purpose. The team's purpose is to evaluate, educate, and recommend ways to improve the present 1st and 2nd echelon preventative maintenance/supply procedures. This is accomplished by holding informal periods of instruction, examination of equipment, vehicle/supply records, observations of shop/supply procedures and work flow. The entire maintenance spectrum is dependent on the success or failure of its first echelon maintenance program. The purpose of preventative maintenance is to stop failures before they start. This team recognizes the overwhelming odds the units are plagued with (geographic elements lack of adequate numbers of vehicles and/or talents, tools and/or special equipment and facilities).

2. Topic. Noted Observations.

a. Personnel Status.

(1) One Major (3502), One Capt (3502), One 1stLt (3502), One 2ndLt (3510), One W.O. (3510), One MSgt (3537), One MGSgt (3537), One MSgt (3516), One GSgt (3516), Two GSgt (3537), Two SSgt (3516), and Two SSgt (3537).

(2) Total Personnel on hand 242 of which (54 are 3516's)

(3) NOTE: Not Included in the above figures are Thirty Motor Transport Personnel working out of their MOS (3537/3516/3531) of which six are Staff NCO's.

b. Vehicle Status.

(1) 321 end items of which (209 are prime-movers)

(2) Twenty (20) vehicles are deadlined.

c. Review of Master Dispatch Log, trip tickets, vehicle record folders, and tactical equipment repair orders revealed that some were incorrect and/or not properly completed. Examples:

(1) Master Dispatch Log - Very Good. Average daily mileage 6000 miles.

(2) DD-110 Trip Tickets - Using locally reproduced forms. Some vehicle operators change w/o being redispached (usually S/NCO's). Many Officers are operating -- Many errors in Trip Tickets; improperly filled out, (missing/improper fuel entries; missing/improper load/cargo entries; missing release signatures; missing/improper trip entries (This pertains mostly to light vehicles and "U-Drives"). Officers must have in their immediate possession authorization to operate Government motor vehicles in accordance with paragraph 203011.7 of MCO P4400.20, Vol II, MARCORSUPMAN Recommend Bn Co designate in writing, Officers authorized to operate Bn Motor Vehicles.

(3) DD-314 PM Schedule and Record - Many weeklies not performed (#186146 has had one weekly since receipt 11Feb67). Recommend schedule be balanced (8 M35 "A-PM's" due in Jan). Recommend PM's be rescheduled from scheduled date Vice completed date (do not erase penciled entries).

(4) Vehicle Jackets - Recommend stricter final inspection procedures (#312096 "A" PM 4Apr67 24134 miles-- 6Apr67 25144 miles "tune-up" 14Apr67 25331 miles "Tune-up"). Reminder to dispose of excess "Q" and A-PM forms. Return "Quality control reports" on new vehicles to MCSC within 60 days.

(5) Tactical Equipment Repair Orders - Recommend Shop Chief, inspector, Records Clerk, and Operations Chief sign appropriate blocks. Annotate brake lining wear on 10490 and 10491 forms. Jeep fuel tank wells must be cleaned on "A-PM's", if not sooner.

d. That the mechanics tool kits were found to be short and/or unserviceable tools. The motor transport personnel require additional guidance in the care and use of hand tools and hydraulic/mechanical jacks. (96 Gen mechanics tool kits ordered 30Jun66) Ref: FMFPac ltr 4C/4: JF over 441 dtd 30Jun66. Requisitions are listed as pending on obligation listing.

e. Due to the lack of knowledge on the part of the vehicle operator's many repairs and adjustments that are beyond the operator's capabilities to correct are not being reported to the maintenance personnel.

f. Spot observations of selective vehicles revealed that more emphasis is required in the inspection and lubrication system to observe and control the quality of operator's (1st echelon) and mechanics (2nd echelon) preventative maintenance practices.

3. Recommendations and/or reminders for Improvements.

a. That all supervisory personnel conduct frequent spot inspections to ascertain the qualities of drivers (1st echelon) maintenance and to ensure expeditious corrective action. Ensure drivers are annotating and reporting all discrepancies that may exist on the vehicle trip ticket.

b. That closer supervision and continued instruction/education be given drivers while engaged in daily end/or weekly PM services. (Operations supervisors and/or 3516 maintenance personnel). Ensure that all drivers review the PM's applicable to the vehicle which they are operating in order to increase their knowledge and perform quality (1st echelon) maintenance. (See reference (d)).

c. That closer supervision and continued instruction/education be given all mechanics while engaged in daily interim repairs "Q" and/or "A" PM's. (Maint Chief, Shop supervisors and Inspector). Ensure that all mechanics review the TM's applicable to the unit vehicles in order to increase their knowledge and perform quality (2nd echelon) maintenance. Ensure that all items and/or components that have been replaced and/or serviced by the maintenance personnel have been lubricated prior to release of the vehicles from the shop and/or maintenance area. (Gear boxes, drive shafts/U-joints, emergency brake shoes, carburetor (5ton), water pumps, distributors, air-packs, governors (gas), rear spring seat bearings, etc.).

d. To give reasonable assurance of trouble free operations until next "Q" and/or "A" PM services, establish tune-up procedures, fully utilizing test equipment and all prime-movers should receive a "minor tune-up" on all Q1 and Q3 PM's and a "major tune-up" on all Q2 and A-PM's. Annotate tune-up and what wheel to inspect on TERO's to ensure that the mechanic understands exactly what he has to do. In addition, remind the mechanic to check all body mounting hardware, spring U-bolts, motor mounts, drive shafts for tightness, steering gear adjustments, air and fuel filter, and all gear box (vents) breathers.

e. Tightening of body and/or chassis hardware (nuts and bolts). Clean threads, saturate with penetrating and/or PL oil. (Allow adequate time for lubrication to penetrate threads). Use a torque wrench when areas of torque specifications are required. (When torque is used, ensure threads are clean and free of lubrication and/or foreign material). On other hardware do not overtighten as this may strip threads or cause distortions, tightening will always be understood to include the correct installation of locking wire and/or cotter pins, locknuts to secure to tightened nut.

f. Ensure compliance with all MI's/PI's and SI's. In addition, ensure all pertinent publications and directives are available at the working level. (See reference (c), para 301.3D)

g. To preclude deterioration, all deadlined vehicles must be maintained in accordance with reference (c), paragraph 313, that frequent inspections be conducted by supervisory personnel of deadlined vehicle to ensure vehicles are being serviced and not cannibalized.

h. Eliminate light and heavy workloads for maintenance personnel by programming and monitoring scheduled maintenance services 90 days in advance on the DD-314 Cards. Ensure to marry trailers with prime-movers during weekly, "Q" and/or "A-PM's" services.

i. Paint all M-422 nylon engine vent tubes (TM9-2320225-20 change 3, page 95, para 77 of 3 May 1965). To prevent deterioration and cracking of these lines, they should be cleaned with an authorized cleaning solvent and painted with two coats of Marine Corps Green enamel using brush or spray-gun.

j. All spare parts obtained by scrounging and/or selective interchange be reported on a local form and/or DD-1150 to Bn Supply for valid usage data.

k. A continuous requirement - In accordance with reference (c), para 301.3D and 302, ensure the availability of the vehicle with operator when due for scheduled weekly PM's and/or the maintenance personnel when vehicles are due for scheduled "Q" and/or "A" PM services. (Many vehicles not available when due for scheduled PM's).

l. A continuity file be maintained by the M.T. Officer to ensure references and guidance in the event of sudden absence or transfer. (Local ground rules and various area contacts regarding Motor Transport Operations/Repairs.)

m. Excellent driver education training. Advised Chief Instructor available for only one hour a day due to reassignment as Bn Career Advisor.

#### 4. Additional Remarks.

a. The above recommendations and finer observations were thoroughly reviewed and instructions were held at great lengths to all Motor Transport personnel available, in addition, many references including hard to find FSN's, tools, and equipment, and the latest MI's, TI's and SI's were reviewed and left overnight with the Motor Transport personnel to increase their knowledge and the quality of performed maintenance.

b. It was a pleasure for the instruction team to visit with this Unit. The attention and cooperation given this team by the Motor Transport personnel was outstanding.

Self-Service was introduced in the RVN when a Store was officially opened at Camp J. Books on 23 May 1967. Interest expressed by using units indicates the facility is most welcomed. Sales amounted to \$9,395 during the first week of operation.

Unit Distribution of Bakery Products commenced during May. All units in the DaNang TAOR serviced by 1st FSR's bakery now receive direct door to door delivery service.

Ammunition Company received and issued 26,711 S/T of Class V, a daily average of 864 S/T, an increase of 370% over April 1966.
