**NARRATIVE SUMMARY**

During the month of February 1971, Headquarters and Service Battalion provided administrative, motor transport, communications, and general support to Force Logistic Command and numerous other Marine and Allied Units. The Battalion Commander and his staff continued to function in a dual capacity as Camp Books Commander and staff and as such were responsible for the many common usage facilities and functions of Camp Books, i. e. sanitation, police, maintenance, fire protection and utilities. Elements of Truck Company and Support Company provided vehicular and material handling equipment to U. S. Army units in support of Operation Dewey Canyon II. A vigorous program to identify and prepare material excesses for retrograde was initiated. Depletions of stockpiled civic action commodities was effected in the course of completing outstanding civic action projects. Security requirements for Force Logistic Command were re-evaluated. The current force commitment remained static during the reporting period.

NARRATIVE SUMMARY

During the month of February 1971, Truck Company provided both administrative and tactical motor transport support to all elements of Force Logistic Command and specified III Marine Amphibious Force Units. The Motor Transport Coordination Center provided operational assistance to the 11th Motor Transport Battalion in support of 1st Marine Division Units.

Landing Zone Baldy, Fire Support Base Ross, and Hill 37 were supported daily with fuel and water. During the latter part of the month, Truck Company backloaded elements of the 5th Marine Regiment from Landing Zone Baldy to the 1st Marine Division area.

From 13 February 1971 to 25 February 1971, Truck Company supplied four fuel tankers and two Low-Boys in support of operation Dewey Canyon II.

Truck Company's Maintenance Platoon consisting of 1 Officer and 71 Enlisted, is responsible for the second echelon repair of 461 pieces of Motor Transport Equipment. During the month of February, Maintenance Platoon opened 277 second echelon TERO's and completed 261. 48 vehicles were sent to Motor Transport Maintenance, Maintenance Battalion for 3rd echelon repair; 38 were for repairs, 5 were for accident investigation LTI's 4 were for condition code LTI's, and 1 was for LTI for excess.

5. SPECIAL OPERATIONS. During the period 13 February 1971 to 25 February 1971 Truck Company supplied four fuel tankers, two low-boys and 12 personnel in support of Operation Dewey Canyon II. The four 5000 gallon fuel tankers operated between Fire Support Base Vandergrift, Khe San and Tam My driving approximately 3600 miles and transporting 240,000 gallons of fuel. The two low-boys transported two 6,000 pound fork-lifts which were used for loading and unloading supplies at Fire Support Base Vandergrift.

In addition, Truck Company ran a tactical convoy consisting of two Gun Trucks, one M543 wrecker, one M52 tractor and thirteen personnel. The convoy retrieved one M52 tractor and one M131 5000 gallon tanker which had been disabled at Tam My.



No. of Passengers X 1000 \*\*\*




Gal. X 1000 FUEL AND WATER \*\*\*

Total Fuel = 350,595








# TERO'S PROCESSED 277

NARRATIVE SUMMARY

During the reporting period, the Laundry Section, Service Platoon processed a total of 68,580 pounds of laundry for an average of 2,450 pounds per day. This is a decrease of 20,240 pounds from the month of January. Principal users are the 1st Marine Division, Force Logistic Command, 1st Medical Battalion, Children's Hospital and the Marine Transient Center. Field Service is also provided the 2nd Battalion, 1st Marines. The Material Handling Equipment Platoon has handled 53,132 tons of supplies as of 23Feb1971, an increase of 7,062 pounds over the previous month. The Communication Platoon processed a total of 19,055 messages during February, a decrease of 3,890 from the month of January. The Wire Section processed 645,429 calls through the Dial Central exchange and 32,065 were operator assisted. 35 telephone work orders were filled, 159 telephone troubles cleared and 6 new installations were completed.



1. This month there were 97 items scrounged (the majority of these items were assemblies/subassemblies) enabling this unit to keep the deadline rate to a minimum. 2. Sixty-two contact teams were dispatched utilizing a total of 997 man hours expended for the period 30 January 1971 to 26 February 1971. The utilization of these contact teams continued to keep the unnecessary equipment out of the shops.
3. During the month of February 1971, this unit transferred eight enlisted Marines, and joined seven enlisted Marines. Officers strength stayed the same.
4. Six ROK Marines were assigned to this company on the 24th of January 1971. They were working in the Generator shop receiving instructions and O.J.T. They rotated from this company three weeks after arrival.
5. During the periods 8 - 12 February 1971, this unit conducted a total of 30 training hours on 700 Series Generators for personnel representing all units in III MAF. A total of 43 Marines received instruction in the electrical/mechanical aspects of protective circuitry and generator trouble shooting and preventive maintenance of the 700 Series Generators. The results of this instruction are considered very satisfactory and it is believed that this training will prove beneficial to III MAF and the Marine Corps by enabling personnel to more accurately diagnose their generator malfunctions and correct a greater percentage of them at the using sites.





During the month of February, Bulk Fuel Platoon manned and operated seven (7) fuel sites (LZ Ross, LZ Baldy, Hoi An, Hill 37, Hill 34, 1st Motor and Camp Books) dispensing 131,257 gallons of Bulk motor gasoline and 171,567 gallons of Bulk Diesel Fuel to Marine, Army and ROK Forces. On 15 February, the operation of the fuel site at LZ Ross was discontinued and all equipment was brought back to Platoon Headquarters. Also during February 1971, 499 drums of fuel and 1208 gallons of assorted POL packaged products was issued.

During the month of February 1971 Ammunition Platoon handled 14,735 s/tons of Class V(W) ammunition and 4320 s/tons of Class V(A) ammunition. The daily average for receipts and issues was 467 s/tons.

Issues of "A" Rations during the month of February 1971 totaled 2,000,000 pounds of Meat, Fish, Butter and Produce. Issues of "B" Rations and MCI's during the month of February 1971 totaled 7,500,000 pounds of MCI's and canned goods.

LSU #3 is located at LZ Baldy. The LSU provided Class I, III and V supply support, 3rd echelon maintenance in Engineer, Motor Transport, Ordnance and Electronic commodity areas. Forklift, Laundry, RUC line and ice machine services are also provided the supported units.

LSU #5 is located at Hill 37. The LSU provides Class I, III and V supply support as well as forklift and laundry services to the 1st Marine Regiment.

During the month of February, 42 MedCaps were conducted. A total of 2059 patients were treated. Psyops leaflets were distributed at all MedCaps held by Supply Battalion. Approximately 2059 leaflets were distributed in this manner.

# Supply Bn Wins FLC's title of Best Mess for Jan

DA NANG — Supply Bn. has won FLC's best mess of the month competition for January.

BGen. James R. Jones, CG FLC, presented the four-foot high trophy to GySgt. Robert Aragon, Supply Bn. mess chief, at a ceremony recently in the battalion messhall. The trophy, a monthly rotating award, will be retained by the Supply Bn. messhall until it is won by another messhall in subsequent monthly competition.

Six enlisted messhalls within FLC compete for the trophy and are scored on such things as administration, food preparation and serving, appearance of personnel, dining area, mess deck beautification and appearance of the outside area.

Each messhall is inspected monthly by the FLC Food Service Officer, during a scheduled or unannounced visit. The three messhalls having the highest scores are then inspected by the Assistant Chief of Staff (G-4), FLC Medical Officer and Ser-

Major who drop by unannounced and grade the messhalls again to select the winner.

"I am very proud to have won the award," said GySgt. Aragon, "and so do all my men." Aragon has a messhall staff of 17 cooks and 20 messmen, all Marines, and 36 Vietnamese civilian workers.

Since the best mess competition was begun in December 1970, Aragon has taken the initiative to improve his messhall. "We are continuously painting both the inside and out," he said.

"We have also procured ashtrays for all the tables, placed flowers around the inside, installed recorded music and provided a service so the troops can leave their plates on the tables. Vietnamese workers pick them up," he said.

Supply Bn.'s messhall, which feeds about 700 men, is the second recipient of the best mess of the month trophy. The Transient Facility messhall won the award for December.

# FLC's Retrograde Facility Reclaims and Recirculates Excess Gear Back Home

DA NANG — FLC's retrograde facility is run by 50 Marines. They will probably be here after every other Marine unit has gone.

The facility has two primary functions.

"We are responsible for retrograding all gear of use to the Marine Corps back to the states or to other units in WestPac," said 1stLt. Thomas W. Foster.

Lt. Foster, officer in charge for four months, is now the Retrograde facility assistant under Maj. R. L. Fraser.

The second primary function of the facility, a part of Supply Co., Supply, is a salvage operation.

"We take gear of no further use to the Marine Corps and turn it over to the Army," said Lt. Foster. "The Army either gives it to other forces or sells it as scrap."

When gear is turned in, Marines at the retrograde facility, located near the FLC Camp Books supply complex eight miles northwest of here, make the final preparations for shipping.

"The unit turning in equipment is responsible for cleaning and repairing it within the unit's capabilities," Lt. Foster said.

At the retrograde facility, anything easily broken, such as windshields and headlights, is protected. The gear is labeled and any paperwork accompanying the gear is attached to it. Then, it is loaded onto a truck and taken to a deep water harbor in the Da Nang area to be put on a ship.

Gear is shipped either commercially or on a vessel of the Navy's Seventh Fleet, if there is space available, returning to the U.S.

The salvage operation is not as involved as the retrograding.

"If a unit comes in with a truckload of unusable gear we just give it a document and the unit takes the gear to the Army Property Disposal Office (APDO) at Marble Mountain," said Lt. Foster.

"If it is not a full truckload, we take it here and wait until we have a full load before taking it to the APDO," he said.

All types of Marine Corps gear are retrograded. Trucks, jeeps — any rolling stock, ordnance in-

cluding brass cannisters and ordnance pallets, and various communications items such as field radios and accessories are shipped out continually.

"We are averaging about 1000 ordnance, 500-800 communications and 400-500 rolling stock items per month," said Lt. Foster. The most difficult times come when a unit deactivates and large quantities of gear are turned in at one time to be retrograded," according to Lt. Foster.

The retrograde facility also has a jungle utility repair service and a body armor exchange program.

Units turn jungle utilities in to the facility. Those that are repairable are turned over to a Vietnamese company who contract to repair them. After they are repaired, the utilities are turned to the supply company to be reissued.

Under the body armor exchange program, units may bring in unusable body armor and exchange it on a one for one basis. The old armor is sent to Okinawa to be repaired, after which it is shipped back to retrograde.

"About 2000 pieces of jungle utilities and 1500 pieces of body armor per month are returned to stock in usable condition," said Lt. Foster.

The facility also acts as the collection agency for captured weapons and precious metals, such as are used in some types of batteries and film.

The metals are delivered to APDO which ships them back to the U.S.

"If a weapon has no intelligence value or the intelligence has been taken, the weapon is turned over to us and we turn it over to the Army," Lt. Foster explained.

In addition to the other services, retrograde also has a vehicle washing facility which may be used by units having a vehicle to turn in.

Retrograde is located about a mile northeast of Camp Books in a 500 by 800-foot compound enclosed by a high wall. Vehicles, bomb pallets, and cannisters stand in neat rows ready to be shipped out. As more Marine units leave Vietnam, the stocks will diminish in size until the last piece of usable gear is gone.

Then, retrograde can go.

# III MAF's Grocery Bill Runs \$2.2 million a mo.



**DA NANG** — In Vietnam, it's difficult to go to the corner supermarket for a head of lettuce and the family butcher is thousands of miles away. But the Marines still eat well.

FLC's Ration Pit., part of Support Co. Supply Bn. at Camp Jay K. Books, supplies over 100,000 pounds of fresh and frozen foods each day to units in Military Region 1, Vietnam's northernmost tactical zone.

The food comes from the Army Supply Depot Activity (ASDA), near Da Nang. The supplies are brought from ASDA to FLC by large refrigerated vans and stored in large refrigerators called "reefers".

Approximately 70 vans arrive at FLC each month. Some of them remain loaded and are simply hooked into the FLC

electrical system which provides power for the self-contained refrigeration units on the vans. The remaining 45 to 50 vans are unloaded into the reefers. Nearly one million pounds of meat and 800,000 pounds of produce are received, stored and shipped by Ration Pit. each month. The most often used meat pro-







## 'Chieu Hoi' Means Opportunity, to 130 Former VC Families

DA NANG — If one English word could describe what the Vietnamese words "chieu hoi" have meant to 130 former Viet Cong families near here, that word would have to be "opportunity" . . .

Literally, "chieu hoi" means "open arms", the policy extended by the South Vietnamese government to communist troops or sympathizers who wish to rally to the side of the South Vietnamese government.

Chieu Hoi-I hamlet, one of 11 in Hoa Khanh village, eight miles northwest of here, is significant in the Vietnamization process because it exemplifies what people can do once they are free to determine for themselves what their lives will mean.

The hamlet is comprised of 130 families, all formerly VC or communist sympathizers. "It's one of our best hamlets," said LCpl. Gary Johnson, a civic action Marine from the Civil Affairs section of FLC Supply Bn.

"The people are highly motivated," said LCpl. Johnson. "We've started them on a number of projects and they went ahead on their own until the project was completed."

Chieu Hoi-I was recognized as a hamlet in December 1967, when the area it occupies was inhabited by 100 families. The inhabitants had no sturdy homes, only makeshift shelters.

Now, each of the 130 families has a home built of various types of wood which will stand up under most Vietnam weather conditions.

Most of the building materials

have been supplied by Supply Bn. Civil Affairs, which is charged with Civic Action projects of Hoa Khanh village. "We've tried to show them the way so they can provide for themselves when we leave Vietnam," said Johnson.

In the center of the hamlet stands a bright yellow two-room elementary school made of concrete. Across from it is an old plywood building. Combined, the two structures accommodate 210 students and four teachers. The teachers are supplied by the South Vietnamese government.

Construction on the second room of the new school began in October 1970, and it was completed in late January 1971. Before the second room was added, many students had to attend school in other hamlets.

Plans for a third room have been submitted to Supply Bn. Civil Affairs by the hamlet chief. He has also submitted a request to the South Vietnamese government for another teacher.

Near the school is a Protestant church fashioned from large sheets of plywood. It, too,

was begun in October and completed in January. The preacher, converted to Protestantism by American missionaries, has a substantial following.

Ten new homes have recently been built and reparations completed for 50 others damaged by Typhoon Kate in October. Six additional wells have also been installed in locations easily accessible to inhabitants of the new homes.

Income is earned in various ways. A large percentage of the hamlet's people are employed by the American or South Vietnamese governments on a full or part-time basis.

Others grow enough vegetables to feed their families and to trade in the market places. A few own businesses — two carpentry shops and a barber shop — within the hamlet and employ relatives or close friends.

Measured against standards of more advanced cultures, the gains these people have made may seem small. But judged on the basis of continual progress, they have made significant inroads.
