A. Organization Data.

1. 3rd Dental Company, 3rd Marine Division (Rein), FMF, FPO
San Francisco 96602 - Danang, Republic of Vietnam
 - a. 3rd Dental Company Headquarters. The 3rd Dental Company CP is located in the 3rd Shore Party Battalion area. The Company CP occupies a tin-roofed hut. The Commanding Officer, Administrative Officer, Administrative Chief, Company Training Petty Officer, two office clerks and one driver staff the CP.
 - b. 3rd Shore Party Battalion site. The Clinic at 3rd Shore Party Battalion is located adjacent to the Company Office in one-third of a tin-roofed hut. It was established in early November. One dental officer and two dental technicians provide routine operative dentistry and preventive dentistry treatment. This Clinic is readily accessible for Marines being staged here prior to being sent to the field.
 - c. 1st Medical Battalion site. This Clinic occupies two tin-roofed huts and a preventive dentistry lean-to. Operative, prosthetic, endodontic, oral surgery, periodontic, and preventive dentistry services are provided at this Clinic. Dental Clinics in the Danang and Dong Ha areas refer patients here for specialized treatment. Eight dental officers and 16 dental technicians are assigned to this Clinic.
 - d. 7th Engineers site. This Clinic is in one-half of a tin-roofed hut. Two dental officers and two dental technicians are assigned to this Clinic.
 - e. Fleet Logistic Support Group site. This Clinic utilizes two quonset huts. One of the quonsets has two dental operating rooms and the Company Supply Section. The second quonset houses the Company Mount-Out Section and the Dental Repair Section. Both quonsets have concrete decks and the one with the clinical spaces and supply is air-conditioned. Two dental officers and eight dental technicians are assigned to this facility. The need for dental support will continue to exist here as long as FLC and FLSG are located at Red Beach. A Vietnamese Pediatric Hospital is in operation at FLSG. Through coordination with COL WEIERS and the FLSG Medical Officer, space has been allocated for a Dental Clinic to further our Civic Action Program.
 - f. An Hoa site. This clinic was disestablished on 14 Dec 1966. The 1st Dental Company has taken over this area of responsibility.

- g. Khe Sanh site. This Clinic is in the Special Forces Camp Dispensary. Present plans are to keep one dental technician assigned permanently and have a dental officer go into the area one week every month or oftener if necessary. The dental technician will provide emergency dental treatment, preventive dentistry and carry on with the people to people program. He will work closely with the Army Special Forces Aid Team and the BAS.
- h. Dong Ha site. This Clinic is located in an old French building. The interior remodeling was completed in December. The Dental Company had to furnish all of the materials and the CB's did the remodeling. Three dental officers and four dental technicians staff this Clinic.
- i. Camp Carroll site. A Dental/Surgical Van is in this area with one dental officer and one dental technician assigned.
- j. Phu Bai site. This Clinic utilizes a 16' X 48' tin-roofed hut in the "A" Medical Company area. Operative, prosthetic, and oral surgery services are provided by this Clinic. Five dental officers and seven dental technicians are assigned.
- k. 7th Motor Transport site. This Clinic is located in a tin-roofed hut and is staffed by one dental officer and one dental technician.
- l. Hill 55 site. This Clinic is located in a tin-roofed hut. One dental officer and one dental technician are assigned here.
- m. III MAF site. This is a new Clinic that was put into operation in December. It is located in the same building as the III MAF Force Dental Officer. One dental officer and two dental technicians are assigned to this Clinic.
- n. The Commanding General has approved a seven dental operating room air-conditioned clinic in the 3rd MARDIV CP area at Phu Bai. Completion is planned for early in CY 1967.

- 2. Administration. The Administrative Officer meets daily with the supervisory personnel to discuss problems and disseminate information.
- 3. Training. The weekly training program for enlisted personnel (E-3 through E-6) is comprised of a weekly study assignment of subjects in military and professional fields, followed by a test in each assignment. A one-hour weekly class in leadership is held for all personnel. Troop indoctrination is accomplished in compliance with Force Bulletin 1700 of September 1965.
- 4. Command and Control. The Commanding Officer maintains liaison with Clinic Directors by periodic visits and telephone calls. The Commanding Officer and the Administrative Officer confer daily concerning Company operations. The Commanding Officer confers frequently with his professional staff in regards to both military and professional subjects.
- 5. Dental Support. The 3rd Dental Company furnishes dental support to Marine Corps personnel in Danang, Hue Phu Bai, Dong Ha, and the Khe Sanh areas of RVN. There are eleven 3rd Dental Company Clinics. The 3rd Dental Company, particularly the two oral surgeons, assists in Mass Casualty Care when additional personnel are needed.
- 6. Civil Affairs/Military Government/Community Relations. The 3rd Dental Company's Dental Civil Affairs Program included the rendering of emergency dental treatment in the following villages in RVN:

1. General: The \$35,000.00 requested for Project 20, Operation and Maintenance, Navy (Medical Care), Fiscal Year 1967 is primarily based upon anticipated requirements for known commitments for budget fiscal year. Knowledge of known commitments is limited due to the combat deployment in the field. Very little usage rate information or usage rates is available for use in submission of this budget. This is due to deployment from "in garrison" operation to "field operations". It is, however, considered to be the minimum required to provide complete dental support for the Third Marine Division in the field and for reinforcing units attached. It does not include funds for operation of Dental Detachment, 3rd Dental Company, Sub Unit #2, Okinawa. This category includes Care of the Sick and Expeditionary Material (Initial and Maintenance).
