fires by arty and air were timely, accurate and significantly contributed to the success of this enemy defeat. They are to be highly complimented. Arty and air destroyed heavily fortified area in treeline along a stream bed. Co "A" found one bunker containing 35 82mm mortar rds, 4 RPG rds, and 100 lbs of rice. All were destroyed. Co "A" began to move into the area of Co "B's" contact of 22 May and recovered bodies of MIA's and Marines previously killed but not retrieved the night before. All missing equipment was found with the exception of one PRC-25. Resulting casualties of contact were: 5 USMC WIA (EVAC) and 142 NVA KIA (estimate); Co "A" had 32 NVA KIA; 40 NVA KIA by air; 50 NVA KIA killed by arty; 20 killed by tanks. Area could not be completely swept due to direction of contact and open area of the trace. 1/4 consolidated the area, evaced remaining dead and wounded and began to move southwest toward the night position (YD 143692). No further contact with the enemy was made during this action. The afternoon of 24 May Co "B" returned to Yankee Station and on 25 May, Co "A", "D" and the Battalion Command Group returned to A-4.

While the Battalion had its' companies in the field, "H" Co, 2nd Bn, 26th Marines was chopped to 1/4 to fill in the lines at A-4. Forty-two men from the Battalion rear at Dong Ha were dispatched to A-4 to further assist in its defense. "H" Co, 2/26 remained at A-4 while 1/4 began its move into the 4th Marines OA at Camp Carroll.

On 25 May, Co "B" chopped to 4th Marines and departed Yankee Station for Camp Carroll. On 26 May, Co's "D" and "A" (-) were transported to the "Rockpile" area. One platoon of Co "A" was chopped to Co "B", 1/4 at Camp Carroll. On 27 May the Battalion Command Group and Co "C" chopped to 4th Marines and assumed the defense of Camp Carroll while 2/26 assumed the defense of A-4. Until 30 May, the Battalion was deployed with Co "B" reinforced with one platoon from Co "A" and the Battalion Command Group at Camp Carroll. Co "C" occupied four positions along Rt # 9 within the OA. Co's "D" and "A" (-) were OPCON to 4th Marines at the Rockpile. The evening of 30 May the Battalion's "Bravo" Command Group chopped to 4th Marines and trucked to the Rockpile where it assumed OPCON of Co's "D" and "A" (-) and the responsibility for the defense to that portion of the 4th Marines OA.

- (e) Continually conduct preemptive/suppressive counter battery fires and air strikes against known and suspected enemy mortar/rocket/artillery positions and FO locations. These preemptive fires will be in addition to immediate counter battery fires conducted against active enemy gun and mortar positions and will include maximum use of organic weapons.

Operations

01 May At 0155H, OP#1 observed one secondary explosion during TOR at YD 090707.

At 0655H, Co "A" platoon patrol observed 4 NVA to their front at YD 118709. Patrol received s/w fire. Took NVA under fire with s/a, a/w and M-79. The patrol was reinforced with the rest of Co "A". Called 81mm and 4.2 mortar mission. AO on station called fixed wing on NVA along east-west road. Co "A" elements observed 25 NVA to the north approaching site of contact. Co "A" elements found tunnel and command detonated mines facing A-4 outer wire. Casualties were retrieved and Co "A" returned to perimeter. Artillery called on target. Action resulted in 4 friendly WIA (3 evac and 1 non evac) and 14 NVA KIA (5 by Co "A"; 5 by air and 4 by arty).

At 0830H, OP#1 received one sniper rd. from YD 101701. Observation of area revealed 3 NVA in treeline. NVA were wearing green utilities with cooly hats. The OP received 2 more sniper rds. Fired 2 .50 c spotter rds. Fired 106mm HEAT rd. Several observers witnessed rd impact directly on sniper. Fired 3 additional rds to either side of enemy position. Observers saw one NVA flee northwest. NVA did not have weapon and was wearing a USMC flak jacket, helmet, and gas mask worn on back of flak jacket. NVA disappeared in the thick brush. One NVA KIA (confirmed).

At 1020H, while firing an artillery mission in support of 1/4, 4/12 made a 200 mil deflection error. Three rds impacted in the perimeter. Called for immediate check fire. Two friendly KIA (EBC) and one WIA (NBC).

At 1020H, OP#1 observed 5 NVA in the open at YD 104742. NVA were wearing helmets and khaki uniforms. Fired 6 rds 106mm RR and 61 rds 81mm mortar. Observers saw one NVA blown in air. One NVA KIA (confirmed).

02 May At 0540H, A-4 received 14 rds estimated 82mm mortar between 0540H and 0620H. Fired 105mm arty mission, 81mm mortar and dusters on following coordinates, YD 133714, YD 124716, and YD 130727. Also fired counter mortar in Sector I. Two friendly WIA (emergency) and one routine, resulted from incoming. The emergency medevac later died of wounds.

At 0735H, Co "B" road sweep received s/a fire from approximately 4-5 NVA at YD 128675. Took NVA under fire with s/a and tanks. Reinforced road sweep with Co "C" platoon with Co Command Group and 3 additional tanks. Called 81mm mortar mission with good coverage. Units in contact swept area with negative findings. One USMC WIA (minor).

At 0835H, OP#1 observed 3-4 NVA at YD 096712 and YD 095710. Fired 81mm mortar mission and 4.2 mortar mission with good coverage.

At 1017H, A-4 received one round 82mm outside perimeter. Continued firing counter mortar mission.

At 1125H, A-4 received 3 rds. 82mm. Fired 4.2 mortar mission on YD 13297248 with excellent coverage.

At 1128H, A-4 received 1 round 82mm mortar. AO on station checked area with negative results. Fired counter mortar mission when AO was clear.

At 1130H, AO on station observed 2 NVA at YD 103705. AO observed freshly dug fighting holes in area. Fired 81mm mission with good target coverage.

At 1330H, snipers with Co "D" observed 3 NVA as the enemy moved when a WP round impacted near their position. NVA were wearing green utilities and 2 carried AK-47's. Snipers took NVA under fire, killing two. Other NVA fled. Two NVA KIA (confirmed).

At 1520H, A-4 received 10-12 rds of unknown cal. high velocity arty. Several of the incoming rds were VT air bursts. Fired arty mission on YD 164776.

At 2358H, perimeter and OP's observed 3 large explosions on outer wire. One to NE, one to North and one to NW. No enemy movement was observed. At 0015H, A-4 began to receive incoming estimated 82mm mortar and 85mm arty. From then until 0043H, 19 rds impacted in and around perimeter. Fired 4.2 counter mortar mission. Came to 100% alert.

03 May

At 0905H, OP#1 received 1 rd sniper fire. Rd hit upper bunker. Fired 60mm mortar mission on YD 106708. Excellent coverage of target, results unknown.

At 1011H, A-4 received six rds 60mm and 82mm mortar rds. Incoming was sporadic, spread over every 30 minutes or hour. Fired counter mortar fire on YD 133733 and YD 126722.

At 1245H, OP#2 received 2 60mm rds. Fired 81mm mortar mission and 106mm RR mission. Excellent coverage of target.

At 1500H, and until 1555H, A-4 received 4 rds 60mm, 7 rds 82mm and 5 rds of 122mm rockets. Fired arty mission on YD 050665 and YD 102723. Good target coverage, results unknown.

At 2145H, troops on Co "A" lines heard movement. Fired 81mm mortar mission on YD 120713. Observed secondary explosion.

04 May

At 0830H, A-4 received 2 82mm mortar rds in OP#2 area. Fired 4.2 mortar mission with unknown results.

At 1015H, while receiving 2-4 rds unknown type arty incoming, personnel at A-4 observed delta wing aircraft roll in from the north. Aircraft fired 2-6 rockets/missiles, one impacting near the CMR and later identified as a Shrike missile. Witnesses also reported hearing rapid firing from aircraft. Three other missiles impacted in minefield to the SW. Fired 4.2 mortar mission and arty missions on suspected emplacements of enemy arty at YD 087706 and YD 093642. One friendly KIA and 4 WIA resulted from missile.

At 1235H, A-4 received 6 unknown type rockets from a direction of 5600 mils. OP's observed flashes from YD 065663. Fired arty mission on suspected enemy position.

At 1340H, A-4 received one 82mm mortar rd in southern portion of perimeter. At approximately the same time, OP#3 received one sni rd. Fired 81mm mortar mission on suspected mortar position at YD 0998700.

At 1416H, A-4 received 2 rds 82mm mortar from unknown direction and range.

At 1610H, C-2 Bridge received one rd estimated 152mm arty from YD 064668. Rd impacted in southern portion of perimeter. Fired arty mission on enemy position.

At 1705H, A-4 received 6 82mm rds which impacted in the northern and center portions of the perimeter. Fired arty mission on enemy position at YD 083702.

05 May

At 0307H, Co "A" received 4 82mm mortar rds. Fired 81mm and 4.2 mortar mission with good target coverage. Results unknown.

At 0922H, A-4 received 4 rds 82mm mortar from YD 137728. Fired 4.2 mortar mission on enemy position.

At 1000H, A-4 received 1 82mm mortar rd. Fired counter mortar mission on YD 096703.

At 1210H, A-4 received 3 82mm mortar rds. Fired 81mm mortar mission on YD 116715.

At 1315H, A-4 received 3 rds 82mm mortar from YD 123716. Fired 4.2 and 81mm mortar missions on enemy positions. One friendly WIA(EVAC).

At 1400H, C-2 Bridge received 6 rds of estimated 122mm rockets. At about the same time, Yankee Station received 4 rds estimated 100mm arty or larger. Fired arty missions on enemy positions at YD 064742 and YD 093723. Friendly casualties sustained: 1 WIA(EVAC), 3 WIA(minor)

06 May

At 1215H, Co "D" OP/ambush observed 6 NVA at YD 106679. The NVA were moving towards A-4. Two NVA carried AK-47's and something attached to their waists. OP/ambush was unable to fire due to orientating, but reorientated themselves and took 3 NVA under fire. A quick check of area produced negative results. Ambush returned to perimeter.

At 0400H, personnel on Co "A" lines observed 2 explosions 150 meters outside of Co "A" CP. Checked area at first light with negative results.

At 0920H, A-4 received 2 82mm mortar rds. Co "A" observed 82mm being fired and movement in brush at YD 100703. Fired 81mm mortar mission on enemy position with good target coverage. Two USMC WIA (minor).

At 1130H, and occurring since 1000H, A-4 received 9 82mm mortar rds. Fired arty mission on YD 098701.

At 1115H, OP at C-2 Bridge observed flashes at YD 055655 at the same time C-2 was receiving incoming rockets. Fired arty mission on enemy position.

At 1145H, "A" Co OP observed recoilless rifle at YD 096707. Rifle was heavily camouflaged. Fired arty mission on enemy position.

At 1154H, A-4 received 2 82mm mortar rds. Continued counter mortar.

At 1230H, A-4 received 2 82mm mortar rds from unknown direction and range.

At 1405H, A-4 received 2 82mm mortar rds from YD 1028072090. Fired arty and 81mm mortar mission on enemy position.

At 1545H, A-4 received 8 rds estimated 130mm arty from YD 123780. Fired arty mission on enemy position. 1 USMC KIA and 1 USMC WIA (evac).

At 1640H, A-4 received 3 82mm mortar rds from YD 134717. Fired arty mission.

At 2245H, OP#1 observed 10-12 NVA moving from treeline toward outer defensive wire. NVA were moving by two's and three's. Fired 4.2 mortar mission of approximately 40 rds. Observed 2 NVA KIA, confirmed by Co "D" through NOD.

07 May

At 0800H, OP#2 spotted 7 NVA in the open at YD 165784. Fired arty mission on enemy position.

At 0801H, A-4 received 3 82mm mortar rds. Fired arty mission on YD 138719.

At 0927H, A-4 received 2 rds of VT outside perimeter. Apparent propaganda leaflets were dropped from the VT. Leaflets were too far out to pick up. OP#1 received 1 rd. sniper fire. A-4 also received 3 rds estimated 100mm to 120mm arty. Fired suppressive fires on YD 06067534, YD 12217834, and YD 11947963. 1 WIA (evac).

At 1013H, A-4 received 6 82mm mortar rds from YD 13887198. Fired arty missions on enemy positions.

At 1100H, A-4 received 2 82mm mortar rds. Fired 81mm mortar mission on YD 127728.

At 1605H, A-4 received 3 82mm mortar rds from YD 13887198. Fired arty mission on enemy position.

At 1800H, A-4 received 12 82mm mortar rds from YD 1248071885 and YD 1236071660. Fired arty and 81mm mortar mission. Excellent target coverage. OP#2 observed one secondary explosion. Two USMC WIA (evac) and 4 USMC WIA (non evac).

At 2035H, OP#1 spotted 5 NVA in the open at YD 102669. Fired 4.2 mortar mission with excellent target coverage.

At 2355H, OP#1 observed 5 NVA 100 meters outside wire to west. Fired M-79 with unknown results.

08 May

At 0445H, Co "A" OP/ambush, while moving into position at YD 121706, made contact with an estimated NVA squad. Returned fire with s/a and M-26 grenades. Broke contact and returned to perimeter. One USMC WIA (minor). Two NVA KIA (confirmed). Captured one AK-51.

At 0815H, A-4 received 2 rds of 82mm mortar from YD 102700. Fired 106's on enemy position.

At 1000H, A-4 received 1 82mm mortar and 17 light arty rds. Fired arty missions on YD 0808075920, YD 0828075590, YD 135795, YD 125755, YD 145085, and YD 148792.

At 1630H, A-4 received 1 82mm mortar rd. Fired 81mm mortar and arty missions.

09 May

At 0205H, OP#1 observed 4 NVA in the open at YD 10626869. Fired 4.2 mortar mission, excellent coverage of target. Estimated 2 NVA KIA, observed one NVA carried off, other was dragged off.

At 0831H, A-4 received two 60mm mortar rds from YD 095703. Fired 4.2 mortar mission on enemy position with good target coverage.

At 1115H, Co "A" OP observed 3 NVA at YD 122720. Snipers took NVA under fire, killing one. Called 60mm mission. OP returned to perimeter.

At 1135H, A-4 received 2 82mm mortar rds from YD 127713. Fired 81mm mortar mission on enemy position.

At 1350H, OI#3, while adjusting arty mission on suspected rocket position, reported two secondary explosions.

At 1345H, A-4 received 1 82mm mortar rd from unknown direction and range.

From 1750-1820H, A-4 received 2 rds of estimated rockets from YD 095616 and 065664 and 11 rds from estimated recoilless rifle at YD 100715. All rds were received during above time span. Fired counter arty mission on enemy positions with excellent target coverage.

At 1920H, fired 81mm mortar mission on suspected mortar position and observed secondary explosion at YD 118719.

10 May

At 0100H, personnel on Co "A" lines and OI's # 2 and 3 observed explosion along outer wire to the northeast. Utilized NOD's to check out area, negative results.

Between 0547H and 0645H, A-4 received 29 arty rds, two estimated rockets and two air bursts that appeared to drop leaflets that fell outside perimeter. Fired counter battery mission on YD 14498009, YD 12708083, and YD 131751. Three USMC WIA (minor).

At 0940H, OI#1 observed 2 NVA at YD 098707. Fired 4.2 mortar mission with good target coverage. Results unknown.

At 1640H, A-4 received 7 rds of estimated 82mm mortar. Fired 81mm mortar mission, 4.2 mortar mission and arty mission on enemy positions at YD 083704, YD 102703, and YD 099702.

At 2230H, OI#1 observed 1 NVA in the open with NOD. Sniper took NVA under fire with M-14 utilizing a starlight scope. Observers saw NVA knocked down by impact of bullet. Fired 4.2 mission on target at YD 105705. One NVA KIA (confirmed).

At 2245H, personnel on lines observed 4 NVA. Co "C" lines took NVA under fire with s/a. Movement ceased.

11 May

At 0005H, personnel observed 5 NVA with NOD at YD 105705. Sniper using M-14 with Starlight Scope, took NVA under fire. Observers saw two NVA fall and others apparently try to drag them away. Two NVA KIA (confirmed)

At 0740H, OI#1 took one rd of sniper fire from unknown direction and range. One USMC WIA (evac)

At 1150H, OI#1 received 2 rds of estimated 82mm mortar from YD 097705. Fired 81mm mortar mission on enemy position. Good target coverage.

At 1350H, MajGen Thompkins and MajGen Davis arrived at A-4 and departed approximately 40 minutes later.

At 1705H, A-4 received 2 rds 82mm mortar. Fired 81mm mortar mission on YD 100730, and YD 102692.

12 May

At 0720H, Co "D" found one dead NVA who appeared to have been killed by mortars or arty approximately 2 to 3 weeks ago. NVA was not wearing clothing. One NVA KIA (confirmed).

At 1040H, A-4 received 3 82mm mortar rds from direction of 5000 mils. Fired counter mortar mission.

At 1244H, Yankee Station received two estimated 100mm arty rds while A-4 received 4 rds of 82mm mortar. Fired 4.2 mortar mission on enemy position at YD 123717. Good target coverage.

At 1315H, OP#2, while firing 106's, 81mm mortar and tank mission on active enemy mortar position, reported one secondary explosion.

13 May

At 0842H, A-4 received 3 rds of 82mm mortar. Fired arty and 81mm mortar mission on enemy position at YD 124719 and YD 083704. Excellent coverage of target.

At 0950H, A-4 received 6 82mm mortar rds. Fired 81mm mortar and 4.2 mortar missions on enemy positions at YD 101712, YD 08327042 and YD 12417191.

At 1300H, Co "C" discovered bunker complex at YD 124662. Approximately 19 bunkers were found in the area. Destroyed bunkers.

At 1515H, A-4 received 1 82mm mortar rd from unknown direction and range.

14 May

6. New techniques employed.

a. Technique. Utilization of Night Observation Devices in the maneuver of ground troops at night.

b. Comment. In May, a platoon from Co "D" was on a night ambush patrol west of Con Thien. An OP at Con Thien, using a NOD, observed a group of NVA moving along between the outer perimeter wire and the ambush patrol. The patrol was alerted but due to the pitch darkness, the patrol was unable to observe any movement. The company commander went to the OP and by observing his patrol and the NVA through the NOD, was able to maneuver his troops into an advantageous position. Artillery illumination was called and the ambush sprung killing seven NVA.

8. Logistics.

a. Supply.

(1) Class I. The stockage objective remained at 15 days at A-4. On the average, only about 10 days were maintained during the period. One meal of "R" rations was served every other day at A-4 and Yankee Station, while two meals were served on a daily basis at C-2 Bridge, A-4 and Yankee Station. received supplemental rations including canned fruit, bread, assorted condiments, and milk. Within three days after moving to Camp Carroll, "R" rations were being served three times a day to one company (rein) and the Bn Command Group. One "R" ration was being served to one company on Route # 9 and two companies (-) were receiving "R" rations at the Rockpile.

(2) Class II. Battalion Supply remained at Dong Ha with FISC-B as the source of supply. Shortages in the following items were again experienced during this period:

b. Transportation.

(1) Organic. Only three M422A1 (Mighty Mites) were on hand during this period. These vehicles were utilized for administrative runs to Dong Ha, as well as local runs between A-4, Yankee Station and C-2 Bridge. The Battalion presently has three M-37 (PC) trucks operationally ready.

(2) Support.

(a) Vehicular. The 9th Motor Transport Battalion provided 2 trucks at times but due to other commitments this was not on a continuous basis. The amount of time the trucks were available did not always provide sufficient household runs. The available M50A1 water tanker (1000 gallon) was provided by FLSC-B and driven by an operator from 9th Motor Transport Battalion. Without the tanker there would have been a definite problem in resupplying water to A-4 and Yankee Station.

(b) Engineer Support. Engineer support teams provided the Battalion with demolitions capabilities. A TD-18 tractor was utilized extensively at the trash dump and for building storage areas. However, most of the time, the tractor was deadlined due to mechanical difficulties and a lack of spare parts.

9. Civil Affairs.

There were no Civil Affairs activities conducted during this reporting period. First Lieutenant James M. ALLEN, 096017, USMC, the Battalion Personnel Officer, was assigned the additional duties of the G-5 and he attended the one day Personal Response Course conducted by the 3d MarDiv at Quang Tri.

10. Psychological Warfare.

All psychological warfare operations were conducted by higher echelon.

11. Personnel and Administration.

a. General. During the reporting period, the Battalion's administration section was located at Dong Ha. At the close of the reporting period, each rifle company was averaging 34 men below manning level and 100 were in a non-effective status. This battalion is presently 11 officers below M/I in the 0302 MOS and still has a critical shortage of 0402.

12. Intelligence.a. Enemy.

(1) Enemy activity in the OA increased during May. Night time probes of the perimeter wire, daylight sightings, mortar harassing fire, sniper incidents and incoming rockets characterized the reporting period. Two significant contacts with the NVA were made. The first occurred east of A-4 with an estimated 50-60 NVA. The second occurred a few days later at about the same location with an estimated NVA Regiment. The NVA units encountered are thought to have recently infiltrated from the north due to the newness of their equipment, however, the poor state of care for this equipment indicates a lack of training and discipline. Aerial Observers have reported new fighting holes, bunker complexes and trail networks in the OA.

Excellent observation of the plains area farther north has contributed significantly to our ability to call observed fires on the enemy in the open.
