NARRATIVE SUMMARY

1. The Battalion's shortages are two 0302 Captains, six 0302 Lts, one 0202 Captain, one 0130 Lt, one 0402 Captain, one 2502 Captain. There is a need for one Sgt Maj, two 0369 GySgt, eight 0369 SSgt's and forty-one 03 Sgts. The major shortage exists in platoon leadership billets in the 03 field. This shortage is made more evident by the fact that the Battalion has only 69% of its M/L strength in Staff NCO's 0369, and only 43% of M/L strength in 03 Sgts.
2. Battalion Intelligence efforts during the first half of the month were primarily directed toward enemy activity in the Battalion's TACN in the vicinity of Hai Van Pass. The enemy kept up his harrasing activities concentrating on small group movements. During the last half of the month the Battalion operated in the Go Noi Island area South of Da Nang.
3. The Battalion was engaged in Phase II of Operation HOUSTON throughout the first half of the month. Intensive patrolling along Highway #1 continued along with bridge security. During the last half of the month the Battalion was on Operation ALLEN BROOK South of Da Nang.
4. The Battalion held no Indoctrination School of it's own. All new personnel attended a Regimental Indoctrination School. Special Schools were conducted by the Battalion during the first part of the month encompassing communications field expedients and instruction in the use of the An/PPS-6.

a. Personnel and Administration

(1) The Battalion began the month of May with an on board strength of 30 Marine Officers, 1065 Marine Enlisted, 2 Navy Officers, and 53 Navy Enlisted. The current on board strength is 31 Marine Officers, and 1039 Marine Enlisted, 4 Navy Officers, and 53 Navy Enlisted.

(2) The current effective strength of the Battalion is 24 Marine Officers, and 874 Marine Enlisted.

(3) Sixty-two Marine Enlisted plus 2 Marine Officers are scheduled for rotation during June 1968.

b. Intelligence(1) Personnel

(a) During the month of May 1968 the Battalion Intelligence Section lost one Draftsman, Cpl. 1441, and one Interrogator/Translator, Sgt. 0251.

(b) During the reporting period Scout Dog Teams were unavailable, however, Armed Propaganda Teams and Scout/Sniper Teams were effectively employed. The Battalion's current attachments include five Scout/Sniper Teams.

(2) Collection. The main collection efforts during Operation HOUSTON II, and Operation ALLEN BROCK have been as follows:

- (a) Map corrections
- (b) Trail and water point locations
- (c) Enemy order of battle
- (d) Enemy infrastructure

(3) Reporting. The Battalion S-2 Section has conducted daily Commander and Staff intelligence briefings during May 1968.

(4) Enemy Activity.

(a) Synopsis 1. Operation HOUSTON II. Enemy activity decreased during the reporting period. For the most part, enemy activity in the Battalion AO took the form of limited attacks by fire, harassment by fire, and mining incidents, spread widely throughout the AO. Enemy interdiction attempts continued along Highway #1, concentrated in the Hai Van/Phu Loc areas. The enemy's primary effort has been concerned with the collection of food stuffs. The enemy has been moving in small units and has been trying to avoid contact with the Allied Forces.

2. The enemy has been using command detonated mines and booby-trapped M/26 grenades extensively throughout the Hai Van Pass area.

3. The enemy is keeping his units as mobile as possible in order to evade Allied Forces operating in the area.

4. Operation ALLEN BROOK. The enemy unsuccessfully attempted to resist friendly incursion into his safehaven on Go Noi Island, and has been prevented from taking significant initiative against key Allied installations in the Da Nang area. Indications are that the enemy continues to attempt to hold the territory he occupies, while replenishing, recruiting and regrouping his forces.

5. Although agent reports and PW interrogations have contained indications of an enemy offensive, aimed at achieving a propaganda victory, victory for the peace talks, and to build morale, the disposition of enemy forces does not lend itself to the immediate accomplishment of widespread successes against major friendly positions.

(5) Vietnamese Attachments

(a) Interpreters. The Battalion continues to employ at least five ARVN interpreters. Efforts are continually being made to insure that the rifle companies and the S-5 have at least one qualified ARVN interpreter each.

(b) Kit Carson Scouts. The Battalion continues to await assignment of Kit Carson Scouts.

(1) During the month of May Battery F, 11th Marines, was in direct support of 3rd Battalion, 5th Marines. Batteries M, and Whiskey Battery were in general support. US Navy patrol boats gave off shore support during Operation HOUSTON II. Battery F, displaced to the Da Nang TAOR during the last half of May to support 3rd Battalion, 5th Marines on Operation ALLEN BROOK.

(2) Battery F FO's gave 23 hours of training in FO procedures to CAP 7 and CAP 9. About 15 hours of instruction concerning defensive fires was also given to these units. The FO's also gave 26 hours of instruction to infantry units.

(3) Battery F fired a total of 3808 rounds in support of 3rd Battalion, 5th Marines during May. Of these rounds 3384 were fired with HE fuze quick, 303 with fuze VT, 40 WP, 3 HC smoke, 50 fuze timed, 10 fuze delay and 18 Illumination. Battery M fired 863 rounds, and Whiskey Battery fired 639 rounds in support of 3rd Battalion, 5th Marines.

(4) Batteries F, M, and Whiskey fired a total of 4963 rounds during the month of May.

(5) Batteries F, M, and Whiskey fired a total of 1159 rounds in support of unobserved missions during the month.

(6) Batteries F, M, and Whiskey fired a total of 3575 rounds of H&I fires during the month. Navy patrol boats fired 33 rounds of 81mm mortar.

(7) Batteries F, M, and Whiskey fired 54 observed missions during the month. The Batteries fired 635 rounds in support of these missions.

f. Air Support. Air Support of the Battalion has been commensurate with Battalion needs.

(1) Tactical Fixed Wing Support: There were 46 fixed wing airstrikes during the month of May in support of Operation HOUSTON II and ALLEN BROOK.

(2) Helicopter Support

- (a) 8 Huey gunship strikes
- (b) 20 medevacs, including 6 Emergency medevacs.
- (c) 23 resupply missions to troops in the field.

(3) There are two ALO/FAC officer assigned to this Battalion. Sufficient trained personnel were available to provide radio teams at company and Battalion levels.

g. Communications

(1) The Battalion was supported primarily with F.M. communications during the month of May.

(2) A manual relay, followed by an automatic relay station was set up to maintain communications with Co. M during the period 10 May to 16 May.

(3) AN/PPS-6 school was held by the Comm Chief with personnel newly joined by the Battalion. The following observations were made.

a Set up in a pre-plotted with (FDC or FSCC) position or send in the location after setting up. Polar Plots may then be used by the supporting arms.

b Each operator must plot returns as they occur.

c When first assuming watch the operator must check out all plotted returns from the previous watch.

d The operator must operate the set, checking out all returns as to azimuth distance and direction of movement. Mere setting a range and sweeping; sitting down and waiting for something to happen is insufficient and most targets would not be detected due to disinterest.

(4) Teletype (covered) via Radio Relay (AN/MRC-62) was maintained with the Fifth Marine Regiment until 16 May 68. This was a semipermanent position and the previously reported bulkiness of the TT-4's, which this Battalion uses was more than offset by the dependability of their operation in this type location.

(5) The importance of Not med-ovaidg radios with wounded operators or placing them on resupply helicopters without an escort cannot be overemphaized. Since 18 May 68 this Battalion has had 4 radios lost to friendly troops after placed on helicopters for return to the L.S.A. They were not dropped off at the L.S.A. as Bn. personnel there did not receive them. An additional 6 radios were dropped at destinations other than those designated when placed aboard the helicopter.

(6) Support by and liasion with the communications platoon of the 27th Marine Regiment has been outstanding thus far during Operation ALLEN BROOK.

h. Logistics

(1) General. The overall logistical status of the battalion is satisfactory.

(2) Supply.

(a) During the first part of May, Battalion Supply prepared diligently for its inspection by the Material Management Team, scheduled for 22 May 1968. However, this was cancelled on 20 May to be rescheduled at a later date.

(b) Also, during the month they initiated action to effect the exchange of the chrome chambered M-16 rifles. To date, Battalion Supply has exchanged 802 rifles, with only stragglers remaining.

(c) On 15 May, the Supply Officer and Supply Chief attended the second Supply Officer/Chief conference in Da Nang.

(d) On 18 May, Battalion Supply sent an armorer and supply man to the field to work as ordinance and supply liaison during Operation ALLEN BROOK.

(e) On 22 May, Battalion Supply turned in 634 blankets and 307 field jackets to FLSC-A for further shipment to FLC in order to be cleaned.

(f) A vehicle is utilized daily for the purpose of picking up necessary classes of supply and ensuring that all RUC gear is removed from the Shipping and Receiving area at FLSC-A on a timely basis.

(3) Motor Transport.

(a) On 17 May Motor Transport received twenty new M-151 vehicles replacing the M-422A1's which are scheduled to be turned in on 1 June 1968.

(b) The problem of obtaining parts for the M-274A2 still exists, however it has been somewhat alleviated with the procurement of thirteen new starter assemblies, a carburator, and magneto repair kits. Three items for the M-274A2 are presently on order through the Red Ball System.

(c) The Motor Transport Chief will be leaving in July, and many of the key personnel in the section are leaving within the next sixty days.

i. Civic Action

(1) Medcaps. 1,063 people were treated in Medcaps that were held this month. Most of the Medcaps were held in the refugee camp at Phu Luong (862-158).

(2) PsyOps. 4,500 leaflets were distributed in our TAOR. A total of 14 leaflet drops were requested. Nine of these were in support of an operation by Company M. 400 Chieu Hoi balls and 1,060 Chieu Hoi Pens were also distributed.

(3) Civil Affairs Assistance: A number of bath tubs were made by the section and used in conjunction with the Medcaps. The people were taught how to bathe properly and they began to use the tubs after being given instructions. We have also made a couple of small hospital beds that will be used to provide more sanitary conditions for children. A few see-saws are also in the planning stage, and they will be given out to the refugee camp at Phu Luong (862-158).

(4) Problems: None

(5) Serious Incident Reports: There were no Serious Incidents the month of May.

a. The enemy forces anticipated on Operation HOUSTON II, were not expected to exceed two VCMF Battalions, seven NVA Battalions, one Regimental Headquarters, and several selected hamlet/village defense squads. This intelligence was passed to the Battalion Commander, staff and unit commanders in estimate, briefing, and overlay form.

b. The following enemy units were identified as being disposed in the area from Phu Bai south to Hai Van Pass.

c. Collection and dissemination

(1) During Operation HOUSTON II, the 3rd Battalion, 5th Marines ITT Team interrogated 20 Vietnamese nationals. These interrogations resulted in all being classified as innocent civilians and released.

(2) Captured documents include several personal letters, and one diary.

(3) Captured weapons include three B/40 rocket launchers, two flare pistols and two French sniper rifles.

(4) Other captured gear includes twenty Chi-Com grenades, 19 non-electrical blasting caps, four B/40 rocket rounds, six pounds of 782 gear.

(5) Total enemy losses were 22 KIA (confirmed).

9. Mission

During the conduct of Operation HOUSTON II, 3rd Battalion, 5th Marines was assigned the mission of keeping Highway #1 open through the Hai Van Pass Area. Intensive patrolling and bridge security were included in the mission.

10. Concept of Operations

At 010001H May 1968, Phase II of Operation HOUSTON commenced with the 3rd Battalion, 5th Marines continuing their mission of keeping Highway #1 open. Since the Battalion occupied the same position when Operation HOUSTON II commenced as it did when Operation HOUSTON I terminated, there was no significant change in the concept of operations.

11. Execution:a. 1 May 1968

(1) At 010825H 35th Eng. (USA) at coord. 809016 Road scrapper detonated pressure type mine with right rear wheel. Blew right rear tire with slight damage to wheel rim. Mine left 2' x 4' crater in the road. Road still passable.

(2) At 011100H Kilo Bridge Security At coord. 886954. Two farmers while tilling soil detonated a dud M-79 round. Both farmers were wounded. Corpman gave first aid and med-evac was called.

b. 2 May 1968

(1) At 021900H India Ft. ambush at coord. 202998. While patrol was moving to ambush site they made small arms contact with unknown number of VC. The enemy fired 40-50 rounds. Patrol returned 150 rounds 5.56. Enemy broke contact. 2 USMC WIA 1 emergency and 1 priority.

(2) At 022050H Kilo Ft. ambush at coord. 883955. Ambush heard loud movement to their front. Ambush called in artillery illum. and observed 4 enemy troops in light colored uniforms, with packs, helmets, and rifles. Patrol fired approx. 250 5.56 rounds, 25 7.62 rounds, and 8 M-79 rounds. Enemy returned 40-50 rounds, and tried to envelope the ambush. Patrol threw 8 M-33 grenades and movement ceased. Called artillery mission and searched area. Found 3 NVA KIA's.

c. 3 May 1968

(1) At 030700H Kilo at coord 882955 while searching area of contact as reported in spot rep. 022050. Found one NVA KIA and equipment. Also found blood trails in brush and paddie area. Found 1 AK-47 rifle with ammo and two chicom grenades, hammock, and extra uniform.

(2) 031100H Lima Co. at coord. 936917. Found one dead VC. body looks to be about a month old. Two chicom grenades were found by body.

(3) At 031600 3/5 CP at 936917. Army truck ran off road. Army officer requested 3/5 eng. to blow truck. Marines salvaged all usable gear and blew truck with 120 pounds of C-4.

(4) At 031700 H Lima Co. At coord. 937886. Army vehicle ran off road while heading South. Vehicle went about 30 meters off road, turned over on its top, and burst into flames. Exploding ordnance prevented quick extinguishment of the fire. Army personnel claimed bodies and uncharred equipment.

d. 4 May 1968

(1) At 041025H 35th Eng. (USA) 5 ton tractor-trailer detonated pressure type mine. Slight damage to low bed.

e. 5 May 1968

(1) At 052230H India Bridge Security received 6 HE mortar rounds of unknown size. Fired illum., but neg. counter battery fire.

(2) At 050100H 3/5 CP at Hai Van Pass heard small arms fire along road. Checked area and found crater in the road. Road still passable. Will check thoroughly at first light.

13. Administrative Mattersa. Resupply

(1) Almost all resupply during Phase II of Operation HOUSTON was accomplished by vehicle.

(2) There were 10 helicopter resupply mission during the operation.

b. Maintenance. Difficulty in getting parts for several of the vehicles effected some inconvenience.

c. Treatment of Casualties, Evacuation, and Hospitalization.

(1) Casualty treatment was handled very capably by the Battalion Surgeon and his corpsman in the field.

(2) Evacuation of casualties were effected with minimum loss of time.

d. Transportation. The unavailability of transportation from the Battalion rear at Phu Bai to Hai Van Pass was slowed down due to the unavailability of parts for some vehicles. The lack of parts did not cause any major problems for the Battalion rear or Battalion forward during Phase two of the operation.

e. Communications.

(1) Continued to support the battalion utilizing primarily F.M. communications. Covered TTY was also used secondarily between regiment and the Battalion.

(2) A manual relay followed by an automatic relay station set up by division, was required to effectively maintain communication with Mike Co. during the period 10 May to 16 May. This was caused by direct terrain masking of the line of communications to Mike Co.

(3) AN/PPS-6's were used to assist with the guarding of two bridges. It is important to sit in the

PPS-6 and plot the location with the supported units arty and mortar F.O's. This enables Polar Coordinates to be used in requesting supporting fires. Immediately upon setting in, approx. 10 to 15 minutes should be spent plotting returns as to distance and size from fixed target returns. This enables there operators to be briefed prior to assuming their respective watch. It must be emphasized that the man on watch must "operate the set. Checking all returns he detects. Mere sitting in setting range and searching is insufficient.

(4) The advantage of having enlisted FAC teams with each company was emphasized by contact action of Mike Co. . 10 to 16 May. Handling of med-evac in extremely difficult terrain and the running of air strikes in the same circumstances was enhanced by trained and experienced enlisted personnel assigned to the company on a permanent basis. Their continuing supervision of all communications in the company also assisted in leaving the commander free to concentrate on the tactical situation.

14. Special Equipment and Techniques. It was noted that the two gallon plastic water bottle fits securely inside the standard 20 pound demolitions bag. This protects the water bottle from puncture and provides an easy means of carrying the bottle slung over the shoulder.

15. Commander's Analysis.

(a) Phase 2 of operation Houston was no different from the final portion of phase 1 which was previously discussed. This search and clear operation was designed to keep highway one open between Danang and Phu Bai. Although several enemy mining incidents caused temporary halts in the flow of traffic there was no significant cessation during the period covered by the report. The operation was characterized by increased small unit contacts and incidents of mines and booby traps.

(b) Company Mike's combat patrol inadvertently happened upon an NVA base camp and was heavily engaged in extremely torturous terrain. This action eventually required an additional company and a command group from the 2nd Battalion, 5th Marines and was highly productive in the collection of information of intelligence value.
