NARRATIVE SUMMARY

Company "A" (Rein), 7th Engineer Battalion continued support of the III Marine Amphibious Force within the Danang area. The company continued maintenance responsibility of 32.2 miles of road. In addition, the company carried the minesweep responsibilities of 9.3 miles of road.

Company "A" (Rein), 7th Engineer Battalion, conducted the following daily minesweeps:

Route 545 from AT912787 to AT875829

Route 1 D & LTL-4 from AT965605 to AT992578

The two (2) water pumps operated by Company "A" produced 1,547,000 gallons of water.

## PART III

1. Sequential Listing of Significant Eventsa. Personnel and Administration: none

b. Enemy, Weather, and Terrain: The weather in the Danang area was cloudy and warm during the first part of the month, with intermittent seasonal rains. Sporadic rainfall interrupted several road jobs for a short time in the later days of the month.

c. Enemy Activities: See Tab B Enclosure (1)

d. Organization and Operations

(1) Officer Assignments - See Tab A Enclosure (1)

(2) Operations: 1 - 15 November 1970

(a) Horizontal Construction - During the first 15 days of November, the company hauled 2,698 cubic yards of earth products. MCB-3 received the following support; 1,624 cubic yards of CBR to QL 1 B to repair road shoulders. The company supported itself with the following: 161 cubic yards of CBR for emergency road repair, 868 cubic yards to QL 1 C, 280 cubic yards of CBR to HL 540, and 35 cubic yards of rock to HL 545. In addition, "A" Company hauled 5,000 gallons of oil, and 800 gallons of water in the upgrade of HL 545. HL 545 was upgraded and HL 540 was repaired as weather permitted.

(b) Vertical Construction - Emergency repairs began on the ammo bunkers and generator shack at ASP-2. The company also constructed two (2) 400 man bleachers and a (12' x 36') stage with backdrop for the Marine Corps Birthday Ball. "A" Company personnel built one (1) (75' x 75') helo-pad, and two (2) (50' x 50') helo-pads at Camp Haskins. The company prefabricated six (6) SEA-huts for MASS-3 and 2nd CAG, and worked on repairs of the III MAF SNCO club. The company also assisted 94th Artillery in the disassembly and assembly of SEA-huts. "A" Company personnel began construction of an electronic maintenance building (38' x 50') on Hill 327 for MASS-3. Electrical projects are underway in the following locations: 2nd CAG at Hoi An and 2nd ROK Marine Brigade, as well as at FSB Ross, and FLC Retrograde.

## (c) Engineer Comments

(1) 3 November 1970 - "A" Company provided equipment to remove debris from Cobb Bridge.

(2) 4 November 1970 - The electrical upgrade of FSB Ross is completed.

(3) 4 November 1970 - The upgrade of the drainage system at FIC Retrograde is completed.

(4) 4 November 1970 - Construction of a fuel berm for Bulk Fuel Platoon, FIC is completed.

(5) 5 November 1970 - The upgrade of HL 545 is completed.

(6) 5 November 1970 - The construction of three (3) helo-pads at Camp Haskins is completed.

(7) 5 November 1970 - The upgrade of the Camp Haskins water system is completed.

(8) 6 November 1970 - The electrical upgrade at 2nd CAG was completed.

(9) 8 November 1970 - The company completed work on the 800 man bleachers, spotlight platform, stage, and backdrop for the Marine Corps Birthday Ball.

(10) 15 November 1970 - The company issued materials for watch tower repair for 2nd ROK Marine Brigade.

(11) 22 November 1970 - The construction of four (4) SEA-huts and one (1) 38' x 50' building for MASS-3.

(3) Operations : 16 - 30 November 1970

(a) Horizontal Construction - The company hauled a total of 2,632 cubic yards of earth products during the last half of November. MCB - 3 was supported with 1,372 cubic yards of CBR to QL-1 B. The company supported itself with 1,085 cubic yards of CBR to QL-1 C and 175 cubic yards of CBR to LTL-4 E. In addition, "A" Company graded roads in the 1st Marine Division CP area, and oiled the roads with 5000 gallons of oil. Mine craters and ruts along LTL-4E were filled, graded, and oiled. The upgrade of QL-1 C and HL 540 continues.

(b) Vertical Construction - The company provided personnel to repair typhoon damages to ASP-1. Two watch towers were repaired at 2nd CAG and repairs got underway at the FIC Bakery, the PP&P building at FIC, and the III MAF Officer's Club. A 96' x 16' building at 1st Military Police Battalion was erected and work began on the redecking of the Eiffel Bridge at Dai Loc. Three (3) SEA-huts were constructed at 2nd CAG Headquarters. One (1) 24' x 16' SEA-huts was constructed for the 51st ARVN Regiment, and a generator shed for Maintenance Battalion was completed.

(5) 19 November 1970 - The watch tower repair for 2nd Combined Action Group is completed.

(6) 22 November 1970 - The repairs of typhoon damages at ASP-1 are completed.

(7) 22 November 1970 - The electrical upgrade of the Division ridgeline (Sectors C & D) is completed.

(8) 24 November 1970 - The repairs of mine craters and ruts, and potholes on LTL-4 east have been completed.

(9) 25 November 1970 - Repairs to Staff Non Commissioned Officer building are completed.

(10) 26 November 1970 - The repairs to the Force Logistics Command Bakery roof is completed.

(11) 26 November 1970 - The repairs to the Force Logistics Command PP&P roof is completed.

(12) 26 November 1970 - The construction of a generator shed at Maintenance Battalion is completed.

(13) 27 November 1970 - Company "A" graded and oiled two (2) roads in the Division CP.

(14) 29 November 1970 - The construction of the 96' x 16' building at 1st Military Police Battalion is completed.

(2) Company Supply processed 283 documents of which 77 were completed. 57 items were turned into direct exchange with 42 items being received. There were 63 back order documents completed and 5 back order direct exchange items completed.

(2) Motor Transport: A total of 67,000 miles were logged in by the company motor transport vehicles. There were 8,256.1 tons of earth products, 21,610 tons of equipment and general cargo, and 2,350 passengers transported during the month of November.

(3) Maintenance The company maintenance platoon received 107 work orders, of which 42 were completed. Of the 65 pending work orders 42 are waiting parts of which 6 are combat deadlined for these parts. 11 work orders have been passed to higher echelon and 38 are awaiting parts which do not deadline the vehicles.
