1 March

At 011635H Mortar Battery was detached from Task Force Delta upon completion of Operation DOUBLE EABLE. At 011800H Mortar Battery returned to their primary position. From 011455H to 011600H Battery "A", 11th Marines fired 4 observed missions in support of 12th Marines FO School. At 011810H Battery "A", 11th Marines fired an illumination mission at (AT 965802). At 012100H Battery "A", 11th Marines fired an illumination mission at (AT 95588095). The battalion fired 203 harassing and interdiction missions.

2 March

From 021400H to 021554H Battery "A", 11th Marines fired 8 observed missions in support of the 12th Marines FO School. The battalion fired 172 harassing and interdiction missions.

3 March

At 031430H Battery "C" staged their howitzers at Marine Air Freight for air movement to Phu Bai. At 031605 Battery "K" displaced 2x155 (Towed) (K Xray) to Le My to support Company "A" 3rd Recon Battalion. The battalion fired 198 harassing and interdiction missions.

4 March

At 040435H Battery "C" began a motor march with Operation ROUGH RIDER to Phu Bai. At 041315H Battery "B" displaced 1 howitzer to Battery "C" position at (AT 92237374). At 081632H Battery "B" fired in a defensive concentration at (AT 872070). At 081706H Battery "B" fired in a defensive concentration at (AT 86797349). From 270950H to 271035H Battery "K" conducted 2 registrations at (AT 859860) and at (AT 839860). From 271134H to 271249H Battery "A", 12th Marines fired 3 observed missions on suspected VC at (AT 86226653), (AT 87446611) and (AT 87396453) in support of 3rd Recon Battalion; observed mission on suspected VC at (AT 93296429; no VC sighted. At 271225H Battery "A", 11th Marines fired 9 observed practice missions in grid squares 9884, 8883, 8884, 8885, 8985 in support of 12th Marines FO School. At 271855H Battery "B" fired an observed mission on a suspected VC mortar position at (AT 868687), no VC sighted. The battalion fired 94 harassing and interdiction missions.
