NARRATIVE SUMMARY

During the month of December the Battalion remained in General Support of the 1st Marine Division. The Battalion supported no named operations during the month.

The Battalion retained operational and administrative control of Battery K, 4th Battalion, 13th Marines throughout the month. Battery K's mission remained Reinforcing, 3rd Battalion, 11th Marines. On 9 December Battery K's Fire Direction Center commenced producing technical firing data for a platoon of 105mm howitzers of Battery G, 3rd Battalion, 11th Marines. This Platoon remained in position, collocated with Battery K, when their parent unit displaced 2 platoons and their Fire Direction Center to a forward fire support base.

Battery M continued its mission of General Support, Reinforcing 2nd Battalion, 11th Marines. The Battery continued to answer calls for fire directly from reconnaissance units operating in the southern portion of the Division TAOR.

Batteries K and L continued their mission of General Support. Due to the relatively low level of enemy activity, the majority of their firing during the month was directed towards intelligence and pre-emptive targets located in the northern and center portions of the Division TAOR.

On 18 December Battery K's mission was changed from General Support to General Support, Reinforcing 1st Battalion, 13th Marines in order to support an operation conducted by the 26th Marines. On 25 December Battery K reverted to General Support. During this reinforcing period, Battery K fired 6 missions, expending 116 rounds in a reinforcing role.

During the month of December, units of the Battalion fired a total of 2127 missions, expending 21,626 rounds in support of the following units:

SECRETg. Intelligence.

(1) During the month of December 1969, the S-2 made six liaison trips to Regimental S-2 and two liaison trips to Division G-2. Numerous trips were made to counter rocket observation posts Hawk, Tiger, Laugh, Lou, Bravo Tower and Crowsnest for the purpose of inspection and training.

(2) During December a new system of patrolling was incorporated into the defense of Hill 34. Headquarters Battery, 4th Battalion (Rein), 11th Marines; 1st Force Recon Co; B Company, 7th Engineers; 1st 175mm Gun Battery and 3rd 8" Howitzer Battery participated in squad size patrols conducted in 4th Battalion (Rein), 11th Marines TAOR of the Southern Sector Defense Command. The patrols were scheduled and briefed by S-2, 4th Battalion (Rein), 11th Marines and coordinated with 1st Tank Battalion.

(3) A night observation device was obtained from Ground Surveillance Department, G-2, and will shortly be installed in Counter Rocket Observation Post Tiger.

(4) Eight M-79 rounds, one 60mm mortar round, and one 105mm artillery round were turned in through the Volunteer Informant Program. A total of 2300 \$VN was expended for the purchase of these rounds.

h. Organization and Operations

(1) The Battalion remained in General Support of the 1st Marine Division, delivering supporting fires throughout the TAOR.

(2) Organization for Combat at the end of the reporting period.

(3) Throughout the month, continued improvements were made on the defensive positions around the Battalion CP in anticipation of enemy activities during the TET holidays.

(4) On 17 and 18 December a Staff Assistance/Operations Inspection of the Battalion Fire Direction Center was conducted by personnel of the 11th Marine Regiment. After observing the functioning of the Fire Direction Center during the two day period, the Inspectors judged overall operations as Noteworthy.

(5) During the month of December, the Operations Section prepared a new Fire Support Plan for the defense of the Southern Sector Defense Command. The new fire support plan provides for more flexible and timely artillery fire support in the event of enemy activity within the Southern Sector Defense Command.

i. Training.

(1) Normal GMS and MOS training was conducted as operational commitments allowed.

(2) On 26 December an 81mm Mortar FIREX was conducted on the HOA CAM range facilities. Both mortar crew and forward observer training was accomplished in order to improve the defensive posture of the Battalion CP.

(3) Familiarization firing was conducted on 21 and 28 December for all members of Headquarters Battery. Both crew-served and individual weapons were fired.

j. Logistics, Equipment and Supply.

(1) During this period the deadline for M109 Howitzers remained at a low level due to the outstanding performance of maintenance crews. At the end of the month 1 M109 Howitzer was deadlined.

(2) Fifteen motor transport vehicles are presently deadlined for a rate of 12%. Of these fifteen, three are deadlined at 3rd echelon facilities.

(3) Requisitions submitted since this Battalion has been in the Republic of Vietnam total 47,476. Of this number 30,640 have been filled.
