

**SECRET**PART IINARRATIVE SUMMARY1. INTRODUCTION.

a. GENERAL. During October 1968, III Marine Amphibious Force Headquarters was located in East Danang, Republic of Vietnam. The average personnel strength was 137,380 a decrease of 17,350 under the previous month.

b. ACTIVITIES. III MAF continues to be guided by COMUSMACV letter of instruction (LOI 3-66) dated 30 March 1966 in pursuit of its objectives for October 1968.

2. OVERALL EVALUATION. Throughout most of I Corps during October hostilities remained at a low level in contrast to the other intense activity of the previous month. Except in Quang Nam Province, small units contacts were infrequent. III MAF units continued to discover large amounts of enemy weapons, food, and medical supplies.

In Quang Nam Province a major enemy effort to capture the Thuong Duc District Headquarters and Special Forces Camp early in the month was disrupted by elements of the 1st Marine Division and the 51st ARVN Regiment. Heavy casualties were inflicted upon the enemy and they were forced to withdraw from the area.

Elsewhere in the Province, other 1st Marine Division on Operations Mameluke Thrust and Henderson Hill, accounted for over 500 enemy KIA, with only light losses to friendly forces.

During the month of October III MAF units initiated a total eight new major unit operations. In all III MAF units conducted a total of 20 major unit operations in the I Corps Tactical Zone.

PART III (S)SEQUENTIAL LISTINGS OF SIGNIFICANT EVENTS, OCTOBER 1968

1. SUMMARY OF OPERATIONS. (The following five operations had moderate to significant contact).

a. Operation KENTUCKY. The 3rd Marine Division (1st Bde, 5th Inf Div) continued clear and search operations in Quang Tri Province with moderate contact for the period 1-31 October 1968. At 110913H B/1/77 ARM engaged an estimated enemy platoon. B/1/77 returned fire with all organic weapons. Results of the contact were 3 USA KIA, 7 USA WIA, 20 NVA KIA. At 241500H B/1/61 found 2,000 lbs of rice, 25 rds of 60 mm mortar, 680 rds of SA ammo, and documents. From 241500H to 241830H 1/61 called air strikes and artillery on several groups of enemy, accounting for 58 NVA KIA. At 250700H 1/61 discovered a bunker complex and immediately began receiving heavy mortar and SA fire, 1/61 returned fire with all organic weapons and called artillery and air strikes. Moving to link up with 1/61, B/1/77 had 2 tanks disabled by mines. A third tank struck a mine and was totally destroyed. At 251830H B/1/77 completed its link up with 1/61 as the enemy broke contact. Results of the contact were: 7 USA KIA, 24 USA WIA, 232 NVA KIA.

b. Operation MAMELUKE THRUST. The 1st Marine Division continued clear and search operations in Quang Nam Province with significant contact for the period 1-31 October 1968. At 071430H a recon team observed 75 NVA in the open. Artillery was directed upon the enemy accounting for 46 NVA KIA. At 090630H B/1/5 received small arms and automatic weapons fire from an unknown number of enemy. B/1/5 returned fire supported by tanks and artillery. Results of contact were 4 USMC WIA, 23 VC KIA. At 221400H a recon team observed thirty-two NVA. Air strikes were directed upon the enemy, with results of 32 NVA KIA. At 221800H a second recon team observed approximately 80 NVA and engaged them with artillery, accounting for 22 NVA KIA. At 0720H the following morning the team observed 200 enemy with packs and weapons, carrying rockets and other materials in carts. Between 230725H and 231050H, artillery called by the team accounted for a further 68 enemy KIA in scattered contacts.

c. COMMANCHE FALLS. The 1st Cavalry Division (Airmobile) continued clear and search operations in Quang Tri and Thua Thien Province with moderate contact for the period 1-31 October 1968.

At 071110H B/2/12 Cavalry found 9 huts and bunkers containing a code book, three radios and a generator. At the same time, D/1/9 Cavalry found a hospital complex with 50 crates of medicine. At 091222H B/2/12 found a second cache of medical supplies which included 30 vials of novacaine, 32 vials morphine, 41 atrophine syrettes, 13 quarts of plasma and miscellaneous other equipment and supplies. At 181005H C/2/8 CAV found 5400 lbs of rice buried in the ground. The rice was evacuated to Trieu Phoung.

d. HENDERSON HILL. At 231201H October 1968 the 1st Marine Division commenced clear and search operations in Quang Nam Province with moderate contact for the period 23-31 October 1968. At 231530H a recon team observer 15 NVA with weapons. The team called artillery, with results 7 NVA KIA. At 271030H CP/1/5 observed an unknown number of enemy. 1/5 engaged the enemy and called artillery and air support. Results of contact were 14 VC KIA. There were no friendly casualties. At 280510H D/1/5 received small arms fire and grenade from an estimated ten enemy. D/1/5 returned fire and called artillery and spooky. Results of contact were 4 USMC WIA, 8 VC KIA. Contacts with small groups of NVA/VC were frequent throughout the first week of the operation, the bulk of enemy casualties being sustained in these actions.

e. MAUI PEAK. At 060601H October 1968 the 1st Marine Division commenced clear and search operations in Quang Nam Province to relieve and reinforce the Thuon Duc Special Forces Camp. Contact was moderate for the period 6 - 19 October 1968. At 071550H an aerial observer in support of 2/5 observed 27 NVA. Air strikes were directed upon the enemy resulting in 27 NVA KIA. At 081655H E/2/5 on a Company sweep received small arms and mortar fire from an unknown number of enemy. E/2/5 returned fire supported by tanks and artillery. Results of contact were: 1 USMC KIA, 9 USMC WIA, 37 NVA KIA. At 091330H H&S/2/5 observed 30 NVA, and engaged them with artillery accounting for 10 NVA KIA. At 092030H H/2/5 received 80 rounds of mixed 60 and 80mm mortar fire followed by a ground attack. H/2/5 repelled the attack supported by air strikes and spooky. Casualties were 9 USMC WIA, 16 NVA KIA. At 120400H 2/5 while occupying a battalion defensive position received small arms and mortar fire from an unknown number of enemy. 2/5 returned fire supported by artillery. Contact continued until 0820H with results 8 USMC KIA, 20 USMC WIA, 61 NVA KIA.

## a. Special Services.

(b) Theater. The Theater was operational 30 days in October. Total attendance was 37,520.

(c) Gymnasium. The Gymnasium was operational 31 days in October.

(d) Outdoor Facilities. No change from last report.

(e) Bowling Center. The Bowling Center was operational 26 days in October. Total attendance was approximately 2500. New hours are 0900 - 1700 vice 1000 - 1700.

(f) Construction Completed. Gates were completed for both entrance and exit roads.

(g) Major Construction Pending. No change from last report.

(2) R&R Activities

(a) of 7039 seats allocated to III MAF, 6,324 were filled for 89.8 percent utilization. Of 8,703 seats allocated to III MAF (Including Naval Forces in I Corps), 7,687 were filled for 88.4 percent utilization. Total allocations for Danang R&R Center consisted of 14,027 seats of which 12,521 were filled for a utilization percentage of 89.3.

18 October. Discussed with the Reverend Gordon Smith of United World Mission the Major General Bruno A. Hochmuth Building to be constructed at the China Beach Orphanage.

22 October. Entertained His Excellency, Peter Chi, the Bishop of Danang. Force Chaplain took Chaplain Richardson on a familiarization visit to 1st Marine Division, the site of the Hoa Khanh Technical School and the ARVN Ranger Camp. Force Chaplain commenced teaching, in a two evening a week adult education program at the Danang High School, a course in advanced English.

23 October. Force Chaplain took Chaplain Richardson on a familiarization trip to Hoi An during which visits were made to the Hoi An Catholic Orphanage, the Dieu Nhan Buddhist Day School/Orphanage and MIL-PHAP (Military Provincial Hospital Assistance Program).

25 October. Force Chaplain welcomed Mr. Do Van Ly (former Ambassador to U. S. and Cao Dai leader) on his visit to III MAF. Attended and spoke at CAG Officer's Conference.

27 October. Force Chaplain attended III MAF Protestant Rally at 1st Marine Air Wing.

29 October. Force Chaplain attended ceremony at China Beach Orphanage at which Lieutenant General Lewis WALT, USMC, presented an organ and other gifts to the orphanage.

30 October. I Corps Supervisory Chaplain's Conference was conducted in the Commanding General's Briefing Room. Sixteen Supervisory Chaplains were in attendance.

31 October. Force Chaplain briefed Lieutenant General Lewis WALT, USMC, on projects supported by the III MAF Chaplain's Civic Action Fund.

5. Intelligence

a. General Enemy Situation. During the month of October, enemy initiated activity remained at relatively low levels in all five provinces of the I Corps Tactical Zone, with the exception of QUANG NAM (P), where enemy forces subordinate to Front 4 continued to be active in the eastern portion of the province.

In northern I Corps enemy forces normally positioned along the DMZ remained generally withdrawn north of the BEN HAI River while the majority of major enemy tactical units in THUA THIEN Province remained withdrawn into the western mountainous regions and/or eastern LAOS. In QUANG TIN and QUANG NGAI Provinces, the enemy apparently withdrew the majority of his NVA/NF units into the piedmont and highland areas in an effort to avoid large-scale ground engagements with friendly forces. On the other hand, local force and guerrilla units remaining in the lowland areas maintained some degree of initiative by continuing efforts at unconventional and psychological warfare.

The first two weeks of the month saw the majority of enemy initiated activity in the I Corps Tactical Zone concentrated in east central QUANG NAM (P) where enemy forces exerted strong pressure against the THUONG DUC area. The enemy's efforts to overrun the THUONG DUC Special Forces/CIDG Camp and District Headquarters were disrupted, however, and the enemy units involved were subsequently forced to withdraw from the area. Enemy initiated incidents dropped significantly during the middle of the month as heavy rains caused by the transition from the southwest to the northeast monsoon curtailed enemy combat operations. Northeastern QUANG TRI Province produced the most significant ground engagements as friendly forces inflicted heavy casualties on enemy tactical units near the BEN HAI River in the eastern DMZ during the latter part of the month.

In QUANG TRI Province, the tempo of enemy activity remained generally at a reduced level during October, with attacks by fire and attempts at interdiction of friendly lines of communication principally characterizing the extent of the enemy's efforts. Allied installations and friendly tactical units in the northern portion of the province were harassed throughout the month by sporadic mortar, artillery and rocket attacks. The heaviest attack occurred during the early part of the month when elements of the 2nd ARVN Regiment received 170 rounds of 105mm artillery fire on 3 October while engaged in an operation northeast of GIO LINH. A marked increase was noted in indirect, long-range artillery fire from north of the BEN HAI River during the latter part of the month. The DONG HA Combat Base, including the village of DONG HA, sustained the heaviest loss as a total of 70 rounds of 130mm artillery fire on 22 and 30 October resulted in moderate friendly casualties and substantial material damage.

US naval vessels including the battleship USS NEW JERSEY also received light artillery attacks during the latter part of the month while operating east and northeast of the mouth of the BEN HAI River in the Gulf of TONKIN. These attacks by fire emanated from enemy firing positions on TIGER Island and in the vicinity of CAP MUI LAY, North Vietnam, but did not result in any friendly casualties or damages to the ships that were fired upon. Enemy sappers persisted in their attempts to deny friendly forces the use of the vital CUA VIENT River. There were several instances of naval patrol craft receiving RPG, small arms and automatic weapons fire from the banks of the river, and a series of mining incidents were preempted by mine sweep operations and the throwing of concussion grenades at various objects floating in the river which produced large secondary explosions. Friendly tactical operations dominated ground combat action on the QUANG TRI battlefield during the month of October. Extensive sweep operations throughout the SCOTLAND and LANCASTER areas in the northwestern portion of the province by elements of the 3rd Marine Division met with only minimal enemy resistance but continued to uncover large enemy munitions, ordnance and supply caches as well as additional bunker complexes and defensive positions. Evidence of the enemy's probable employment of heavy artillery pieces in the central DMZ area was revealed on 4 October when elements of the 2nd Battalion, 26th Marines discovered an unoccupied 152mm gun position 13 kilometers north of the ROCKPILE containing over 200 rounds of 152mm ammunition, and by the subsequent discovery on 18 October of two caches containing 333 rounds of 152mm ammunition in the same general area by elements of the 1st Battalion, 3rd Marines. The most significant discovery however, occurred on 7 October when elements of the 2nd Battalion, 26th Marines discovered a Soviet-made, diesel, tracked vehicle 12 kilometers north of the ROCKPILE which had been partially destroyed by air strikes. The discovery of this vehicle, along with subsequent discoveries of a vehicle park containing drums of diesel fuel, two underwater bridges in the vicinity of the BEN HAI River and reports by Marine tactical units of vehicle noises in the area provided strong evidence of the enemy's probable use of vehicles to move artillery pieces and resupply troop units within the central DMZ area. The SCOTLAND area provided significant enemy intelligence on 28 October when elements of the 3rd Battalion, 3rd Marines captured a PW 19 kilometers north northwest of KHE SANH who identified his unit as an element of the 246th Regiment, 338th Division. The capture of this PW marked the first contact with this regiment since the latter part of June when the unit was located in the KHE SANH area. However, due to the lack of recent contact with enemy forces in the area where the PW was captured, it is believed that the 246th Regiment has departed the area for either Laos or North Vietnam. The northeastern portion of QUANG TRI Province produced the most significant ground engagements in the I Corps Tactical Zone during October as well as producing significant enemy order

of battle intelligence. On 14 and 15 October, elements of the 2nd ARVN Regiment, supported by ARVN Armored Cavalry Assault Troops, inflicted 105 casualties on probable elements of the 138th NVA Regiment while participating in Operation LAM SON 271 east northeast of GIO LINH. A week later, again in Operation LAM SON 271, elements of the 2nd ARVN Regiment and ARVN Armored Cavalry Assault Troops, supported by U. S. Forces, accounted for 112 enemy KIA (17 by previous B-52 strikes) in a contact with a reinforced enemy company believed to have been elements of the 138th Regiment, northeast of GIO LINH near the BEN HAI River on 23 October. On 24 and 25 October, elements of the 1st Brigade, 5th Mechanized Division, supported by artillery, tactical air strikes and naval gunfire, accounted for 302 enemy KIA in heavy fighting during a two-day sweep operation north of CON THIEN near the BEN HAI River. A PW subsequently identified the enemy unit in contact as the 2nd Battalion, 138th NVA Regiment. The rapid reappearances of this major enemy tactical unit in northeastern QUANG TRI (?) after suffering heavy casualties in numerous engagements with friendly forces in the past three months confirms its capability to rapidly recoup its losses and assimilate replacements, and its flexibility and maneuverability in moving frequently back and forth across the BEN HAI River.

The enemy situation in THUA THIEN Province remained generally unaltered during the month of October as major enemy forces avoided large-scale ground engagements with friendly tactical units by remaining withdrawn from the battlefield. The enemy continued to be kept off balance by aggressive sweep, cordon and reconnaissance-in-force operations by US and ARVN Forces throughout the province during the month. Evidence of the success of these operations in eastern THUA THIEN was revealed on 16 October by a captured document taken from the body of a known member of a Military Proselyting Unit who was killed in an ambush in QUANG DIEN District by elements of the 101st Airborne Division (AM). The author indicated that recent operations had resulted in the loss of the VC infrastructure within the district, and had resulted in a distrust of the revolution and loss of confidence in the cadre. He further indicated that military proselyting activities had come to a standstill as a result of these operations, that great numbers of guerrilla and local force members had been killed causing chaos among the people. He concluded by saying "it is the darkest moment for QUANG DIEN District, one which did not exist before." The enemy suffered continuing losses of food, weapons, ammunition, supplies and equipment caches and base camps as a result of friendly operations. The extent of the enemy's efforts was again characterized by local harassment, most of which took the form of scattered harassing attacks by fire, with the majority of these attacks being concentrated in the southeastern portion of the province. Friendly installations and tactical units in the PHU LOC area received several light to moderate mortar attacks, and HUE City, PHU BAI and Camp EAGLE all received small amounts of incoming mortars and/or rockets.

With respect to QUANG NAM Province, the THUONG DUC area was the focal point of the majority of enemy initiated activity in the I Corps Tactical Zone during the early part of October. Enemy forces, identified by PW's as elements of the 141st NVA Regiment, in conjunction with possible elements of the 21st and 31st NVA Regiments and the 368B Rocket Regiment, exerted strong pressure against the THUONG DUC Special Forces/CIDG Camp, including THUONG DUC District Headquarters, in an effort to overrun and seize this key installation. As the situation became more critical toward the end of the first week of October, elements of the 1st Marine Division, in conjunction with elements of the 51st ARVN Regiment, commenced a multi-battalion operation, MAUI PEAK, in the THUONG DUC area on 6 October with the mission of destroying enemy forces threatening the Special Force/CIDG Camp and the District Headquarters. These friendly forces continued to meet with moderate to heavy enemy resistance in the area throughout the week of 6 through 12 October. The early part of the following week however, enemy activity subsided considerably in the THUONG DUC area, and it appeared that the majority of enemy forces threatening the THUONG DUC Special Forces/CIDG Camp and District Headquarters had withdrawn from the area, thus substantially reducing the threat of overrunning and seizing the camp. On 17 October, Operation HUNG QUANG 1-74, the 51st ARVN Regiment's portion of the THUONG DUC operation terminated, followed two days later by the termination of Operation MAUI PEAK. Combined cumulative enemy losses for these two operations were 354 KIA, 42 individual and five crew-served weapons captured as well as two PW's. The DANANG TAOR produced the most consistent activity in QUANG NAM (P) during the course of the month as those enemy forces remaining in the eastern portion of the province, particularly local force and guerrilla units, continued their efforts to conduct unconventional and psychological warfare. Scattered harassing attacks by fire, the use of mines and booby traps, and attempts at interdiction of friendly lines of communication primarily characterized the tempo of this activity. The enemy relied heavily on the use of mines and booby traps to harass friendly forces, inflict casualties, and keep friendly tactical units off balance. There were a few small ground attacks during the latter part of the month, most of which were targeted against CAP Units and RF/PF Forces and were minor in nature. One exception however, was an attack on 22 October by an estimated 100-man VC force against a company of the 2nd ROK Marine Brigade in night defensive positions ten kilometers southwest of HOI AN City which resulted in 19 VC KIA. There were several light contacts in the DANANG TAOR during October and numerous instances of enemy assaults by fire on friendly tactical units, particularly during the latter two weeks. However, none of these encounters developed into any real significant engagements. Significant enemy activity developed in the southwestern DANANG TAOR during latter part of the month as large sightings of enemy troop movements were made in the AN HOA Basin.

During a 48-hour period between 22 and 24 October, reconnaissance sighting of nearly 600 enemy troops, mainly NVA regular forces, were made in an area six to seven kilometers northwest of AN HOA. These forces, believed to have been elements of the 21st NVA Regiment were moving generally in a south-westerly direction with all of their arms and equipment including 60mm and 82mm mortars and 122mm rockets. Artillery and tactical air strikes called in on the majority of these sightings during this 48-hour period resulted in approximately 200 enemy KIA. Thirty-eight kilometers west southwest of DANANG on 23 October, Operation MANELUKE THRUST terminated. Total cumulative enemy losses for this five month operation which commenced on 18 May were 2730 KIA, 47 PW's, eight returnees, 337 individual and 125 crew-served weapons captured.

Enemy initiated activity in the southern two provinces of QUANG TIN and QUANG NGAI was generally very light throughout the month of October as major enemy tactical units, primarily elements of the 2nd and 3rd NVA Divisions, remained withdrawn into the piedmont and highland areas in the western portions of these two respective provinces. One significant engagement took place in the TIEN PHUOC-HAU DUC area of QUANG TIN Province during the early part of the month. Elements of the AMERICAL Division suffered moderate casualties in a contact with an unknown size enemy force in a bunker and trenchline complex five kilometers south of TIEN PHUOC on 1 October in which two helicopters were shot down by enemy ground fire. Local force and guerrilla units continued to be active in the eastern lowland areas where the majority of activity was concentrated. This activity was characterized by scattered harassing attacks by fire and continued attempts at interdiction of friendly lines of communication as well as a few small ground attacks and ambushes. The enemy also continued his campaign of terrorism and harassment of hamlets and refugee camps in an effort to demonstrate an inability on the part of the GVN and Allied Forces to defend the people. Several civilians were kidnapped and/or murdered, and there were also several bombing incidents, particularly in major populated areas. A noticeable increase in local harassing tactics occurred in the eastern coastal lowland areas of QUANG NGAI Province during the week of 13-19 October as enemy combat operations in the remaining four provinces of I Corps were curtailed by inclement weather. QUANG NGAI City received several light mortar attacks and one light rocket attack during this period. A Buddhist temple was 100% destroyed and a Catholic church sustained 50% damage in a VC sapper attack in BINH SON City on 14 October, while the DUC PHO City market place was the target of a sapper attack by an unknown number of enemy employing satchel charges, B-40 rockets and small arms fire on 16 October. The enemy demonstrated his willingness to exercise his chemical capability in I Corps Tactical Zone on 1 October when CS gas was employed during a small mortar attack against a Provincial Reconnaissance Unit at TAN KY City. Friendly operations dominated activity on the QUANG

TRU and QUANG NGAI battlefields during the month of October but met with minimal enemy resistance.

c. Enemy Order of Battle (Confirmed). Enemy forces operating in ICTZ on 31 October 1968.

(1) QUANG TRI. Confirmed units in QUANG TRI include only those considered to be operating south of the DMZ. Major units are: The 48th, 52nd and 64th Regiments of the 320th Division; the 138th Independent Regiment; four separate battalions and the 812th NVA Regiment of the probable NVA 7th Front; the 2nd and 3rd Battalions of the 27th Independent NVA Regiment; and the 4th and 6th Battalions of the probable 270th NVA Regiment. Additionally, four independent companies are located within the province. The total confirmed strength in QUANG TRI is 9,790.

(2) THUA THIEN. The TRI-THIEN-HUE Military Region Headquarters; 6th, 9th, 803rd, 90th, and 29th NVA Regiments; the K4B and K4C Battalions of the 4th NVA Regiment; the K4, K10, and Chi Thua 1 Sapper Battalion of the 5th NVA Regiment; and six independent companies are located within the province. The total confirmed strength for THUA THIEN is 9,885.

(3) QUANG NAM. The 21st Regiment, 2nd NVA Division; the 102nd and 103rd Battalions, 31st NVA Regiment; the 36th NVA Regiment; the 141st NVA Regiment; the 368B Artillery Regiment; the R-20, V-25 and D-7 Infantry, and the T89 and 3rd Sapper Battalions of the 38th Regiment; the 1st Battalion, 68B NVA Artillery Regiment; and six independent companies are located in QUANG NAM Province. The total confirmed strength in QUANG NAM is 8,080.

(4) QUANG TIN. The 1st VC, and 31st NVA Regiments; 2nd NVA Division Headquarters and support units; three independent battalions and six independent companies are located in the province. The total confirmed strength in QUANG TIN is 3,835.

(5) QUANG NGAI. Military Region 5 Headquarters; the 120th VC, 406th Sapper, and the 107th Artillery Battalions of the 401st NVA Sapper Regiment; the 2nd MF Regiment; the 22nd NVA Regiment; the 3rd NVA Division Headquarters and support units; three independent battalions and ten independent companies are located in the province. The total confirmed strength in QUANG NGAI is 8,200.

d. Counterintelligence.

(1) Counterintelligence Monthly Overview. The reorientation of Viet Cong efforts toward political, vice military, objectives became increasingly apparent during October. This trend, which had become obvious after the brief flurry of VC/NVA offensive actions on 22-23 August 1968, took on added significance with an awareness of the intense effort the VC and Hanoi government were placing on the newly formed Liberation Committees and People's Revolutionary Councils. Counterintelligence-related activity was directed towards increasing the prestige, influence, and legitimacy of these VC organizations and towards supporting VC/NVA tactical operations through sabotage, mining, and low-level espionage.

(2) Propaganda and Subversion. Propaganda activities, while remaining at a normal level, were primarily in support of the Viet Cong political program with a decreased effort towards boosting the morale of VC cadre and soldiers. Prevalent themes were directed towards soliciting popular support for the VC cause, increasing the prestige of Liberation Committees, and generally preparing for a future negotiated settlement in South Vietnam. It was significant that captured documents, dated 28 October 1968, reflected the imminency of a bombing halt and provided guidance for propaganda exploitation of this U. S. action. Other propaganda themes continued efforts to subvert GVN programs by requesting the populace to oppose U. S. actions and petitioning ARVN soldiers and GVN officials to defect to the VC cause.

(3) Political Activity. VC political activity intensified and expanded as the month progressed. Political activities were concentrated on the establishment and strengthening of Liberation Committees and People's Revolutionary Councils, particularly in providing these organizations with

a semblance of legitimacy and popular support that would serve to challenge the GVN authority in these areas. This organizational activity was heaviest in QUANG NAM and QUANG NGAI Provinces. Also of note were increased efforts toward organizing protest demonstrations against U. S. and GVN policies.

(4) Terrorism. Terrorism dropped slightly during October from the level of the previous month with the majority of activity consisting of attacks by fire and mining of civilian vehicles. Terrorist activities against refugee and resettlement camps decreased noticeably. Decreased terrorist activity towards the end of the reporting period appears consistent with the VC political program by reflecting a reliance on propaganda and persuasion vice terrorism and coercion.

(5) Sabotage. Sabotage activity remained at a normal and fairly constant level during October with the primary effort devoted to interdiction of friendly LOCs, particularly the destruction of key bridges and the disruption of shipping on the CUA VIET River.

(6) Espionage. Reported espionage activity was noticeably lower during October than during the previous month. Women, children, and agents infiltrating the cities as refugees continue to be the primary collectors of low-level intelligence. Of particular significance were reports in late October that the VC were compiling detailed dossiers on personnel working on various GVN programs or employed at U.S./GVN military installations. While the ultimate purpose of this activity is unknown, it contains the potential for long-term intelligence exploitation.

(1) The logistical posture in ICTZ remained satisfactory during the month of October. Monsoon rains and the shipping requirements of operation LIBERTY CANYON curtailed cargo resupply for short periods during October but had no significant effect on supply levels.

b. Dental.

(1) Periodic visits to III MAF dental facilities, NSA Hospital, USS Sanctuary, Camp Tien Sha, 95th Evacuation Hospital, Camp Faulkner, Camp Adinir, Danang Air Base and 1st Logistic Command were made by Force Dental Officer throughout the month of October.

(2) Dental Civic Action (DENTCAP) was conducted by III MAF Dental Companies during October, but statistics have not been received from such units to date and will be included in the November Command Chronology.

c. Embarkation.

(1) Air LOC. Air movement of cargo during October was dominated by large unit moves (GOLDEN SWORD AND LIBERTY CANYON). Four airfields were opened for C-7A and C-123 aircraft (Quang Ngai, Duc Pho, Ca Lo Re Island and Mai Loc). Marine KC-130's were required for resupply of JP-4 and ammunition to An Hoa throughout the month.

(2) Sea LOC. Surface movement was completely halted during the period 14-16 October as a result of the first seasonal monsoon rains. Operation LIBERTY CANYON commenced on 28 October. Cargo resupply was curtailed, due to the shipping requirements for this move, but all classes of supplies in the northern ICTZ remained at satisfactory levels. Enemy action had no adverse effects on surface shipment during the month.

(3) Road LOC. Highway operations during October included 37 resupply missions, 37 retrograde missions and 6 unit moves.

Dredge DAVIDSON opened channel lane 120 feet wide and 15 feet deep. All ports fully operational. Ca Lo Re Island and Duc Pho opened to C-7A and C-123 aircraft.

- 27Oct - Operation LIBERTY CANYON commenced for air movements.
- 28Oct - Operation LIBERTY CANYON commenced for surface movements. Due to this operation, surface resupply was curtailed in Northern ICTZ. LST's 649 and 287 departed for Saigon in conjunction with this operation. MAYO LYKES departed for CONUS with 181 S/T retrograde cargo. Quang Ngai opened to C-7A and C-123 aircraft.
- 29Oct - Port facilities at Hue/Tan My received 7 rounds of 60mm mortars. No damage or casualties. LST-551 and POINT DEFIANCE departed for Saigon in conjunction with Operation LIBERTY CANYON.

d. Engineer.

(1) Road and Bridge Resume. Damage to LOC structures by enemy interdiction was exceptionally light throughout the ICTZ, with only two bridges and six culverts being damaged or destroyed. Extensive flooding, resulting from tropical storm rains early in the month, caused significant damage to 18 bridges and many culverts. Relatively fair weather subsequent to the storm permitted rapid recovery operations which effected the repair of 13 of the bridges and most of the culverts. During this period 486 feet of new bridging was constructed and 1334 feet of tactical bridging was installed. The upgrading, repair and maintenance of all LOC's in the ICTZ has continued.

(2) Vietamese National Railroad. Restoration of the Danang-Hue segment of the VNRS progressed steadily, with the southern work crew completing repairs through the Hai Van Pass to Lang Co Station, and the northern work crew from Hue completing repairs southward to the Truoi River Bridge. Seabee

construction of three bridges just north of Lang Co Station has commenced, with one bridge being about 80% complete and construction of the second just underway.

e. Food Services.

(1) On 1 Oct the General Support Group, US Army, assumed Class I supply support for the Phu Bai area from FLSG-A.

(2) Force Food Service Officer made orientation visits to all major commands and all Class I supply points supporting III MAF during the period 7-11 October.

(3) The III MAF Subsistence Operational Analysis Report for September was submitted to HQMC on 18 Oct 68. Data highlights are as follows:

(3) III MAF Motor Transport Technical Assistance Team aided 2d Combined Action Group, 1st Combined Action Group and units of the 3d Marine Division.

(4) LtCol F. J. BAKER, Head, Motor Transport Branch, G-4, HQMC (AO4H) visited III MAF units from 26 October to 31 October.

g. Ordnance

(1) Five of the six M109 Howitzers that were on loan from the Army to provide a float capability during the installation of SEA Product Improvement Kits on Marine Corps M109 Howitzers, have been returned. The vehicles were shipped on 8 October aboard LST-822 to the U.S. Army Depot, Saigon. The remaining vehicles was offered for shipment to Saigon by FLC on 30 October 1968.

(2) The direct exchange of chrome chambered rifles to III MAF units, and initial issue of the weapon to the 1stMAW, continues. In addition, the direct exchange of rifles with the Second Brigade, ROKMC has been initiated. The status of the program is as follows:

(a) Maneuver Units. 100% equipped with chrome chambered rifles. Rifles on hand total approximately 28,782.

(b) Combat Support and Combat Service Support Units. 90% equipped with chrome chambered rifles. Chrome chambered and standard chambered rifles on hand total approximately 24,202 and 2,744 respectively. Another 1,623 weapons are in the process of being exchanged. Upon completion of issue of these weapons, these units will be 96% complete with 25,325 chrome chambered and 1,121 standard chambered weapons. The 1,121 weapons remaining to be exchanged are in FLSC ALPHA.

(c) Initial Issue. An additional 4,500 new rifles with equipment are in the process of being issued to the 1st MAW. This quantity, combined with the 3,747 previously issued, will bring the 1st MAW to approximately 67% of its initial issue. The quantity of M14 rifles still requiring replacement in the 1st MAW is approximately 4,064. Total remaining initial issue requirements for III MAF are as follows:

(d) Second Brigade, ROKMC. 3,500 chrome chambered weapons have been allocated and positioned for exchange within the Second Brigade, ROKMC. Upon the completion of this exchange, the maneuver units of the ROKMC will be 100% equipped with chrome chambered weapons.

(e) Divisional Units. All Divisional Units have been reported as 100% equipped with chrome chambered rifles. As such, a 100% inspection of M16A1 Rifles in the First and Third Marine Divisions is in the process of being conducted. This inspection will determine whether or not any personnel in the divisions were overlooked during the rifle exchange program.

(3) As of 30 September 1968, 8,342.5 short tons of suspended/unserviceable ammunition was on hand in the ASP's. During the period 1-31 October 1968, disposition instructions for 6,412 short tons of this ammunition were provided by HQMC. The HQMC action has reduced the forementioned level of 8,342.5 short tons to 2,240.5 short tons.

(4) On 22 October 1968, a barge containing ammunition capsized and sank in Danang Harbor and 422 short tons of ammunition was lost. Included in the 422 short tons were 12,146 rounds of 105mm HE ammunition. The barge was refloated with a minimal quantity of ammunition still on board. As of this date, the ammunition has not been located. Salvage operations are continuing in attempts to pinpoint the ammunition in order that recovery operations can commence.

#### h. Supply.

(1) Although funding restrictions caused a delay in the initial procurement of lightweight rainsuits and slippage in production resulted in additional delays, approximately 28 per cent of the total requirement has been received. It is expected that total requirements will be filled by 15Nov68. Approximately 35,000 rainsuits will be diverted to Third Force Service Regiment by 15Dec68, where they will be held for future requirements.

(2) Assets of concertina wire and tape have improved to such a degree during October that this item is no longer in short supply.

(3) A total of 85 Chain Saws have been procured by Headquarters Marine Corps and are to be air shipped to the Force Logistic Command. This quantity will fill all T/E

deficiencies for this critically short item. The Force Logistic Command maintenance float and stock requirements will be satisfied by an additional procurement.

i. Medical

(1) The total average patient load for the two Medical Battalions was 256, with a total of 1624 admitted and 273 patients evacuated out of country. 572 pints whole blood were expended to use.

a. Objectives. The basic objectives of the III Marine Amphibious Force Civil Affairs program remains the same.

b. Civic Action.

(1) During the month of October the Civic Action Program provided continuous support in supplying commodities, educational efforts, medical treatments, and construction projects. MEDCAP treatments increased by 122,168 for a total of 319,412 treatments for the year and 878 person were treated for a total of 11,528 DENTCAPS. October shows a tremendous increase in MEDCAPS due to mass inoculation for cholera administered to general populace. Educational efforts continued to show significant progress with 1057 English classes held and 17,864 persons in attendance. Construction projects increased by 20% for a total of 61 for the month. The populace showed an increase in village, hamlet and territorial security for the month in furtherance of GVN's objectives. US/FWMAF units participated in the Vietnamese Mid-Autumn Festival, 5-6 October and contributed toys and candies.

**SECRET**g. Narrative Summary.(1) General.

(a) The monthly PSYOP Conference was conducted on 18 October at III MAF Headquarters, with representatives of I Corps POLWAR, III MAF PSYOP, CORDS/PSYOP, VIS, major US military commands, ICTZ, ARVN First and Second Divisions, APA Quang Tri and Quang Ngai in attendance. Agenda items included Nguyen Trai Campaign, Credibility of ICTZ Chieu Hoi Program, employment of Safe Conduct Passes and Rally/Surrender procedures, Rev Dev team employment, Refugee resettlement and PSYOP role of national police.

(b) On 21 October, the Commanding Generals of I Corps and III MAF made personal and direct appeal to NVA and VC soldiers to lay down their arms. The Generals' signed message was delivered to enemy troops in leaflet form, by airdrop. Leaflet stressed enemy casualties -- particularly during unsuccessful Khe Sanh siege -- and advised enemy soldiers that they are being sacrificed in battles enemy leaders must know are hopeless. Commanding Generals of I Corps and III MAF joint surrender appeal received considerable coverage, indigenous media, including TV, radio and newspaper. Extensive publicity intended to insure public awareness of the extent of enemy battle losses and magnitude of defeats.

(2) Chieu Hoi Campaign. The III MAF/I Corps 1968 Chieu Hoi Campaign continues to exceed 1967's record, with a total of 347 ralliers received during October 1968, as compared to 164 received in October 1967. The total for the period January through October 1968, was 2,583 compared to the total of 1,962 ralliers for the same period in 1967. The 1967 total was 2,539 ralliers.

(3) Anti NVA Campaign.

(a) Reports from several sources including prisoner/rallier interrogations continue to stress hardships experienced by NVA units. Reports cite inadequate medical supplies, constant movement as result of allied tactical pressures, as contributing to poor morale. (Vulnerabilities disclosed by these reports are constantly being exploited by tactical units).

(b) First Marine Division reported Anti-NVA Campaign concentrated on enemy base camps located in mountainous areas, with employment of leaflet drops and helo-borne loudspeaker broadcasts to induce NVA to surrender/rally. PSYOP messages exploit known NVA vulnerabilities; to include: food shortages, lack of medical treatment, and aggravation of poor living conditions due to monsoon rains.

(a) 1st Marine Division. Sixteen (16) potential Scouts under went training at KCS Training Center, six (6) of whom were recruited by 1st CAG.

(b) 3rd Marine Division. The 8th KCS school commenced on 22 October 1968, with fifteen (15) recruits. The course was scheduled for completion on 20 November 1968.

(c) 1st Air Calvary Division. One KCS was released for excessive AWOL. The KCS program continues to be noted as "successful" by the 1st Air Calvary.

(d) 101st Air Calvary Division. The KCS program has been well received and considered to be a proven valuable asset. The KCS are intergrated into maneuver elements at platoon level.

(e) Americal Division. One (1) KCS was reported AWOL. As Americal Division gains experience in handling and using KCS, requesty for additional KCS continues to increase.

(f) 1st CAG. Received total of seven (7) new graduates of 1st Marine Division KCS School. Overall effectiveness of KCS is rated as outstanding.

(1) Lessons Learned. Indications are that patrols accompanied by KCS suffer less casualties.

(2) Problems Encountered.

(a) Units employing KCS at lower levels such as platoon level have encountered difficulties in obtaining data concerning KCS accomplishments as KCS activities are meshed with platoon accomplishments.

(b) Under MACV directive 525-6, dated 23 September 1968, US Army Divisions currently reporting to III MAF have been relieved of this report requirement, and will submit their report directly to Hq USARV. Consequently, future reports will reflect KCS Data for 1st Marine Division, 3rd Marine Division and 1st CAG only.

(c) Difficulty in obtaining draft deferments for KCS is being encountered.

(d) KCS are still experiencing harassment from ARVN military police.

**SECRET**(4) Anti VC Campaign.

(a) A First Marine Division prisoner interrogation report concerning statements made by a messenger of LOC SON (V) unit number 69 and who was captured on 25 September by L/3/5, that GVN/FWMAF leaflets was most influential PSYOP medium with aerial loudspeaker broadcasts being second. Prisoner added that most effective deterrent to rallying is VC propaganda countermeasure stating that GVN/FWMAF executed ralliers. Additionally, the potential rallier fears that GVN/FWMAF will shoot before rallier's intentions are clearly evident.

(5) Support GVN Campaign.

(a) NAG (FCZA) reported continuation of VNN/USN PSYOP program targeting fishermen and coastal residents. Program primarily employs personal "face to face" communications supplemented by loudspeaker broadcasts and specially-tailored leaflets emphasizing Pro-GVN themes.

(b) NAG (FCZA) also reported USN advisors assisted local Civil officials and VN Navy in distributing gifts to 1,000 children of Thuan An refugee settlement during a mid-autumn festival. The report noted that the activity was well received by refugees and will likely advance the Pro-GVN program in that area.

(6) Civilian Rewards Campaign. III MAF/I Corps Civilian Rewards program achieved new highs during October with total 1,794 incidents and 1,039,009 \$VN paid to Vietnamese participants as rewards. Both figures exceed highest previous monthly totals and brings total number of incidents for January through October to 6,891.


