NARRATIVE SUMMARY

1. General. (U) During the period 1 - 30 June 1967, Marine Wing Headquarters Group One continued to provide 1st Marine Aircraft Wing with support in air control, air defense, administration and maintenance of Wing Headquarters Camp Facilities. Marine Air Control Squadron Four joined MWHG-1 on 3 June 1967.

2. Personnel. (C) MASS-2 and MASS-3 remained in a C-1 category, and 2d LAAM Bn joined sufficient trained personnel to advance to C-1 also. H&HS-1 and 1st LAAM Bn remained in C-2 condition and MACS-7 stayed C-3. MACS-4 arrived in country in a C-1 condition and remained so throughout the month.

3. Administration. (U) Routine administration progressed throughout the month of June.

4. Morale/Welfare. (U) Liberty remained secured in Danang and Hoa Phut Village, outside the Danang Air Base, throughout the month of June. The beach facilities in the Danang/Chu Lai areas were open to all hands and provided the majority of recreation for personnel. In country R&R was provided at China Beach and there were one day cultural sight-seeing trips to HUE, along with one day fishing trips every Wednesday and Saturday. R&R flights to the following locations were conducted during the month of June:

4. MONTHLY CIVIL A. FAIRS RECAP BY UNITS OR MWAG-1.

a. MACS-4

- 1. The Civil Affairs Officer and ECO have met and discussed the Civil Affairs with their counterparts on all levels.
- 2. MACS-4 has made itself available to the Civic Action OIC of NSA for projects in and around Hai Village on an "on call" basis.
- 3. MACS-4 has volunteered to teach Buddhist Monks English in and around Hai Village after they return from their three month retreat
- 4. MACS-4 is presently employing twenty (20) refugees on a daily basis, to fill sandbags.

b. 1st LAAM Bn.

- 1. A piano was presented to the Sacred Heart Orphanage.

2. Thirty-five (35) refugees from Hoa Coun~~g~~ Village were employed to fill sandbags and were paid in food.

3. Father Singleton was provided a 2½ ton truck five days to aid in his food distribution program.

c. MASS-3

1. Films were shown in Trung Toan and Son Hi and 125 people attended at each showing.

English Language classes were begun in Ky He Village.

3. Seven bags of cement were given to the Hamlet chief of Trung Toan for construction of a public well.

4. Three bags of cement were given to Ky He Village for repair of a public building.

d. MAHS-1

1. One truckload of damaged lumber was given to the chief of Hoa Tien.

2. The CA team passed out 450 bars of soap to the people of the refugee camp.

3. Work has been found for many of the refugees filling sandbags for the different units of MAHG-1.

4. L/cpl Gosko, a member of the CA team, is sponsoring one of the refugee children through school in Danang.

e. 2nd LAAM Bn.

1. 100 school kits were distributed to the schools at Hoa My and Hoa Long.

2. The immunization program is continuing with over 700 civilians having received plague and cholera shots.

f. Assistance rendered to the Vietnamese by MAHG-1 during June included the following:

1. Divine Services

a. Roman Catholic Mass was said in the Wing Memorial Chapel through the month of June by Wing Chaplain Ferreri. Sunday Masses (0800 and 1745) had a total attendance of 372. Daily Mass at 1730 totaled 117.

b. Protestant services were held at 0930 Sundays and 1830 Monday through Saturday. Sunday attendance was 159, with 228 attending during the week.

c. Episcopalian services were conducted each Sunday at 1600.

d. Orthodox services were conducted the 1st and 3rd Sundays at 1100.

2. Personnel

a. Chaplain Peter J. Ferreri, CDR, CHC, USN, Wing Chaplain serves as Roman Catholic Chaplain for MWHG-1.

b. Chaplain William J. Winslow, LCDR, CHC, USN, Admin-Assistant to the Wing Chaplain is now serving as the Group Chaplain.

c. Chaplain Saltzman, LT, CHC, USNR, the MWHG-1 Jewish Chaplain was detached 5 June 1967 for release from active duty.

3. Civic Action

a. Chaplain Winslow donated 540 lbs. of food stuffs to Danang Baptist Mission. Chaplain Winslow also donated 580 lbs. of flour to the Baptist Mission.

b. Group Chaplain Winslow gave 3 Indoctrination Lectures with 60 attending.
