NARRATIVE SUMMARY

1. Special Operations:

a. During September 1968, VMO-2 flew a total of 2,822 sorties for a total of 2,473.5 hours. This total includes gunships and OV-10A's. During these combat sorties, the pilots accomplished the following tasks:

- (1) Armed Helo Escort
- (2) Visual Reconnaissance
- (3) Fire Fly
- (4) TAC(A)
- (5) VIP
- (6) APD (Airborne Personnel Detection)

2. Highlights of the month. The following data is taken from the daily after action reports and is typical of the kind of operations that were preformed by VMO-2 during the month of September 1968.

- 6 Sept OV-10A while on VR mission located and maintained watch over 2 stranded marines in the allenbrooke area, also helped conduct rescue operation.
- 10 Sept An OV-10A was scrambled after another OV-10A sighted road building equipment, but had to leave due to bingo fuel. The second OV-10A controlled 2 flights of fixed wing resulting in 1 road roller, 1 road grader, and 1 bridge destroyed. Also there was a supply area damaged and 2 concrete bunkers uncovered.
- 20 Sept 2 gunships, in support of 1st Recon Bn, observed an active .50 cal position and attacked it. Mission was aborted due to intense enemy fire in area.
- 28 Sept 2 gunships observed rockets and RPG rounds being launched against Thoung Duc. Returned suppressive fire against all positions, with unknown BDA due to darkness.
