NARRATIVE SUMMARY

APRIL: A detachment of three (3) officers and ten (10) enlisted with two (2) OV-10A aircraft were deployed to NAS Atsugi to provide artillery spotting for training exercises conducted by the 12th Marines. The 12th Marines made two (2) A/O's available at NAS Atsugi for liaison and mission requirements. For the period 24 March thru 21 April the detachment flew a total of fifty-two (52) sorties accumulating one hundred and ten point three (110.3) flight hours. Only 33 percent of all scheduled sorties in support of the 12th Marines were flown due to poor visibility and low clouds.

During the period 26 thru 30 April the Squadron was inspected by the Inspector General of the Marine Corps. All hands participated in at least one phase of the inspection. The Squadron personnel put forth a great deal of effort in preparing for the inspection. The Squadron overall got a satisfactory grade and discrepancies noted were corrected.

MAY: A detachment of three (3) officers and ten (10) enlisted with two (2) OV-10A aircraft deployed to NAS Atsugi, Japan during the period 12 May thru 25 May to provide FAC(A)/CAS support for training exercises conducted by BLT 2/4. During the deployment the detachment flew a total of twenty-nine (29) sorties accumulating sixty point eight (60.8) hours. In addition to support of BLT 2/4 training was accomplished in International Navigation and Cross Country Flying.

Two (2) OV-10A aircraft departed for NAS Atsugi on 12 May 1971. Approaching MCAS Iwakuni the scheduled RON/refueling enroute stop, the two aircraft had a Mid-Air collision. All three crew members ejected and were safely picked up at sea by the Japanese Coast Guard. Both aircraft were lost at sea.

On 14 May LTCOL J. L. NORTON assumed command of VMO-6 at a Change of Command Ceremony conducted on the Squadron Flight Line.

On 27 May SCPTMAJ AURIN was transferred to Group Headquarters and 1STSGT A. T. TORIZZO assumed the SCPTMAJ duties of VMO-6.

JUNE: A detachment of six (6) officers and fourteen (14) enlisted with two (2) OV-10A aircraft deployed to NAS Atangi on 21 June and is scheduled to return on 2 July 1971. The detachment deployed to provide artillery spotting for training exercises conducted by BLT 3/9. The detachment has flown a total of forty-eight point seven (48.7) hours and twenty (20) sorties during the period 21 June thru 30 June.

On 25 June 1971 the UH-1E Pilots, UH-1E maintenance personnel and UH-1E aircraft were transferred to HML-367.
