

PART TWO: Narrative Summary

Marine Aircraft Group 13 continued its support of III MAF and all other free world Armed Forces in the I Corps Tactical Zone, Laos and the Gulf of Tonkin. Operations supported were Iron Mountain, Purple Martin, Oklahoma Hills, Russell Beach, Fredrick Hills, Project Delta, Massachusetts Striker, Bristol Boats, Pipestone Canyon, Victory Dragon XI, Apache Snow, Virginia Ridge, Cameron Falls, Massachusetts Bay, Herkimer Mountain, Geneva Park, Lamar Plain and Kentucky Jumper. Flying a wide variety of missions, MAG-13 aircraft provided support for the First and Third Marine Divisions, Task Force 77, Attack Force Alpha, Republic of Korea Marines, ARVN forces, 7th Air Force, 101st Airborne Division, Americal Division and other U. S. Army units.

Air-to-ground strikes, consisting of 1442 sorties, resulted in 123 KBMA, 726 bunkers destroyed, 289 secondary fires, 728 structures destroyed, 121 secondary explosions, 18 tunnel complexes destroyed, 7 sampans, 10 trucks, 18 AA weapons positions, 2 dams, 1 bridge, 1 armored personnel carrier and 5 water buffalo destroyed.

Fightertown Phantoms logged 77 fighter sorties over the waters off North Vietnam as a Barrier Cap in support of air operations in the Gulf of Tonkin. There were no engagements with enemy aircraft.

MAG-13 lost two (2) aircraft as a result of enemy action during May.

On 11 May, an F4B from VMFA-115 was shot down during an air strike in support of Task Force Alpha. The pilot ejected successfully and was rescued some two (2) hours later and required MEDEVAC out of country. The RIO was lost in the crash of the aircraft and declared KIA.

On 12 May, an F4J from VMFA-334 was hit by ground fire during a CAS mission. Both crewmembers egressed successfully and were rescued with minor injuries.

On 16 May, F4B BuNo 153037 crashed on takeoff at NAS Cubi Point. The crew ejected safely and were uninjured.

On 18 May while flying a CAP mission, Major J. D. MOODY (Pilot)/1stLt R. R. GRIFFITHS (Rio) (F4B BuNo 152450) and Major A. GILLESPIE (Pilot)/1stLt V. R. MADDOX (Rio) (F4B BuNo 152270) were air refueling from a KC-130 when it was struck by a VMFA-542 aircraft. Major GILLESPIE's aircraft broke away and returned safely with minor damage. Major MOODY's aircraft received FOD damage to both engines with uncontrolled flight ensuing. The crewmembers ejected safely, were uninjured and rescued immediately.

PART THREE: Significant Events

1. Personnel

During the month of May, Marine Aircraft Group 13 had a loss of sixteen officers and 190 enlisted personnel due to rotation and transfers. During the same period, ten officers and 133 enlisted personnel reported to this Group for duty.




4. Civic Action

a. The Group Civic Action Program continued in high gear throughout the month as Civic Action personnel conducted a MEDCAP in the village of Binh Son. Vaccinations and treatment were administered to approximately 318 Vietnamese civilians.

b. MAG-13 Civic Action team assisted a Vietnamese father in locating the body of his son, and returned the body from Quang Ngai to Ky Chanh.

c. MAG-13 and 9th Engineers Civic Action Teams were invited to have dinner at a vietnamese home. After the dinner the teams inspected local boys and girl scout units.





5. Intelligence

a. The S-2 section continued it's mission of briefing and de-briefing all aircrew members.

b. The month of May was a very active one for the enemy. Chu Lai came under attack six times during the month. The first attack occurred at 0300H on 12 May. This attack consisted of seven (7) 122mm rockets of which four impacted in An Tay, wounding five civilians, two rounds impacted in subsector #3, and one round in subsector #2 with no casualties or damage reported. The second attack occurred at 1020H the same day. This attack consisted of six 122mm rockets with one round impacting in the 312th Evac Hospital with minor damage to a building, one round impacting near 312th beach, one round on the USO beach area, one round between the East and West fields and two rounds impacting in the ocean near the liquid oxygen plant with no damage reported. The third attack occurred on 12 May at 1336H. One round of 122mm rocket fire impacted in subsector #7 with no casualties or damage. The fourth attack occurred on 17 May at 0630H when five 122mm rockets impacted outside of the perimeter on the west side of Highway One, with no casualties or damage reported. The fifth attack occurred at 0236H on 20 May with six 122mm rockets impacting, with two rounds in the ocean, three rounds in subsector #4, and one round outside the perimeter. The attack resulted in no casualties or damage reported. The sixth and final attack occurred at 0155H 24 May with eight (8) unknown type mortar rounds impacting in subsector #8 with no casualties or damage reported.



- c. Four-hundred sixty-seven line items of APA material have been reported as excess. Disposition for 138 line items has been received, this material has been pulled from stores and shipped.




