Subj: Intelligence Input for Command Chronology (U)

Ref: (a) Group Order 5750.1C, paragraph 6c

1. In compliance with reference (a), the intelligence input for the MAG-16 Command Chronology for May 1968 is submitted herein.

2. Ground Activity. During the month of May the enemy conducted the following attacks against Marble Mountain Air Facility:

5 May	-	41 Rounds of Mortars (82mm)
12 May	-	20 Rounds of 122mm Rockets
20 May	-	31 Rounds of Mortars (82mm)
22 May	-	20 Rounds of Mortars (82mm)

3. Antiaircraft Fire Incidents.

a. 456 fire incidents were reported during the period, up 210 from the previous month; 98 of which resulted in aircraft hits; up 59 from the previous month.

b. Enemy AA fire caused 11 USMC WIA crew, 1 USMC MIA, 1 aircraft to crash USMC, 4 aircraft destroyed USMC and 2 missions to be aborted.

4. Intelligence Information.

a. 16 aircrew spot reports of intelligence value were received from aircrews and other sources; this is an increase of 2 from the previous month.

b. 4 reports of intelligence were received from indigenous sources; up 2 from the previous month.

1. The doctors and corpsmen of 5th Comm. BN. treated a total of 70 patients during the month of May.

2. 1 Vietnamese National is undergoing training in health and sanitation.

D. MCB-128

1. The doctors and corpsmen of MCB-128 treated a total of 325 during the month of May.

F. DSAC, 560th Gen, Sup, Co.

1. Arrangements have been made on a strictly limited basis to transport one person at a time to 95th EVAC Hospital (Army) for treatment. This will be available for serious medical cases in Son-Thuy II hamlet.

II. Education

A. MAG-16

1. Every Thursday of the month, housemaids of MAG-16 are given instruction in the English language. Each class is a $\frac{1}{2}$ hour in duration.

2. Seven students are studying under the General Walt Scholarship Program. Every month 3500\$VN is donated from MAG-16 Civic Action Office with the funds being allocated from 1st MAW.

3. The Monthly Wing and Group Personal Response Meetings were held during this reporting period. Squadron Personal Response Meetings started on 4 June.

B. 3rd LVT.

One movie was shown at the Officer Club on 26 May for 55 children and adults.

C. MCB-128

1. A total of 3 movies were shown with an attendance of 650 people.

2. 2 English classes were held during the month. Attend : 6 people.

D. DSAC, 560th Gen. Sup. Co.

1. DSAC Chaplin teaches his students 26 hours of English per month.

III. Projects

A. MAG-16

1. Among MAG-16's projects including the Village School, Village Dispensary, Nui-Kim-Son Pagoda etc. The majority of this past month's work has been concentrated on the re-construction of 15 homes in Nui-Kim-Son that were destroyed by the 4 May 68 Viet-Cong rocket attack. Work is progressing extremely well. Est 35% complete.

2. Work on the village school is progressing steadily and the dispensary is drawing close to completion.

3. MAG-16 continued to support the Hoa-Long village Contingency Fund with

personnel from Civil Affairs. MAG-16 used to guard and supervise the detail at NSA trash dump.

B. 5th Comm. BN.

1. Construction of the bridge at Da-Mon hamlet has been completed and now in use.

2. Construction of a house for a 5th Comm. BN. Vietnamese employee has been delayed due to lack of lumber.

C. DSAC 560th Gen. Sup. Co.

1. Construction of 13 houses with lumber, tin and cement provided. Est. 54 $\frac{1}{2}$ % complete.

2. DSAC is providing MAG-16's Nui-Kim-Son house re-construction project with large quantities of cement. Est 35% complete.

3. DSAC is also assisting MAG-16 with roofing materials for the Village School Project.

4. Provided materials, lumber and tin to improve and repair two dwellings in Danang.

Completed.

5. Information concerning Vietnamese customs and way of life is being published in the 1st LOG.Command Newspaper and broadcast on Danang T.V. Capt. Brassier, the CAO of DSAC 560th Gen, Sup, Co., had a personal interview on Civil Affairs Projects on Danang radio.

6. Provided lumber and tin to complete a school project at the Baptist Activities Center, 33 Hoang-Dieu Street in Danang.



COMMUNICATIONS Personnel losses exceeded personnel gains during this period. Currently a shortage exists of Communications Center and Wire personnel. However, by cross-training personnel from the Radio Section, the Message Center continues to operate efficiently. Message traffic continues to be big business. Total volume of messages handled by MAG-16 Communications Center was 7,951, a slight decrease of 127 from the previous period. 106 hours of down time was experienced during the month due to faulty equipment.

The following transactions were effected by the Repair Section:

1. 128 items of equipment were processed.
2. 105 items of equipment returned to section.
3. 9 items of equipment evacuated to higher echelon of maintenance.
4. 9 items of equipment returned from higher echelon of maintenance.
5. 49 requisitions processed by Supply Section.

During the rocket attack of 4-5 May, 1 telephone TA-312/PT and approximately 2000 feet of 6 and 12 pair cable connecting the TOM-10 and TOM-20 intercommunications system were destroyed. Restoration of these two systems required approximately 30 hours with all available Wire personnel exerting the maximum effort. On 12 May, Marble Mountain was subjected to an enemy rocket attack at which time, the TOM-10 and TOM-20 cable system was severely damaged. It was evident that the hangar area of H&MS-16 and all tactical squadrons are becoming an enemy rocket and mortar impact area. Therefore, a decision was made to bury four cables, totaling 150 pairs. This would provide adequate protected circuits for the TOM-10 and TOM-20 and all MAG-16 lines to the tactical squadrons.

less HMM-163 as well as the five TOM-20 systems for 3M. This should result in a significant reduction in telephone trouble caused by flying shrapnel. Further, a new five pair and 26 pair cable connecting MAG-16 and Zulu Company has been installed and buried to prevent any interruption by rocket and mortars. During this period the new Command Bunker was completed. The mutual cooperation of Communications, Operations and Intelligence section was evident throughout and permitted these sections to relocate in the new facility without diminution of staff efficiency or operational effectiveness.
