PART IINARRATIVE SUMMARY

(C) During the reporting period, MAG-36 was involved with the final stages of the Vietnamese War. Units from MAG-36 saw the conclusion of the war with the ending of Operation END SWEEP in the Gulf of Tonkin. Combined training with U.S. Navy and MAG-36 units was continued in the Republic of the Philippines.

(C) Operation END SWEEP was partially accomplished due to the efforts made by units from MAG-36. Under the command of CTF-78, the airborne mine-countermeasures (AMCM) and SAR forces of HMM-165 and HMM-164 SAR "Det" were involved.

(C) Operation EAGLE PULL made the force in readiness concept of the Marine Corps hold true. The insurgent conditions around Phnom Penh increased in activity with hostile fire making a contingency plan for extraction of embassy personnel necessary. MAG-36 was alerted and plans went into effect for a composite squadron of 13 CH-53's, 3 CH-46's, and 4 AH-1J's to be assembled aboard the USS Tripoli. Personnel and aircraft were supplied by MAG-36. During the month of August, HMM-165, with detachments from HMM-462 and HMM-164, participated in operations in the Gulf of Siam.

(C) September brought about the need to swap battalions and personnel aboard the USS Tripoli. The stand by for EAGLE PULL had been relaxed to a ready stand by; thus, the Amphibious Ready Group was able to return to Subic Bay to prepare for Operation PAGASA II. The assets for PAGASA II came from the composite squadron and "Det A" of HMM-165, already in Subic Bay. PAGASA II was staged in Mamburao, Republic of the Philippines. Some

assets were ashore and some were working from ship board.

(C) VMGR-152 continued to provide aerial refueling operations and logistical support for Task Force Delta at Nam Phong AB, Thailand. H&MS-36 continued support of operations in Southeast Asia with Detachment Delta at Nam Phong, Thailand. On 17 September, Detachment Delta was deactivated and returned to MAG-36.

(C) In December, after being afloat for 25 months, HMM-165 returned to MCAS(H) Futema. HMM-462 became MAG-36's representative afloat as a composite squadron with 15 CH-53's, 3 CH-46's, 4 AH-1J's, and 2 UH-1E's.

(C) The remaining subordinate units of MAG-36 conducted training on an individual basis to maintain their ready posture. MAG-36 flew 1051 frags during the period. 709 of these frags were 3rd MarDiv, 116 for III MAF, 88 for Camp Butler, and 138 for MAG-36 support.

(C) The period came to an end with HMM-462 afloat aboard the USS Okinawa. Operation EAGLE PULL still remained a contingency with MAG-36 supporting the operation with HMM-462 standing by.

| 26 July | (C) Operation EAGLE PULL, an operation designed to extract embassy personnel from Phnom Penh, Cambodia, made it necessary for MAG-36 to revise off-load plans for HMM-165. |
| 26 July | (U) HMM-165 was alerted for Operational EAGLE PULL. |
| 26 July | (C) Seven CH-53's departed Futema for Cubi Point to join 31st MAU for Operation EAGLE PULL. Pilots furnished by HMM-462, HMM-164, and MAG-36 resources. CH-53's from HMM-462 were to be used. |

- 28 July (C) Six remaining CH-53's departed for Cubi Point for Operation EAGLE PULL.
- 31 July (C) Four AH-1J's "Cobras" were loaded aboard C-5A at MCAS Futema for delivery to Cubi Point to join up with Operation EAGLE PULL.
- 2 August (C) One CH-46, YT-13 of HMM-164 was launched at approximately 0015 on SAR mission to the NTA. Aircraft crashed at approximately 0040 to 0100, and burned. All crew members were killed.
- 2-3 August (U) MGen LANG visited Futema and met with Mr. Robert D. NESSEN, Assistant Secretary of the Navy. He later visited the crash site, and toured MCAS areas.
- 8 August (U) Four OV-10's went to Cubi Point with the date of return to be 23 August 1973.
- 8 August (U) One CH-46 of HMM-164 caught electrical wires on its landing gear while low leveling, no one injured.
- 15 August (U) VAdm STEELE, the new COMSEVENTHFLT, visited MCAS Futema/MAG-36.
- 17 August (U) Colonel F. W. HARRIS III, the new Chief of Staff of III MAF, visited MCAS Futema/MAG-36.
- 20 August (C) One CH-46 of H&MS-36, Sub Unit #2, Atsugi, Japan, crashed while on final approach at Yokosuka NB. The crew sustained minor injuries—two passengers were killed.
- 22 August (U) BGen JANNELL, Assistant Wing Commander, 1stMAW, visited Futema. A dinner was held for him on 23 August. He departed on 24 August. While visiting MAG-36, both General JANNELL and his aide were furnished flight time in Cobras and CH-53's.
- 23 August (U) Colonel KAPETAN went to 1stMAW for Commanding General's Conference. He returned the same day.
- 25 August (U) All Marine CH-46's were grounded until further notice due to latest accident (20 August 1973). Aircraft were to be placed in an up status as they were inspected.
- 31 August (U) MGen LANG was provided transportation by MAG-36 while on Okinawa for 3rd Marine Division change of command.

- 31 August (U) BGen JANNELL stopped at MCAS(H) Futema to change aircraft enroute from MCAS Iwakuni, Japan to the south.
- 3 September (C) Two OV-10's were sent to Atsugi.
- 6 September (C) USS Tripoli, with CH-53's from HMM-165 and HMH-462 aboard, stopped at White Beach to exchange personnel with MAG-36. Also, the BLT was off loaded.
- 9 September (C) Two OV-10's returned from Atsugi.
- 10 September (U) BGen JANNELL visited MCAS(H) Futema for billeting while he was visiting various commands in the area.
- 10 September (U) Major BALCH assumed command of HMH-462 from Major COX.
- 13 September (U) LtCol LUNSFORD assumed command of HML-367 from Major GATZ.
- 14 September (C) Four OV-10's departed for Cubi Point.
- 17 September (C) Detachment Delta at Nam Phong was deactivated.
- 19 September (U) LtGen WILSON, CG FMFPac, visited MCAS(H) Futema and MAG-36. He was escorted by BGen FRIBOURG, CG, Camp Butler.
- 19 September (U) One AH-1J Sea Cobra of HMM-164 had a tail rotor failure, and made an emergency landing 2.5 miles on the 175° radial of Futema Tacan, no one injured.
- 2 October (U) Two CH-53's of HMH-462 departed for Taiwan in support of CMC visit there.
- 2 October (U) One CH-53 of HMH-462 departed for Iruma, Japan, via Iwakuni and NAS Atsugi. It was to be in place for the Japan International Air Show at Iruma on 4 October 1973. After remaining as a static display from 4 October through 11 October, it was scheduled to make a demonstration tour of Japanese Self Defense Bases with Sikorsky factory representatives. The date of return was to be approximately 30 October 1973.
- 3 October (U) One OV-10A of VMO-6 departed for Iruma to be in place by 4 October 1973 as a static display for the International Air Show from 4-11 October.
- 5 October (U) BGen JANNELL arrived via C-130 to visit with III MAF. He spent the night at the "Eagle's Nest".

- 6 October (U) General JANNELL departed.
- 7 October (U) One aircraft in support of CMC returned from Taiwan. One aircraft was down in Taipei and would return as soon as possible.
- 7 October (U) Eight CH-46's and two UH-1E's of HMM-165 returned to MCAS(H) Futema. Two UH-1E's of HML-367 also returned to MCAS(H) Futema.
- 10 October (U) MGen HAYNES visited for briefings by MAG-36 and MCAS(H) Futema.
- 15 October (U) Colonel PALMER, Wing Inspector, and his inspection team arrived. Pre-inspection briefing and counter-part meetings were held in the Station theater.
- 16-19 October (U) Functional Management Inspection was in progress. A general debriefing of the entire inspection was held on 19 October at 1400. The results of the inspection for MAG-36 were considered satisfactory with discrepancies.
- 18 October (U) PROV MAG 10 formally commenced planning.
- 18 October (U) Colonel KAPETAN departed for MCAS Iwakuni for Commanding General's monthly meeting. He returned approximately 1600.
- 20 October (U) Wing Inspection Team departed MCAS(H) Futema for MCAS Iwakuni.
- 23 October (U) MGen LANG, CG 1stMAW, arrived at MCAS(H) Futema, for briefings with Marine units on Okinawa and to fly various MAG-36 aircraft. MGen LANG and his wife were billeted at "Top of the Rock" VIP Quarters.
- 25 October (U) DEFCON Condition 3 was set at 0630Z by MAG-36.
- 26 October (U) MGen LANG departed Okinawa via C-130 for return to MCAS Iwakuni.
- 27 October (U) Ground and Aviation Officers Monitors arrived at MCAS(H) Futema for a visit with Station and MAG-36 personnel.
- 28 October (U) DEFCON Condition 4, Normal Condition, was set by MAG-36.
- 30 October (U) Ground and Aviation Officers Monitors departed for MCAS Iwakuni.

- 6 November (U) MGen LANG visited MAG-36/Squadron Commanders and departed for MCAS Iwakuni.
- 9 November (U) BGen JANNELL visited MAG-36 and flew with the squadrons.
- 10 November (U) 198th birthday of the U.S. Marine Corps, BGen JANNELL attended the celebration. A ball was held in Futema 'O' Club.
- 14 November (U) BGen BROOKS, Assistant Division Commander, 3rd Marine Division, was given a briefing on operations in MAG-36.
- 14 November (U) Colonel KUCI, MAG-36 Executive Officer, departed for MCAS Iwakuni for Commanding General's monthly meeting.
- 15 November (U) Colonel KUCI attended Commanding General's briefing at MCAS Iwakuni.
- 15 November (U) PROVMAG 10 officially stood down due to delay of Operation FLY-A-WAY. Some personnel were maintained to continue planning.
- 26 November (U) MGen JOHNSON, Deputy CG FMFPac, attended MAG-36 Operations briefing.
- 30 November (C) USS Okinawa docked pier side at White Beach to prepare for off-loading of HMM-165 and for on-loading of HMH-462. The composite mix of the squadron was 13 CH-53's, 3 CH-46's, 4 AH-1J's, and 2 UH-1E's.
- 1 December (C) HMH-462 completed on-loading to USS Okinawa. HMM-165 returned to Futema.
- 5 December (C) A CH-46D from HMM-164 crashed at 050618Z in an open field, as it approached Point Yankee. Aircraft was on local post maintenance flight, and had 5 crewmen. Two enlisted crewmen were dead on arrival and one died on the operating table. Pilot suffered third degree burns, while co-pilot suffered a broken neck and his condition was considered very serious.
- 5 December (U) 3rd Marine Division personnel arrived for Air/Ground Officer Exchange Program and began tour of HMM-164. BGen JANNELL arrived with 1stMAW personnel for exchange program.

- 6 December (U) 3rd Marine Division personnel departed for MCAS Iwakuni and 1stMAW personnel began tour of HMM-164.
- 7 December (U) 1stMAW personnel departed for tour of 3rd Marine Division and 3rd Force Service Regiment.
- 11 December (C) One OV-10A from VMO-6 crashed in a training area near Subic Bay, Republic of the Philippines. The pilot was killed and the air observer was injured.
- 12 December (U) 1stMAW personnel returned from 3rd MarDiv and transferred to MCAS Iwakuni by C-117. 3rd MarDiv personnel returned from MCAS Iwakuni and were transported to 3rd MarDiv.
- 23 December (U) Colonel KAPETAN gave Christmas party for MAG-36 staff.

(C) The reporting period began as Operation END SWEEP ended and plans to return HMM-165 to MCAS(H) Futema commenced. Plans were also being made for PAGASA II in the Republic of the Philippines.

(C) The changing of the situation in Phnom Penh, Cambodia, brought about Operation EAGLE PULL and the plans and mobilization of MAG-36 assets to Subic Bay, Republic of the Philippines. A new composite squadron mix

(13 CH-53's, 3 CH-46's, and 4 AH-1J's) was formed and went aboard the USS Tripoli. An ARG was formed and set sail for operations in the Gulf of Siam.

(U) Maj F. E. MILLNER was Operations Officer during July, LtCol W. T. LUNSFORD during August, and LtCol R. M. COOKE took the reins on 23 September.

(C) MAG-36 Operations and PROVMAG 10 worked together from October planning for the upcoming Operation FLY-A-WAY in Korea in February 1974.

(U) Colonel K. C. PALMER, Wing Inspector, and his inspection team arrived on 15 October. Pre-inspection briefings and counterpart meetings were held. Functional Management Inspection began on 16 October and ended 19 October with a debriefing. The results of the inspection for MAG-36 were considered satisfactory with discrepancies.

(U) MAG-36 Operations was involved during the reporting period with numerous briefs for General Officers providing updated information on MAG-36 readiness status and posture.

(C) In December, HMM-165 returned to MCAS(H) Futema for the first time in 25 months. HMH-462 became the deployed float squadron composed of 15 CH-53's, 3 CH-46's, 2 UH-1E's, and 4 AH-1J's. The reporting period ended with MAG-36 and HMH-462 on ready standby for Operation EAGLE PULL.

Between 1 July and 4 July Capt. STUBER conducted a liaison visit at NAM PHONG concerning Headquarters and Maintenance Squadron 36 Det "Delta" and VMGR-152's retrograde returning to MCAS (H) Futema.

NARRATIVE SUMMARY

1. The MAG-36 Human Affairs Branch (S-5) was officially established 7 August 1971. It has continued to progress and provide services to Marine Corps personnel stationed at MCAS(H) Futema since the last command chronology. A diagram of the organization of the Human Affairs Branch is located in Part IV of enclosure (1).

2. Individual Functions:a. Drug Program

1. Drug Abuse Lectures were given to 1,342 Marines during welcome aboard presentations and squadron level indoctrinations.

2. Capt P. J. DISHON and Lt. D. J. VOLLMAR attended the Drug Abuse Advisors' Course at Yokosuka, Japan, during the month of December. Lt. R. R. MOORE attended the Drug Rehabilitation Training Center at UCLA Los Angeles, California, during the month of November 1973.

b. Human Relations Program

1. A total of 331 Marines completed Phase I training. Phase II manuals did not arrive until the last week of November. During the month of December 87 Marines completed Phase II training. There were 36 Human Relations Unit Discussion Leaders Trained.

2. Lt. J. R. WHEELER and SSgt J. P. DEVAUGHN went to Atsugi, Japan, during the month of December to provide Human Relations Training, Phase I and Phase II, to the H&MS-36 Sub Unit #2 detachment.

c. Action Line

1. The action line was down from 13 September to 10 December 1973 for repairs. Fewer calls have been the trend to date, but the continuation of the function appears justified as a meaningful device for rumor control & counseling assistance.

d. Career Planning

1. During the past six months 65 first term eligible Marines reenlisted, a rate of 60%. All 46 eligible career Marines reenlisted. The MAG-36 career planner's office was relocated centrally in the squadron working area, housed in a trailer. The trailer was completely modified inside to give the appearance of an up to date office.

e. Education

1. MAG-36 and MCAS(H) Futema began plans in September to combine their efforts on a full time basis. In November MAG-36 and MCAS(H) Futema physically combined their education offices.

2. An intensive effort has been made to locate all non-high school graduates for counseling, testing and enrollment in vocational and traditional high school courses.

3. Dr. H. BURNETT, director of DOD Educational Programs, Okinawa, has presented PREP lectures to 306 non-high school graduates during the month of November and December. Dr. BURNETT is giving guidance to a DOD pilot program for MCAS(H) Futema. Traditional float material will be used on the station with a test group of 60 Marines. Classes are scheduled to begin in January 1974.

4. A float program was established for HMM-462, which departed in November. Approximately 50 students will be involved.

5. Vocational education is being offered on station for the first time. At present they consist of welding and photography. Heavy equipment operation will be offered in March 1974.

6. The education office is placing most of its emphasis on the Marine who needs a high school diploma. PREP lectures and GED testing are planned for approximately 400 additional Marines. It is the goal of MAG-36 to make the means to a high school education available to all Marines who have a desire to pursue it.

f. Services Review Committee (SRC)

1. The MAG-36 Services Review Committee continues to meet and discuss agenda items proposed by subordinate units. The SRC has been very effective in the improvement of messing procedures, the modification of dress regulations, the improvement of Bus Service, and the improvement of Futema gate procedures.

g. Ad Hoc Functions

1. Members of the Human Affairs Branch have been invited to the University of Ryukus at Naha, located in Shuri City, Okinawa. Human Affairs Personnel have attended university field meets and discussion sessions. Students in exchange have had discussions every Thursday night at MCAS Futema between themselves and MAG-36 Marines.

2. The Human Affairs Branch has initiated a cultural and language program designed to help Marines understand the Okinawa culture and enable Marines to communicate with the Okinawan people.

3. The cultural and language program is organized and controlled by SSgt J. P. DEVAUGHN and Cpl R. C. KORNEGAY. Movies on the History of Okinawa and slides of Okinawa are shown to Marines attending the program.

4. The welcome aboard program is managed by the Human Affairs Branch. The presentation is directed toward helping Marines understand the drug and alcohol problem, inter-racial relationships, group identification symbols, new laws since the reversion, and acquaintant Marines with the Okinawan and Japanese people.

Comment: There is a lack of USO shows at Futema.



n. Item: Bus Service

Comment: The airfield at Futema opens at 0700. Our squadron has frequent large 0700 launches. Our show time for an early launch is 2 hours before takeoff. We are requesting an improved bus schedule to allow our large flight crews (min. of 6 personnel per aircraft) and large maintenance and ground crew (min. of 10 personnel) needed to launch our aircraft, transportation to the hangar area. It is recommended that beginning the bus schedule at 0430 vice 0600 would help solve the transportation problem that now exists in our squadron. Motor T is unable to help with the needed driver and extra truck required to get our launches off on time. The regular bus schedule is unsatisfactory in that they don't adhere to published schedules; the buses often are close together at pick-up points and not spaced apart to conform with bus schedule.

Comment: We would like to know the possibilities of being able to check out 10 speed bikes.

Action: Ten-speed bikes were in the Special Services system last April for one week, and in that time all ten allotted to Futema were broken beyond economically feasible repair. Butler then recalled all bicycles. Further inquiry into the possibility of getting them back will be made.

l. Item: No Smoking Signs on Buses

Comment: Recommend placing "No Smoking" signs on Base busses as soon as possible.

Action: Signs are being made at this time.

m. Item: Hostess House

Comment: Human Affairs Office should investigate the possibility of a Hostess House for enlisted men's wives who come to Okinawa.

Action: Butler Special Services was contacted and relates that there are very few shows being sent over. This month there were 3 shows only, which performed 2 times each; therefore each Marine Corps base had one show. Ours was A Taste of Honey, 1 December.

d. Item: Weight Room

Comment: The weight room in the Futema gym has dirty canvas and is generally unkempt. The Universal machine is broken and racks need to be constructed for the weights.

Action: LT Layher has taken over the Base Special Services program and has made the improvements suggested.

e. Item: MCAS Futema Hobby Shop

Comment: The Hobby Shop is out of stock on many items.

Action: Camp Butler representatives are still attempting to negotiate contracts with individual Japanese corporations to acquire more stock.

f. Item: Snack Lines

Comment: Only one line is set up at the Mess Hall resulting in long lines and periods of waiting to be served.

Action: Problems with the Snack line include crowding, frequent fights as well as long lines. The entire Snack Bar operation is being reviewed by the Group CO and changes will be made shortly.

g. Item: Inadequate Banking Facilities

Comment: The banking facilities are very inadequate on paydays and barely adequate for the rest of the time.

Action: A mobile check-cashing van will be instituted soon to provide this service on paydays. Its first trip should be in January.

h. Item: Movies at the Club

Comment: There are no longer movies being shown in the clubs.

Action: The movies are beginning the first week of December.




DIAGRAM OF THE HUMAN AFFAIRS BRANCH ORGANIZATION


1. Functioning within the guidelines of reference (a), the Board convened on 24 March 1972 to review the case of LCpl JONES, who was granted drug abuse exemption according to reference (b) on 4 February 1972. He reports having used barbiturates, amphetamines, THC, marijuana, hashish, mescaline, psilocybin, and LSD, heavy use of the latter at time of exemption.
2. The exemptee received his initial medical/psychiatric evaluation on 4 February 1972, has received counseling by a military chaplain, and nine individual therapeutic sessions with MAG-36 counselors.
3. The slender, youthful exemptee possesses a personality that is incompatible with normal military life. He relates a history of repeated experiences with hallucinogens over a period of three years and admits to a psychological dependency for daily usage. During the five weeks of regular therapeutic counseling, he attempted to modify his behavior by demonstrating interest in other activities, but change was minimal and relapse to drug usage was admitted. Although rational in his thought and communicative processes, he states no interest in changing his life style or in continuing to work within a squadron environment. Because of poor self-discipline, his inability to recognize his anti-social habits, and his negativism, rehabilitative efforts will be minimal at this time.
4. In view of the exemptee's character/personality disorder (passive-aggressive) and some recognized sociopathic tendencies which presupposes (1) an inability to benefit from Marine Corps rehabilitative programs and (2) a high probability of drug usage, it is recommended that Lance Corporal JONES be administratively separated from the United States Marine Corps in accordance with the provisions of reference (c).




