## MEMORANDUM FOR THE RECORD

**Event:** Visit to the La Mesa Police Department on June 23, 2004 to inquire about an altercation at [REDACTED] La Mesa, California which occurred on August 23, 2003.

9/11 Personal Privacy

On June 23, 2004, Tamm and Cordero visited the La Mesa Police Department located on the corner of University Boulevard and Spring Street to inquire about an altercation between the tenants of apartments [REDACTED] which occurred on August 23, 2003. During an interview of the manager of the [REDACTED] located at [REDACTED], identified as Anthony Divincenzo, telephone numbers [REDACTED] [REDACTED] Divincenzo advised that the tenants of the aforementioned apartments were involved in an altercation which resulted in the eviction of Ashley Abeyta, tenant of apartment [REDACTED] and a call to the police. Divincenzo did not know whether the police had filed a report.

In an effort to identify the individual associated with Ruiz, tenant of apartment [REDACTED] who was involved in the altercation and to ascertain the cause of the altercation, Tamm and Cordero requested the police report regarding the altercation. Tamm and Cordero were advised by a female receptionist, not further identified, that a police report had not been filed. The police department had a record of the altercation involving Phillip Heath, born [REDACTED] on August 23, 2003 at the [REDACTED] but the document memorializing the incident did not identify the other individual, i.e. person associated with Ruiz, tenant of apartment [REDACTED]
