On the above listed dates professional staff members Marco A. Cordero and Quinn John Tamm, Jr. canvassed hotels and motels within walking distance of the King Fahad Mosque, 10100 Washington Boulevard, Culver City, CA and the Mediterranean Gourmet Restaurant, 10113 Venice Boulevard, Culver City, CA, in an effort to locate the motel or hotel used by Nawaf al Hazmi and Khalid al Mihdhar from 01/15/2000 to 02/03/2000 in the Los Angeles, CA area. The hotel/motels are as follows:

1. Culver City Motel, 10111 Culver City Boulevard, Culver City, CA, telephone number 310-558-9769. The manager is Siri Ram (male). The registration cards for the months of January and February 2000 were hand searched by the professional staff members for the names Nawaf al Hazmi, Khalid al Mihdhar, Mohdar Abdullah, and the known aliases of Abderraouf Jdey, which include Abderraouf Dey, al Jiddi, al Jadi and al Tunisi. None of those names were located in the registration cards.
2. Deano's Motel, 3868 South Sepulveda Boulevard, Culver City, CA, telephone number 310-390-3511. The manager is Tony Novellino. The registration cards for the months of January and February 2000 were hand searched by the professional staff members for the names Nawaf al Hazmi, Khalid al Mihdhar, Mohdar Abdullah, and the known aliases of Abderraouf Jdey, which include Abderraouf Dey, al Jiddi, al Jadi and al Tunisi. None of those names were located in the registration cards, for those months. Mohdar Abdullah, Nawaf al Hazmi and Khalid al Mihdhar did stay at this motel on 06/09-10/2000, and the original registration card in the name of Mohdar Abdullah had been seized by special agents of the Federal Bureau of Investigation (FBI).
3. Sunburst Motel Spas and Suites, 3900 Sepulveda Boulevard, Culver City, CA, telephone number 310-398-7523. The manager is Bikash Pandey (male). The registration cards for the months of January and February 2000 were hand searched by Bikash Pandey for the names Nawaf al Hazmi, Khalid al Mihdhar, and Mohdar Abdullah. None of the names were located in the registration cards.
4. Ramada Limited Motel, 3930 Sepulveda Boulevard, Culver City, CA, telephone number 310-391-4529. The manager is Daniel Patel. The registration database printout for the months of January and February 2000 were hand searched by the professional staff members for the names Nawaf al Hazmi, Khalid al Mihdhar,

Mohdar Abdullah, and the known aliases of Abderraouf Jdey, which include Abderraouf Dey, al Jiddi, al Jadi and al Tunisi. None of those names were located on the printout.

5. The Half Moon Motel, 3958 South Sepulveda Boulevard, Culver City, CA, telephone number 310-391-5279. The manager/owner is Janice Jung. The registration cards for the months of January and February 2000 were hand searched by the professional staff members for the names Nawaf al Hazmi, Khalid al Mihdhar, Mohdar Abdullah, and the known aliases of Abderraouf Jdey, which include Abderraouf Dey, al Jiddi, al Jadi and al Tunisi. None of those names were located in the registration cards. Omar al Bayoumi stayed at this motel on 01/09/2000. The original registration card had been seized by special agents of the FBI.

None of those names were located on the printout.
