**MEMORANDUM FOR THE RECORD**

**Event:** Investigation re Mohdar Mohamed Abdullah's California DMV information , to include vehicle registration and possible entry/exit into LAX airport on January 15, 2000.

In response to information obtained from Abdullah's former detention block cell-mates regarding Abdullah's alleged statements (to them) regarding his knowledge of Nawaf Al-Hazmi and Khalid Al-Midhar activities in California and Abdullah's role in picking up aforementioned hi-jackers at LAX on January 15, 2000, commission staffer requested Abdullahs California DMV records. Staffer Cordero used this information to identify Abdullah's vehicle's license plate and to ascertain whether Abdullah's vehicle was recorded exiting LAX parking facilities on or about January 15, 2000.

Abdullah's California DMV information identified Abdullah's car as a 1994 GEO BTM, VIN 2C1MR2463R6717463, California license plate 4HPH316. DMV records suggest Abdullah purchased this vehicle on or about October 19, 1999.

DMV records suggest Abdullah may have obtained a California identification card on August 11, 1999 and obtained his California driver's license on May 31, 2000. Abdullah's driver's license number is D1818362. DMV records also indicate Abdullah was cited for three moving violations/citations on July 13, 2001. The fine for these violations was \$798.00.

9/11 Personal Privacy

On May 27, 2004, staffer Cordero contacted George Harris, an employee of LAX' parking services department at [redacted] and requested a record check on LAX' database to ascertain whether Abdullah's car exited LAX' parking garage on January 15, 2000. Harris advised he would check LAX' database to determine whether Abdullah's car exited LAX' parking facilities between January 15 and 17, 2000. Later in the day, Harris advised LAX' database did not have Abdullah's car exiting LAX' parking garage between January 15 and 17, 2000. Harris also advised that his office had recently received similar requests from two other law enforcement agencies on May 26 and May 27, 2004.

Attached to this document are Abdullah's California DMV records.
